ईओयू स्कीम हेतु यूनिट अनुमोदन समिति की दूसरी बैठक (2023 सीरीज) दिनांक 03.02.2023_को श्री ए. बिपिन मेनन, विकास आयुक्त, नौएडा, एनएसईजेड की अध्यक्षता में संपन्न हुई।

बैठक, ऑनलाइन विडियो कॉन्फ्रेंसिंग के माध्यम से संपन्न हुई बैठक में यूनिट अनुमोदन समिति के निम्नलिखित सदस्य उपस्थित थे:-

2. अध्यक्ष महोदय द्वारा यूएसी के सभी सदस्यों का स्वागत किया गया। तत्पश्चात, कार्यसूची पर विचार-विमर्श शुरू हुआ।

2.01 (2023) दिनांक 06.01.2023 को हुई यूनिट अनुमोदन समिति की बैठक के मिनट्स का रैटीफिकेशन

चूंकि दिनांक 06.01.2023 को आयोजित अनुमोदन सिमिति के निर्णयों के संबंध में अनुमोदन सिमिति या व्यापार के किसी भी सदस्य से कोई संदर्भ प्राप्त नहीं हुआ था, अतः दिनांक 06.01.2023 को आयोजित बैठक के कार्यवृत्तों का सर्वसम्मित से अनुमोदन किया गया।



2.02 (2023) Proposal for surrender of additional location located at A-94/5 & A-94/6, Sector-58, Noida-201301. Of M/s Exl Service.com (India) Pvt Ltd

It was informed to the Committee that:-

Exl Service.com (India) Pvt. Ltd. has been issued LOP No. 42(1999)EPC/50/99 dated 14.08.1999 for services of Software Development. As per records, the date of commencement of production of the unit is 27.03.2000. Unit's current five-year block is valid upto 31.03.2025 and the unit has maintained positive NFE.

- 2) Vide letter dated 12.08.2022, the Unit had applied for surrender / debonding of additional location located at A-94/5 & A-94/6, Sector-58, Noida-201301 and stated that they have planned restructuring and consolidation of various clients' processes / projects and found that they can manage their affairs in the various additional locations by relinquishing the location at A-94/5 & A-94/6, Sector-58, Noida-201301 and decided to surrender / de-bond the location located at A-94/5 & A-94/6, Sector-58, Noida-201301.
- 3) Unit's request for surrender / debonding of location at A-94/5 & A-94/6, Sector-58, Noida-201301 was forwarded to jurisdictional Customs office, Noida vide this office letter dated 27.01.2021 with request to forward the site inspection report and no dues for deletion of the said location from LoP.
- 4) Vide letter C.No. VIII(30)/ Cus/EPC-1/Noida/EXL.A-94,Sec-58/57/18/950 दिनांक 29.12.2022, the Superintendent (Customs), Export Promotion Circle, C-56/42, Sector-62, Noida informed that "M/s Exl Service.com (India) Pvt Ltd, A-94/5 & A-94/6, Sector-58, Noida-201301 (Uttar Pradesh) has already either de-bonded the imported duty free goods or shifted to their other 100%EOU unit as per the Notification No. 52/2003-Cus dated 31.03.2003 and their office has no objection for deletion of location at A-94/5 & A-94/6, sector-58, Noida-201301 from the LOP and as per their records no Govt. dues are pending against the party till date".
- 5) Shri Raman Bhasin and Shri S.P. Singh, Managers of the Unit appeared before the Committee through video conferencing. They reiterated that they have planned restructuring and consolidation of various clients' processes / projects and found that they can manage their affairs in the various additional locations in SEZ by relinquishing the location at A-94/5 & A-94/6, Sector-58, Noida-201301 and decided to surrender / de-bond the location located at

A-94/5 & A-94/6, Sector-58, Noida-201301.

- The UAC noted that as per para 6.34 (7) of Handbook of Procedures 2015-2020, DC may permit change of location from place mentioned in LoP to another and / or include additional location provided that no change in other terms and conditions of approval is envisaged and that new location is within territorial jurisdiction of DC / Designated Officer. However, it is not clear whether surrender / deletion of additional location may fall under this paragraph or not. The Committee noted that after change of location from place mentioned in LoP to another will render the earlier location surrendered / debonded.
- 7) It was noted that in terms of para 6.32(b) of Handbook of Procedures, powers and functions of UAC of EOU shall be as under:-
 - (viii) "to grant approvals and clearances for establishment and operation of EOUs."
- 8) Further, the Committee noted that the Unit has maintained positive NFE. The procedure for exit as mentioned in para 6.18 of Foreign Trade Policy 2015-2020 was also followed for surrender of above location wherein the jurisdictional Customs visited the premises submitted a feasibility report and informed that their office has no objection for deletion of location at A-94/5 & A-94/6, Sector-58, Noida-201301 as no dues are pending against the party till date.
- From the combined reading of para 6.18(e) of FTP 2015-2020, para 6.32(b)(viii) and para 6.34(7) of Handbook of Procedures 2015-2020, the Committee deliberated the proposal and unanimously approved the deletion of location at A-94/5 & A-94/6, Sector-58, Noida-201301 from the existing LOP No. PER/42(1999)/EPC/50/99 dated 14.08.1999

2.03 (2023) Proposal for surrender of additional location at 2000 sq ft from Gate No 3, Ground Floor of Plot A-38C) from existing 100% EOU facility located at A-38, A, B & C, Sector 64, Noida.

It was informed to the Committee that:-

Barco Electronic Systems Private Limited has been issued LOP No. 01/170/2000-100%EOU dated 10.03.2000 for manufacture of All types of Projectors, Monitors, Parts of projectors & Monitors, Interface, Switchers and parts thereof, Wound components Structures,



Hardware/Software IT and Design Services, Populated printed Circuit Boards, Electronic Components and Sub -Assemblies, Automatic Data Processing Machines (including Workstations, Controllers etc.), parts Automatic Data Processing Machines (including Workstations, Controllers etc.), Measuring/Checking Testing Equipment/Fixture and Its parts thereof, Ruggadised Display unit, Video Wall/ Display Wall System/Large Screen Projection System/Large Screen Display System/Video Wall System/Data Wall System/Large Video Screen System/Video projection System and Parts thereof. As per records, the date of commencement of production of the unit is 05.11.2000. Unit's current five-year block is valid upto 31.03.2025 and the unit has maintained positive NFE.

- 2) Vide letter dated 23.11.2022, the Unit applied for surrender / debonding of additional area of 2000 Sq.ft from Gate No 3, Ground Floor of Plot A-38C) from existing 100% EOU facility located at A-38, A, B & C, Sector-64, Noida (U.P.) and stated that to provide better services to their domestic customers, they want to surrender 2000 sq.ft. area from their existing EOU unit and the said location will now be used as a service repair centre to cater to the need of Barco's customers based in India.
- Unit's request for surrender / debonding of 2000 Sq.ft from Gate No 3, Ground Floor of Plot A-38C) from existing 100% EOU facility located at A-38, A, B & C, Sector-64, Noida (U.P.) was forwarded to jurisdictional Customs office, Noida vide this office letter dated 08.12.2022 with request to forward the site inspection report and no dues for deletion of the said area, from LOP.
- 4) Vide letter C.NO. V(30)Cus/STP/Barco/D-III/N-1/211/2017/Pt-2/24 dated 10.01.2023, the Deputy Commissioner of Customs (EPC) Circle-I, C-56/42, Sector-62, Noida informed that, the premise was visited by the Inspector & Superintendent EPC-I, Noida and visit report is enclosed. Further, they informed that their office is having no objection for deletion of the said premises from party's LOP.

As per Inspection Report, it has been noted that, "the Premises of M/s Barco Electronic Systems Pvt Limited, A-38, ABC Sector-64, Noida-20301 (Uttar Pradesh) was visited on 16.12.2022. During the visit the premises for deletion was found to have separate entry and exit and have no direct access from the rest of the premises, further the premises was fully vacated and no equipment, apparatus were available there at the time of visit. The premises

to be surrendered has an area approximate 2000 sq. feet and during visit found as per the revised layout submitted by the party to the Development Commissioner, Noida Special Economic Zone. They also submitted that they intend to use subject premise as service/repair centre for their customers based in India.

- 5) Shri Manish Gaur, Deputy Manager of the Unit present before the Committee in person. He informed that they want to provide better services to their customers in India and hence they want to surrender 2000 sq.ft. area from their existing EOU unit and the said location will now be used as a service repair centre to cater to the need of Barco's customers based in India.
- The UAC noted that as per para 6.34 (7) of Handbook of Procedures 2015-2020, DC may permit change of location from place mentioned in LoP to another and / or include additional location provided that no change in other terms and conditions of approval is envisaged and that new location is within territorial jurisdiction of DC / Designated Officer. However, it is not clear whether surrender / deletion of additional location may fall under this paragraph or not. The Committee noted that after change of location from place mentioned in LoP to another will render the earlier location surrendered / debonded.
- 7) It was noted that in terms of para 6.32(b) of Handbook of Procedures, powers and functions of UAC of EOU shall be as under:-
 - (viii) "to grant approvals and clearances for establishment and operation of EOUs."
- Further, the Committee noted that the Unit has maintained positive NFE.
