2. It was informed to the Committee that the export projections for five years are Rs.272.16 lakhs and projected NFE is Rs.129.82 lakhs. The area of proposed location is 2.02 Hectares. The Committee was informed that the antecedent reports from Vizag, Falta SEEPZ and MEPZ SEZ have been received and nothing adverse noticed. It was also informed that the Customs in their report has mentioned that the party has bought the land from private party for which sale deed has been done but transfer of land has not yet been reflecting online on the website of Government of

Rajasthan. It was further informed that the proposed location was found earmarked surrounded by

the boundary wall which is under construction.

3. Shri Parbhash Jha, AGM Finance, Shri Akshay S Naruka, Manager and Shri Sachidanand

Sharma, Dy. Manager attended the meeting and explained the project. The Committee observed

that no Director or higher level officer from the unit is present before the Committee to explain

the proposal. Unit's representatives informed the Committee that their Managing Director is

hospitalized and their General Manager is out of station. They explained the project and also

handed over the reply of deficiencies communicated to them vide this office letter dated

11.09.2019 and stated that have submitted all the requisite documents except certificate of

financial soundness of foreign national Directors as these are not required since they are

independent Directors of the company.

4. The representatives of the unit stated that the power generated in EOU will be used in

their SEZ unit located at E-1 & E-2, SEZ-II, Sitapura, Jaipur. They further informed that they will

supply the generated electricity to Rajasthan Discom Authority and JVNL Limited and the same

will be got adjusted in the electricity billing of their said SEZ unit. However, the Agreement for

the same is under process and has not been finalized yet. In respect of online transfer of land

record they stated that they have purchased the land and have also submitted the copy of sale

deed but their same has not been registered and reflecting online on website as the online

registration process in their region would start in last week of October, 2019.

It was informed by the Committee that electricity is considered as a goods and not as

'services' as mentioned by the unit in their application i.e. ANF 6A.

- 4. The Committee was informed that since the power for enhancement of limit of imported capital goods on the ground other than currency fluctuations is with Approval Committee, the proposal has been placed before the UAC.
- 5. Unit's representative Shri Ghanshyam Sharma, Finance Analyst attended the meeting. He informed that currently they are engaged in manufacturing and exports of medical products (including component/parts thereof) falling under the broad category of "Continence Care Products" and "Ostomy Care Products". Now in view of increased demand in US and European market, they want to broad band the LOP by including one more Continence Care Product i.e. 'Night Drainage Collector'. He informed that at present about 350 people are working in their unit. Further, he also informed that their expected export turnover will be around Rs.200.00 crore per annum in near future as their company is planning to expand since demands of the product in US and European market is growing.
- 6. He further stated that they are regularly assessing the foreign exchange projections and that is why they have requested for revision of projections including enhancement in projections of imported capital goods.

The Committee after due deliberations, approved the proposal for revision in foreign exchange balance sheet including enhancement of imported capital goods from Rs.3402.12 lakhs to Rs.3565.78 lakhs and broad banding of LOP by inclusion of Night Drainage Collector with annual capacity of 10 lakh pieces per annum.
