3. During the meeting, the Customs representative informed that a case against the unit has been booked by the Customs authority, Jodhpur and during the search from 27.11.2019 to 29.11.2019 by the Customs authority, physical stock of the aforesaid unit did not match with its record and seizure has been made of the excess stock (i.e. indigenous marble blocks and slabs). It appears that the unit has adopted ingenious modus operandi by importing duty free Rough Marble Blocks under 100%EOU scheme and are diverting the same into domestic market and exporting the indigenous marble blocks / slabs in the guise of imported marble blocks/slabs, resulting in huge loss of revenue to government exchequer and the case is under investigation. The Customs representative informed that the investigation is in initial stage and therefore decision on the present proposal may be deferred.

 - (iii) Value of Plant and Machinery (imported CIF value shown Rs.150.00 lakhs whereas in Column. XIII, the same has been mentioned as Rs.300.00 lakhs for next five years;
 - (iv) In Column IX, details of source of finance not submitted;
 - (v) Column. (XI) for Equity including Foreign Investment are left blank;
 - (vi) Column XIV for REJECTS left blank;
 - (vii) Column XVI for Net Foreign Exchange Earning left blank;
 - (viii) Column XVII MARKETING tie-up / Buy-back and Destination of exports left blank;
- (2) Application for conversion of existing DTA unit into 100%EOU, but Annexure to ANF-6A not filled and relevant information not submitted.
- (3) List of machinery / equipments whether these capital goods are imported or indigenously procured not mentioned.
