



- 2.5.4 Shri Navratan Johari, Director, appeared before the Approval Committee through video conferencing on behalf of the unit and explained the proposal. - 2.5.5 The Approval Committee observed that the HS codes indicated against some the items such as those in respect of Copper beads, as reflected in the Agenda, is not correct. After due deliberations, the Approval Committee has empowered the administrative office of NSEZ to examine the proposal for renewal of LOA will be considered on file on receipt of revised Form-F1 with correct HSN codes (Copper beads), clarification to the observations of CA NSEZ on the APR and status of ending BRC of Rs. 831.56 Lakhs.
