


3.1.3 Shri Anil Bindrani, Director appeared before the Approval Committee through video conferencing on behalf of the unit and explained the proposal. He informed that, at present they have five plots in Sitapura SEZ Jaipur.

3.1.4 The Committee noted that Plot No.H-56 (651.84 sq. mt.) has been provisionally allotted by RIICO.

3.1.4 After due deliberations, the Approval Committee **unanimously** approved the proposal of the unit for i) addition of a new location Plot No. H-56 (651.84 sq. mt.); ii) inclusion of new items and activities in LOA as per above details and ii) revision in projections subject to conditions mentioned in Instructions No. 51 issued by DOC regarding import of used and broken jewellery. It was also decided that the approval is subject to 100% examination by Customs Authority. The unit will fulfill prescribed value addition norms and execute revised Bond-Cum-Legal Undertaking.

Meeting ended with a vote of thanks to the chair.


