- 6.1.2 It was informed that the applicant has mentioned projected export of Rs. 10000.00 Lakhs and the NFE of Rs. 2500.00 Lakh over a period of five years. It was further informed that the applicant has proposed investment in plant and machinery of Rs. 200.00 Lakh [Rs. 150.00 Lakh Imported and Rs. 50.00 Lakhs indigenous]
- 6.1.3 It was further informed that the applicant has submitted allotment letter dated 17.11.2021 from RIICO (Developer) for an area of 698.25 Sq. mtrs. at plot no. H-195 SEZ-II Sitapura Jaipur
- 6.1.4 Shri Bhuwan Seth, Partner, appeared before Approval Committee on behalf of the unit and explained the proposal. He informed that Committee members that he has been running a DTA Unit M/s Millennium Jewellery Pvt. Ltd, at Plot No. G1-4,

- 6.1.5 It was informed that as per Instruction No. 88 dated 16/08/2017 of Department of Commerce and DGFT Notification No. 21/2015-2010 dated 14/08/2017, there is restriction of Gold content from 8 carats and above upto a maximum limit of 22 carats for export of Gold Jewellery, including partly processed Jewellery, whether plain or studded and articles.
- 6.1.6 Following discrepancies were observed in the application in the first instance:
  - i. Details of Source of funds at s.no. 6 (B) in form F not mentioned.
    - ii. Company Web-site address not mentioned in Form F.
    - iii. In form F Para VIII requirement of land area details not correct.
    - iv. Brief note on mother of pearls & usage in jewellery is requied
    - v. It is not clear that "mother of pearls" will be imported or purchase from DTA.
    - vi. Registered office address mentioned in form F and letter head is deferent.
    - vii. No. Export policy is there in respect of HS 05080010-Coral.
    - viii. The HS codes 71031011, 12,19,21,23, 24 and 29 are not available in the export Policy.
- 6.1.7 The Committee was informed that as per instructions of Department of Commerce No. 12/04/2013-SEZ dated 31.12.2013, no Unit is allowed to carry on Trading in "Gold, Silver, Platinum, Other precious metals, Diamonds, other precious and semi-precious stones."
- 6.1.8 After due deliberations, the Approval Committee unanimously <u>approved</u> the proposal for setting up a new unit for manufacture of following items:
