

**Minutes of the Approval Committee Meeting of Jaipur Special Economic Zone, Sitapura (Multi Product SEZ) held at 11:00 AM on 28.08.2023 under the chairmanship of Shri A. Bipin Menon, Development Commissioner through Video Conferencing.**

The Chairman welcomed the participants at the outset and the agenda was taken up for sequentially. After detailed deliberation amongst the members of the Approval Committee as well as interaction with Developer/ Representatives of the Units/ Applicants, the following decisions were taken:

**Agenda No. 1**

**Ratification of Minutes of Approval Committee meeting held on 27.07.2023**

It was informed that no reference had been received against the decisions of the Approval Committee Meeting held on 27.07.2023 from any of the members of the Approval Committee/ Trade/ Unit. Therefore, Minutes of the meetings of Approval Committee held on 27.07.2023 were unanimously ratified.

**Agenda No. 2**

**Proposal of M/s Stone Beads International for renewal of LOA with Broad-banding of Authorized Items**

2.1. The proposal of M/s Stone Beads International, Plot No H1-133, SEZII, Sitapura, Jaipur for renewal of LOA No. 2-24/2004-SEZ-II (J) Proj./ 1062 dated: 23.06.2004 with broad-banding of authorized items was discussed in the meeting.

2.2. No one appeared before the Approval Committee.

2.3. After due deliberations, the Approval Committee unanimously approved the proposal in principle for a further period of six months i.e. upto 14.03.2024 JSEZ/Proj/04/2022- 23 I/50413/2023 subject to rectification of deficiencies.

3.1 The proposal of M/s Manglam Gems & Jewellery Plot No. F-89, SEZ-II, Sitapura, Jaipur for renewal of LOA with Broad-banding of Authorized Items was discussed in the meeting.

3.2 No one appeared before the Approval Committee.



3.3 After due deliberations, the Approval Committee deferred the proposal for next UAC. Further, the approval committee directed the unit to rectify all the deficiencies already conveyed and deposit the outstanding dues of RIICO of Rs 2.25 Lakh.

**Proposal of M/s BAMALWA JEWELS for renewal of LOA with Broad-banding of Authorized Items**

4.1. The proposal of M/s BAMALWA JEWELS, Plot No H-63, SEZ-II, Sitapura, Jaipur for renewal of LOA No. 2-117-SEZ-II(J)/Proj./379 dt. 12/05/2006 with broad-banding of authorized items was discussed in the meeting.

4.2. Sh. Jai Hanuman Soni, Proprietor, appeared before the Approval Committee through video conferencing on behalf of the unit but he could not explain the reasons for their dismal export performance during the last block of five years.

4.3 After due deliberations, the Approval Committee deferred the proposal for next UAC. Further, the approval committee directed the unit to rectify all the deficiencies already conveyed. The approval Committee also directed that physical verification of plant and machinery and raw material available in the unit may be done by the Customs Division of JSEZ and a report may be furnished before the UAC in its next meeting. Moreover, the unit was also directed to furnish the buyer's order(s) with their complete details.

**Agenda No. 5**

**Proposal of M/s Lakhota Jewellery Manufacturing Company, for renewal of LOA with Broad-banding of Authorized Items**

5.1. The proposal of M/s Lakhota Jewellery Manufacturing Company, Plot No. H1-77, SEZ-II, for renewal of LOA No. 2-4/2004-SEZ-II(J)Proj./542 dated: 28.05.2004 with broad-banding of authorized items was discussed in the meeting.

5.2. Shri R C Lakhota Manager, appeared before the Approval Committee through video conferencing on behalf of the unit but could not explain the reasons of their dismal export performance during the last block of 5 years.

5.3. After due deliberations, the Approval Committee deferred the proposal for next UAC. Further, the approval committee directed the unit to ratify all the deficiencies already conveyed. The Approval Committee also directed the Customs Division of JSEZ for conducting stock verification of the unit and furnish a report in this regard before it in its next meeting. Moreover, the unit was directed to furnish buyer's order(s) with complete details.

**Agenda No. 6**

**Proposal of M/s Agkem Impex Pvt. Ltd, for renewal of LOA with Broad-banding of Authorized Items**

6.1. The proposal of M/s Agkem Impex Pvt. Ltd., Plot No. H-154, SEZ-II, for renewal of LOA No. 2-120-SEZ-II(J)Proj./495 dated: 03.07.2006 with broad-banding of authorized items was discussed in the meeting.

6.2. Shri Manish Jain Director, appeared before the Approval Committee through video conferencing on behalf of the unit and explained the proposal.

6.3. The Approval Committee observed that the export performance of the unit is very irregular and very meagre in comparison to their projected exports during the last block of five years.

After due deliberations, the Approval Committee deferred the proposal for next UAC. Further, the approval committee directed the unit to ratify all the deficiencies already conveyed. Moreover, the unit was also directed to furnish buyer's order(s) with complete details.

#### Proposal of M/s Millennium Jewellery Pvt. Ltd. for addition/ revision of new items

7.1. The Proposal of M/s Millennium Jewellery Private Limited, Plot No. H- 187, SEZ-II, Sitapura, Jaipur for addition / revision of new items in existing LOA No. 2-92-SEZ-II (J) Proj./ 309 dated: 28.06.2011 was discussed in the meeting.

7.2. Shri Anurag Khatri, Director appeared before the Approval Committee on behalf of the unit and explained the proposal. On being asked by the committee, they informed that the Unit will submit revised Form-F3 with correct details & replies to the observations for further course of action.

Further, the unit will also follow SOP issued by the O/o the DC, NSEZ, Noida vide letter No.1158 dated 31.01.2023 in respect of handling of Silver jewellery studded with Diamonds. **The sourcing of coral would be subject to the provisions of CITES (Convention of International Trade in Endangered Species of wild Fauna and Flora). Further, no export of restricted items will be allowed without an appropriate approval/license.** Further, the unit will also execute BLUT for aforesaid purposes.
