

Item No.2: Proposals for expansion of area of the unit:

2.1. M/s. HCL Technologies Limited (Unit-VI).

2.1.1. M/s. HCL Technologies Limited (Unit-V) had submitted proposal for expansion of area by addition of '2141.87 Sqmt. at partial area of 1st floor, IT Block-01' in its unit located in the HCL IT City Lucknow Pvt. Ltd. IT/ITES SEZ at Lucknow (Uttar Pradesh). Unit had submitted copy of MOU dated 14.01.2021 signed with SEZ Developer for allotment of the proposed additional area. The unit also submitted revised projections, as under:-
