- 3.1.2. Shri Ashwini Choudhary, Director of Vetracare Private Limited joined the meeting through video conferencing and explained the proposal. He informed that while taking steps to implement the project they realized that they should expand their export & NFE projections and for this purpose they will require to import / procure additional machines as well as raw materials and components. He further informed that there is a typographical error in their letter dated 17.09.2020, wherein the name of company has inadvertently written as 'Vetracare India Private Limited' instead of 'Vetracare Private Limited'. This may be read as 'Vetracare Private Limited'.
- 3.1.3. After due deliberations, the Approval Committee unanimously <u>approved</u> the proposal for enhancement in the value of capital goods & raw materials and revised Export / NFE projections of the unit.
