- Following docentary shortcomings were observed in the proposal. 2.1.3
 - i. Foreign Exchange outgo has been shown Rs. 3187.18 lakh, however imports of Rs. 4000.00 lakh has been shown by the unit in the table of revised projections. Hence, breakup of outgo may not be correct.
 - ii. The table given in the letter of the unit shows capital goods as Rs. 859 lakhs, however actually it is approved Rs.800 lakh & Rs. 400 lakh, Imported & Indigenous respectively.
- Sh. Abhinav Banthia, Director of the company joined the meeting through video 2.1.4 conferencing and explained the proposal. He further informed that there is no need to change the description of items of manufacture as the existing one is broad in nature and covers the proposed items as well.
- 2.1.5 After due deliberations, the Committee unanimously approved the proposal of the unit for enhancement of capacity of production and expansion of area subject to submission of revised projections as mentioned at point 2.1.3.
