- At the outset, the Chairman welcomed the participants. After brief introduction, items

  with the applicants / representatives of the developers / units, the following decisions

- 2.1.2 The Approval Committee were informed about the following observations:-
  - 1. Unit has not mentioned paid up capital amount of current and proposed shareholding pattern.
  - 2. Unit has not submitted consent of Developer.
  - 3. Unit has not submitted list of present directors and directors after proposed change.
  - 4. Unit has not any authorization/board resolution in favour of Mr. Sanjul Vaish, Director in respect of filling such application.
  - 5. The date of effect of the proposed change is also not clear.
  - 6. The Unit has not submitted copy of the Share purchase Agreement.
- 2.1.3 The Approval Committee further observed that DOC has issued Instruction No. 109 dated 18.10.2021 in supersession of Instruction No. 89 dated 17.05.2018 and Instruction No. 90 dated 03.08.2018 incorporating that "(i) Reorganization including change of name, change in shareholding pattern, business transfer arrangements, court approved mergers and demergers, change of constitution, change of directors, etc. may be undertaken by the Unit Approval Committee (UAC) concerned subject to the condition that the Developer / Codeveloper / Unit shall not opt out or exit out of the Special Economic Zone and continues to operate as a going concern. All liabilities of the Developer / Co-developer / Unit shall remain unchanged on such reorganization."

- 2.1.4 Shri Ankit Goyal, Finance Controller of M/s. Advanced Technology Consulting Services Private Limited joined the meeting through video conferencing and explained the proposal.
