Minutes of the Approval Committee meeting of Mahindra World City (Jaipur) Ltd. Multi-Product SEZ, Jaipur, held under the Chairmanship of Shri A. Bipin Menon, Zonal Development Commissioner, NSEZ at 12:00 Noon on 28.08.2023 in Hybrid mode at Conference Hall at 2nd Floor of O/o DC, NSEZ, Noida and through Video Conferencing.

Besides, during the meeting (i) Shri Buddhi Prakash, Specified Officer, Mahindra World City SEZ, Jaipur; (ii) Shri Nitin Gupta, Deputy Development Commissioner, NSEZ. (iii) Shri H.K. Meena, Assistant Development Commissioner, NSEZ and (iv) Shri Sunil Gulyani, Stenographer Gr.II, NSEZ were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.

At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken:-

1. Ratification of the Minutes of the Approval Committee meeting held on 20.07.2023:-

2.1. Proposals for setting up a new unit in SEZ

2.1.1. M/s. LNM Auto Industries Pvt. Ltd. had submitted a proposal for setting up a unit over an area of 4037.18 Square metres at Plot No. PA-008-017, Multi Product SEZ, M/s. Mahindra World City (Jaipur) Limited, Jaipur (Rajasthan) for export of following goods:

The applicant had proposed a projected export of Rs. 17215.68 lakhs with a cumulative NFE of Rs. 17015.68 lakhs over a period of five years. The projected investment of Rs. 308.00 lakhs was towards indigenous capital goods and Rs. 200.00 lakhs towards imported capital goods was also proposed. The cost of project was shown as Rs. 1100.00 lakhs which was be met from the capital contribution including interest free unsecured loan Rest. 350.00 lakhs and term loan of Rs. 750.00 lakhs. The applicant submitted copy of "Letter of Provisional Offer of space" dated 12.07.2023 issued by the SEZ Developer for allotment of the proposed land.

- 2.1.2 The Committee was informed that the following discrepancies were found in the application have been communicated to the applicant:-
 - Unit's Directors had not submitted copies of Passport and Voter ID Card.
 - ii. Unit had not submitted copy of registration in GST and Copies of GST Returns for the last three years may be requested.
 - iii. Unit had informed in Means of Finance that they would procure Capital Contribution including interest free unsecured loan of Rs. 350/- lakhs and Term Loan of Rs. 750/- lakhs for the project. Hence, copies of Balance Sheet for the period 2022-23 alongwith copy of Income Tax Return for the Assessment Year 2023-24 would be requested.
 - iv. Unit has submitted only a brief Manufacturing process of the products. However, detailed manufacturing process Flow -Chart showing all processes may also be requested.
 - v. Fund Flow statement in prescribed format is required to be submitted by the unit.
- 2.1.3 Shri Sandeep Mall, Director and Shri Sameep Mall, Director of M/s M/s. LNM Auto Industries Pvt. Ltd. joined the meeting through video conferencing and explained the background of the Company as well as instant proposal. Shri Mall informed that he has a DTA unit in Faridabad (Haryana) which has the business more than Rs. 1500.00 lakhs. He also informed that most of his exports are to countries in Europe and Asia. Shri Mall has informed that the reply to the discrepancies were sent in the morning of 28.08.2023.
- 2.1.4 After due deliberations, the Approval Committee unanimously <u>approved</u> the proposal for setting up of new unit, subject to receipt of satisfactory and complete reply from the unit on the observation made by this office on the application.

Item No. 3: Monitoring of performance

3.1. M/s. EXL Service.com India Private Limited

- 3.1.1 M/s. EXL Service.com India Private Limited had been granted LOA No. STPI/SEZ/Unit/03/48/78 dated 22.02.2010 for setting up a unit in the Evolve, First Floor, Block-A, Tower A2, M/s. Mahindra World City (Jaipur) Limited, Multi Product SEZ, Sanganer, Jaipur (Rajasthan) to undertake services activities i.e. "IT & ITES including BPO. Unit executed Bondcum- LUT which was accepted by the Competent Authority. The unit had commenced its production on 01.07.2010. The LOA of the unit has been extended upto 30.07.2025.
- 3.1.2 Unit had applied for exit from SEZ Scheme located in the Evolve,



First Floor, Block-A, Tower A2, M/s. Mahindra World City (Jaipur) Limited, Multi Product SEZ, Sanganer, Jaipur (Rajasthan). The block wise export performance and status of NFE Earning of the unit, as per APRS since inception, duly verified by NSEZ CA firm, are under:

- 3.1.5 Shri Raman Bhasin, Vice President of the unit physically attend the meeting. He explained the reasons of exit from SEZ scheme and stated that the main reason towards exit are high cost of operations and completion of the agreement of their foreign customer,
- 3.1.6 After due deliberations, the Approval Committee monitored the performance of the Unit in terms of Rule 54 and took note of the positive NFE earned by the unit upto 13.07.2023.

3.2 M/s. Metlife Global Operations Support Center Private Limited.

- 3.2.1 M/s. Metlife Global Operations Support Center Private Limited was granted LOA No. 10/85/2012-SEZ/9216 dated 09.11.2012 for setting up a unit in the Mahindra World City (Jaipur) Ltd. Multi-Product SEZ at Jaipur (Rajasthan) for undertaking authorized operations namely service activities of "ITES". The unit executed Bond-Cum-LUT which has been accepted by the Competent Authority. The unit commenced operation w.e.f. 19.08.2013 and completed 2nd block of five years of operation. Since NFE is positive, the office of the Development Commissioner had granted permission of renewal of LOA for next five years in terms of Rule 19(6A) of SEZ Rules 2006. Accordingly, performance of the unit during last five years of operations is placed before the Approval Committee for review. The Committee noted that as per APR sheet, The Rs. 51.41 lakhs cleared in DTA.
- 3.2.2 Further, renewal of LOA during current five year block period has been granted from 29.08.2023 to 18.08.2028.
- 3.2.3 The year wise export performance and status of NFE Earning of the unit for last five year block, as per APRs, duly verified by NSEZ CA firm, as are under:
