

- Besides, during the meeting i) Shri Rajesh Kumar, DDC, ii). Shri Manoj Kumar Saily, Specified Officer, & iii). Shri Prakash Chand Upadhyay, ADC, were also present to assist the Approval Committee.
- At the outset, the Chairman welcomed the participants. After brief introduction, each item included in the agenda were taken up for deliberation one by one. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developer / units, the following decisions were taken: -
- 01. दिनांक 24.06.2019 को आयोजित अनुमोदन समिति की बैठक की कार्यवृत का अनुसमर्थन :-

The Approval Committee was informed that no reference against the decisions of the Approval Committee held on 24.06.2019 was received from any of the members of the Approval Committee or Trade and therefore, Minutes of the Meeting held on 24.06.2019 were ratified.

- 02. मै॰ वेट्राकेयर प्राइवेट लिमिटेड का मै॰ मिहंद्रा वर्ल्ड सिटी (जयपुर) लिमिटेड की ग्राम कलवारा, झाई, भाम्भोरिया, बागरू खुर्द एवं नेवता, तहसील सांगानेर, जिला- जयपुर (राजस्थान) स्थित बहु-उत्पाद विशेष आर्थिक क्षेत्र में इकाई स्थापित करने का आवेदन।
- 2.1. It was brought to the notice of the Approval committee that M/s. Vetracare Private Limited has submitted an application for setting up a unit over an area of 4081.89 Sqmt. land at Plot No. PA-010-021 in the Multi-Products SEZ of M/s. Mahindra World City (Jaipur) Ltd. located at Village Kalwara, Jhai, Bhamboriya, BagruKhurd & Newta, Tehsil-Sanganer, Distt- Jaipur (Rajasthan) for manufacturing of Herbal / Natural Animal Feed Supplements [ITC(HS) 23099020]- 1400 M. Tons, with projected exports of Rs.5199.50 lakhs and the cumulative NFE of Rs.5199.50 lakhs over a period of five years. It was also informed that the investment of Rs.123.45 lakhs towards Indigenous capital goods and other cost of project shall be met from the Promoter's Contribution & Term loan. It was informed that the applicant has shown requirement of indigenous raw material of Rs. 2075.00 lakhs. It was further informed that the applicant has submitted copy of provisional offer of space for allotment of 4081.89 Sqmt. land at Plot No. PA-010-021 issued by SEZ developer.



- 2.2. It was informed that following documents / information required to be submitted which has been communicated to the applicant:-
 - (i) Discrepancies in Form F:
 - a) Requirement of land in Para VIII(1) to be corrected as per provisional offer of space issued by SEZ Developer. Applicant has mentioned 4000 Sqmt. whereas developer has given provisional offer of space for 4081.89 Sqmt. land at Plot No. PA-010-021.
 - b) In Para VIII (2), built up area should be kept Nil being developer has allotted 4081.89 Sqmt. land. .
 - c) In reply to Para X of Form-F i.e. Whether Foreign Technology agreement is envisaged, the has marked 'Yes', whereas Foreign Collaborator address mentioned as Delhi, India. This need to be clarified /rectified.
 - d) Reply in respect of Para XII (iv) should be given in 'Yes' or 'No'. Applicant has mentioned 'NA'.
 - e) Undertaking of Form-F has not signed by the applicant.
 - f) In the Part-II (ii) of Form- F, applicant has mentioned address of Sub-contractor as Delhi and Sub-contractor type-DTA/Central Excise. However, details of proposed sub-contracting not mentioned in Para (i) of Part-II of Form-F.
 - (ii) Variation in proposed source of finance mentioned in Para VI(b) vis-à-vis details given in Project Report, have been found.
 - (iii) List of raw material with ITC(HS) Code required to be given.
 - (iv) Projected Profit & Loss statement for 5 years required to be submitted.
 - (v) 'Delivery Vehicle' proposed under 'Miscellaneous Fixed Assets' in Project Report may not be allowed.
 - (vi) Information pertains to Income Tax Department required to be given in prescribed format.
- 2.3. Shri Ashwani Choudhary, Director appeared before the Approval Committee on behalf of the unit and explained the proposal. He informed to the Approval Committee that they will not use any raw material made of animal by-products. He further clarified that they will not claim tax/duty benefit on 'Delivery Vehicle'.
- 2.4. After due deliberations, the Approval Committee <u>approved</u> the proposal subject to submission of requisite documents / information as mentioned above.

- 3.1 It was informed that the Approval Committee in its meeting held on 27.05.2019 had approved the proposal of M/s. Poly Medicure Ltd. had submitted proposal for setting up of its 2nd unit over an area of 14422.74 Sqmt. at Plot No. PA-010-018 in the Multi-Product SEZ of M/s. Mahindra World City (Jaipur) Ltd. located at Village Kalwara, Jhai, Bhamboriya, Bagru Khurd & Newta, Tehsil-Sanganer, Distt- Jaipur (Rajasthan) to undertake manufacturing of following items, subject to submission of required documents including details of Items of manufacture proposed under "Other Medical Devices & Components":-

3.2. It was informed that M/s. Poly Medicure Ltd. vide its letter dated 28.05.2019 & subsequent letter dated 27.06.2019 submitted required documents as well as revised proposed item of manufacture, as given below:-

3.3. Further, it was informed that M/s. Poly Medicure Ltd. had also made changes in projected value of imported & indigenous raw materials, forex outgo & NFE projections, as given below:-

3.4. It was informed that on the basis of revised item of manufacture and revised projections submitted by the unit, the Letter of Approval was issued on 08.07.2019, subject to its ratification by

the Approval Committee. Further, it was informed that in the LOA issued to the unit, it had been clearly mentioned that "No import or export of any items will be allowed, which are falling under the Prohibited/Restricted items under prevalent Import / Export policy given in ITC(HS) Classification of DGFT", as the unit had proposed DTA procurement of Raw Material under ITC(HS) Code 15180040 (Amizoil), which is 'Prohibited' under Import Policy- 2017 & Export Policy-2018 of DGFT.

3.5. After due deliberations, the Approval Committee <u>ratified</u> the aforesaid changes in the item of manufacture & projected value of imported & indigenous raw materials, forex outgo & NFE projections given by the unit.

- 4.1 It was informed to the Approval Committee that while considering of the proposal of M/s. Orvi Design Studio for inclusion of above additional items of manufacture in LOA, the Approval Committee in its meeting held on 17.12.2018 had clarified that import of Mother of Pearl (ITC HS Code 96019090) is 'Restricted', hence import of Mother of Pearl shall not be allowed. However, Approval Committee pointed out that import of the restricted item i.e. Mother of Pearl can be allowed by Board of Approval.
- 4.2. It was informed that M/s. Orvi Design Studio vide its letters dated 21.02.2019 requested to forward its proposal to BOA for import / DTA procurement of 'Mother of Pearl (ITC HS Code 96019090)' as raw material for carrying out manufacture of following final product using Mother of Pearl:-

- 4.3. Further, it was informed that the unit had submitted manufacturing process (flow-chart) in respect of 'Mother of Pearls' for manufacturing of tiles. The manufacturing process (flow chart) indicates following steps of process:-
 - Step 1- Procure different types of Mother of pearl from authorized dealers across India and Overseas.

- Step 2- Sorting it according to the standards and then process it according to the usage of the design and elements that will be incorporated into the base material like all type of stone, Wood, Glass, Vitrified tiles.
- Step 3- Inlaying Mother of pearl into the base material like all type of stone, Wood, Glass, Vitrified titles with the help of adhesives.
- Step 4- Polishing of the tile.
- 4.4. It was informed that the proposal of M/s. Orvi Design Studio for import / DTA procurement of 'Mother of Pearl', as raw material in respect of its unit located in the Multi-Product SEZ of M/s. Mahindra World City (Jaipur) Ltd. at Jaipur (Rajasthan), had been forwarded for consideration by BoA, in terms of Instruction No. 47 dated 04.03.2010 issued by DOC. It was informed that the Board of Approval in its meeting held on 18.06.2019 approved the proposal of the unit for import / procurement of 'Mother of Pearl' as raw material subject to the condition that DC, NSEZ will ensure compliance of all other relevant conditions.
- 4.5. Shri Ghanshyan Baheli, General Manager, appeared before the Approval Committee and explained the proposal. He requested the Approval Committee to allow use of 'Coloured Stones' as raw materials. The representative of the unit informed that they also intend to import Marble Blocks & Marble Slabs with more than 20 MM thickness for manufacturing of handcrafted tiles, slabs and other items. However import of Marble Tiles / Slabs more than 20 MM thickness is not allowed as per DGFT Notification dated 17.09.2016.
- 4.6. After due deliberations, keeping in view the approval for import / procurement of 'Mother of Pearl' as raw material, granted by the BoA, and request made by representative of the unit, the Approval Committee approved the proposal for inclusion of following item of manufacture in LOA of the unit:-

- 4.7. As regards, unit's intention for import of Marble Blocks & Marble Slabs with more than 20 MM thickness, the Approval Committee advised the representative of the unit to submit separate proposal to this office.
