Minutes of the Approval Committee meeting in respect of private SEZs located in Noida, Greater Noida & Khurja held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner, NSEZ at 04:00 PM on 03.08.2023.

- 1. Besides, during the meeting i) Shri Rajesh Kumar, DDC, ii). Shri Amit Gupta, Specified Officer, iii) Shri Prakash Chand Upadhyay, ADC, iv) Shri Pramod Kumar, ADC and; iv) Shri Anuj Dixit, UDC were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.
- 2. At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, wherever required, the following decisions were taken unanimously:-

Item No. 1. <u>Ratification of the Minutes of the Approval Committee</u> meeting held on 07.07.2023:-

It was informed to the Approval Committee that due to typo at Item no. 2(ii) of the agenda and minutes of the meeting of SEZs in Noida, Greater Noida & Khurja held on 07.07.2023, the proposed location of M/s. CRM Services India Pvt. Ltd. was written as '4th floor, Tower-8 & 4th floor, Tower-9' instead of '4th floor, Tower-8, 4th floor, Tower-9 & Ground floor, Tower-11'. The LOA dated 31.07.2023 has been issued to the unit with correct location. The Committee took note of the same. As no reference in respect of the decisions of the Approval Committee held on 07.07.2023 was received from any of the members of the Approval Committee or trade, therefore, Minutes of the Meeting held on 07.07.2023 were ratified.

- 2(i).2. The Committee observed that the estimated cost of 'UPS AC/DC Capacitors' & '4 Nos. UPS with Accessories' proposed at SI No. 64 & 65 respectively in Annexure-III, appears to be higher side.
- 2(i).3. Shri Mukesh Chauhan, Senior Manager & Shri Nikhil Rathod, Group Manager of M/s Coforge Limited joined the meeting through video conferencing and explained the requirement of proposed materials. The representatives informed that the proposed UPS are 80 KVA online UPS with its all accessories as well as UPS AC/DC capacitors and the estimated cost have been mentioned on the basis of quotation taken from vendors like Schneider Electric etc. They also assured that they will share a copy of quotations if required.
- 2(i).4. The Approval Committee discussed the proposal in detail and after due deliberations <u>approved</u> the proposed list of materials, subject to submission of copy of vendors quotation in respect of '20 Nos. 2(ii)2. It was informed that the developer has proposed procurement of '2000 Kg HFC Gas' from DTA at S No. 8 under authorised operation *'Fire protection system with sprinklers, fire and smoke detectors (Annexure-I)'*, which is 'Restricted' for Export, as per Notification No.62/2015-2020 dated 23.03.2022 issued by DGFT.

2(ii)3. Shri D.K. Sharma, Associate Director & Shri Vinod Kumar Singh, Associate Director of M/s HCL Technologies Ltd. joined the meeting through video conferencing and explained the requirement of proposed materials. The representatives informed that inadvertently the 'HFC Gas' has been proposed in the aforesaid list. The representative requested to exclude the same from SI. - 4(i).2. The Committee observed that some of the proposed items come under hazardous chemicals and the unit needs to have licence from the competent authority for storage of such hazardous items.
- 4(i).3. Shri Roshan Lal, Sr. Manager of M/s. Arshiya 3PL Services Pvt. Ltd. and Shri Sandeep Batta, AVP of M/s. Jupiter International joined the meeting through video conferencing and explain the proposal. Shri Roshan Lal informed to the Committee that they have obtained licence from the State Government for storage of hazardous items in their FTWZ unit. He further informed that their client M/s. Jupiter International have a manufacturing unit in Baddi (Himachal Pradesh) where the storage space is limited. M/s. Jupiter International will store the proposed chemicals in the FTWZ unit and use the same as per their requirement.
- 4(i).4. The Approval Committee discussed the proposal in detail and after due deliberations <u>approved</u> the inclusion of proposed items in the LOA of the unit. The approval is subject to compliance of relevant rules / laws for storage of hazardous & toxic chemicals in FTWZ unit.

4(ii).2. It was informed that as per directions of the Committee the Standard Operating Procedure (SOP) in respect of aforesaid items was forwarded to DOC for vetting. In this regard, DOC has informed that as per extant SEZ law, approval of the BoA is required in case of prohibited items only. Accordingly, it is requested that the matter may kindly be examined in terms of rules 26 and 27 of the SEZ Rules, 2006. Further, a clarification from MHA was received stating that the aforesaid items are free to import and does not require any licence. HS Code 88071000, Aircraft Engines are also allowed to import freely except second hand / reconditioned parts, which can be imported without licence subject to approval from DGCA.

- 4(ii).3. The Approval Committee discussed the proposal in light of clarifications received from DOC and MHA. After due deliberations the Committee <u>approved</u> the inclusion of proposed items in the LOA of the unit. The approval is subject to following terms & conditions:
 - i. Products which are "Prohibited/Restricted" for import and exports under the Foreign * Trade Policy (FTP) would not be permitted.
 - ii. The scope of authorized operations of the unit will be strictly as per Rule 18(5) of SEZ Rules, 2006.
 - iii. No Domestic Tariff Area (DTA) sale of these items shall be permitted. Only physical export shall be permitted which means that the products would need to be exported out of the geographical territory of India. This would exclude both deemed exports and even SEZ to SEZ transactions.
 - iv. Port restrictions as per DGFT Notifications / Public Notice / Instructions issued from time-to-time, shall be applicable.
 - v. The unit shall obtain necessary 'NOC' from the concerned departments, whenever required as per Import Policy of DGFT or policy of the State Government.
