#### NOIDA SPECIAL ECONOMIC ZONE

Minutes of the Approval Committee meeting in respect of SEZs located in Noida, Greater Noida & Khurja (Uttar Pradesh), held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner, NSEZ at 11.30 AM on 07.03.2024.

The following members of Approval Committee were present during the meeting:-

Besides, during the meeting (i). Shri Amit Gupta, Specified Officer (ii) Shri Rajesh Kumar, DDC, (iii). Shri Prakash Chand Upadhyay, ADC; (iv) Shri Pramod Kumar, ADC and (v) Shri Sunil Gulyani, Stenographer / Dealing Hand were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.

At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken unanimously:-

# 1. Ratification of the Minutes of the Approval Committee meeting held on 01.02.2024:-

As no reference in respect of the decisions of the Approval Committee held on 01.02.2024 was received from any of the members of the Approval Committee or trade, the Minutes of the Meeting held on 01.02.2024 were ratified.

# Item No. 2: Proposal for setting up of new unit.

#### 2.1: M/s. Accelerate Logistics Private Limited (Arshiva SEZ)

- 2.1.1. M/s. Accelerate Logistics Private Limited had submitted an application for setting up a unit in Arshiya Northern FTWZ Limited Multi Sector SEZ at Village Ibrahimpur, Junaidpur urf Maujpur, District Bulandshahr (U.P.) to undertake "Warehousing, Packing, Re-packing, Labeling, Re-labeling, Consolidation list of goods Quality checking and testing" for the items under list of 35 Nos. items with HS Codes submitted by applicant". The applicant projected exports of Rs.1369.10 lakhs and cumulative NFE of Rs.1137.02 lakhs over a period of five years. The applicant submitted a copy of letter of consent for space admeasuring 464.52 Square meter (5000 Square feet) in SEZ, issued by the Developer vide letter dated 05.12.2023.
- 2.1.2. Following documents / information are requested to be submitted which have been communicated to the applicant:
  - i. The applicant needs to clearly mention the proposed authorized operations /

activities to be carried out in FTWZ, in Para V of Form-F, as per activities allowed under Rule 18(5) of SEZ Rules, 2006. List of proposed HS Codes / goods also required to be given separately.

- ii. Copy of INC-22 for change of registered office address.
- iii. In Affidavit submitted by the applicant, date of application has been mentioned as 02.01.2024 instead of 05.01.2024.
- iv. Copy of LOA of existing FTWZ unit in JNPA-SEZ.
- v. Copies of DIR-12 for appointment of both the directors.
- vi. Copies of Audited Balance sheet of the company required to be submitted.
- vii. CA Certified current shareholding pattern of the applicant company.
- viii. In Project Report, the amount of 'Rentals to Developer' has been shown as Foreign Exchange Outgo. Hence, applicant needs clarify as to whether the rentals to developer have to be paid in foreign currency or INR.
- ix. List of proposed imported input services of Rs.232.08 lakhs giving description as per default list of 67 services.
- x. Details in respect of Income Tax Department
- 2.1.3. Shri Vinod Parikh, authorized representative and Shri Sandeep T. Shejwal, Director of M/s. Accelerate Logistics Private Limited joined the meeting through Video Conferencing and explained the proposal.
- 2.1.4. The Approval Committee discussed the proposal in detail and took on board various parameters like quality concerns, possibility of diversion during the long inland transport, lack of economic rationale given the high freight costs incurred and sensitivity of certain commodities as manifested by investigations on some goods conducted by agencies and import value below which some of these goods are prohibited. In this context, it felt that certain goods sought by the unit like Cashew Nut (HSN 08013100), Broken Cashew Nut (HSN 08013210), Areca Nut (HSN 080280), Black Pepper (HSN 09041120), White pepper (HSN 09041190) & Brazil Nut (HSN 20081990) were sensitive.
- 2.1.5 Accordingly, the Approval Committee <u>approved</u> the proposal, barring a list of some sensitive products for setting up of unit to undertake authorised activities strictly in accordance with Rule 18(5) of SEZ Rules, 2006 read with Instruction No. 49 dated 10.03.2010. The list of products proposed for exclusion from the original list were HSN 08013100, 08013210, 080280, 09041120, 09041190 & 20081990 as also those 'Restricted' & 'Prohibited' for imports & exports". The approval is subject to submission of documents pointed out above. The approval is also subject of the following terms & conditions:-
  - Products which are "Prohibited / Restricted" for import and export under the Foreign Trade Policy (FTP) would not be permitted.
  - ii. The scope of authorized operations of the unit will be strictly as per Rule 18(5) of SEZ Rules, 2006.
  - iii. No DTA Sale shall be allowed in respect of approved items.
  - iv. All transaction shall be only in convertible foreign currency in terms of proviso to Rule 18(5) of SEZ Rules, 2006.
  - v. Port restrictions as per DGFT Notifications / Public Notice / Instructions issued from time-to-time, shall be applicable.
  - vi. The unit shall ensure FSSAI Certification in respect of approved items.
  - vii. The unit shall obtain necessary 'NOC' for import / export from the concerned



Central / State Ministries / departments and relevant authorities including Import Policy of DGFT.

# 2.2: M/s. IBIDEN Singapore Pte Limited India Branch Office (Arshiya SEZ)

- 2.2.1. M/s. IBIDEN Singapore Pte Limited India Branch Office has submitted application for setting up a (Branch Office) unit in Arshiya Northern FTWZ Limited Multi Sector SEZ at Village Ibrahimpur, Junaidpur urf Maujpur, District Bulandshahr (U.P.) to undertake "Import and distribution of Silicon Carbide Bricks and Shapes (HSN 69022040)". The applicant projected exports of Rs.24830.66 lakhs and cumulative NFE of Rs.1624.43 lakhs over a period of five years. The applicant submitted a copy of letter of consent for space measuring 46.52 Square meter (500 Square feet) in SEZs, issued by the Developer vide letter dated 05.02.2024.
- 2.2.2. Following documents / information are requested to be submitted which have been communicated to the applicant:
  - i. Form-F and all supporting documents submitted by applicant have not been signed / stamped.
  - ii. Name of Mr. Srivivasamani Rajagopalan required to be removed from the list of directors as mentioned at Para IV of Form-F, as he is not director of the applicant company as per separate list of three directors attached with application.
  - iii. The applicant needs to clearly mention proposed authorized activities in Para V of Form-F, as allowed under Rule 18(5) of SEZ Rules, 2006 and list of goods required to be given separately.
  - iv. Documents in support of Registered Office address at Bengaluru, required to be submitted.
  - v. Brief profile of all directors required to be submitted.
  - vi. CA Certified current shareholding pattern of the applicant company required to be submitted.
  - vii. List of Imported Raw materials of Rs.23206.25 lakhs as mentioned in Para VII(b) giving their HS Code, required to be submitted.
  - viii. List of proposed indigenous input services of Rs.899.51 lakhs giving description as per default list of 67 services, required to be submitted.
  - ix. Undertaking to fulfill Environment & Pollution control norms, required to be submitted.
- 2.2.3. Shri Srivivasamani Rajagopalan, Shri Abhishek and Ms. Dhanashree, authorized representatives of M/s. IBIDEN Singapore Pte Limited India Branch Office joined the meeting through Video Conferencing and explained the proposal. The representatives informed that M/s. IBIDEN Singapore Pte Limited doing business in India since 1997. They further informed that they will import high quality Silicon Carbide substrates tailored for Diesel Filter application and distribute the same to automobile OEMs in India. Further, they informed that all transactions shall be in foreign currency and the proposed item does not come under SCOMET items.
- 2.1.4. The Approval Committee discussed the proposal in detail and after due deliberations, approved the proposal for setting up of unit to undertake "Import and distribution of Silicon Carbide Bricks and Shapes (HSN 69022040)" strictly in accordance with Rule 18(5) of SEZ Rules, 2006 read with Instruction No. 49 dated 10.03.2010 and also excluding those items 'Restricted' & 'Prohibited' for imports &



exports". The approval is subject to obtaining, if applicable, any approvals including SCOMET and adherence to RBI directions/circulars. The approval is subject to submission of documents as pointed out above. Further, the approval is subject to the following terms & conditions:-

- i. Products which are "Prohibited / Restricted" for import and export under the Foreign Trade Policy (FTP) would not be permitted.
- ii. The scope of authorized operations of the unit will be strictly as per Rule 18(5) of SEZ Rules, 2006.
- iii. All transaction shall be only in convertible foreign currency in terms of proviso to Rule 18(5) of SEZ Rules, 2006.
- iv. Port restrictions as per DGFT Notifications / Public Notice / Instructions issued from time-to-time, shall be applicable.
- v. The unit shall obtain, if applicable, any authorisations.
- vi. The unit shall obtain necessary 'NOC' for import / export from the concerned Central / State Ministries / departments and relevant authorities including Import Policy of DGFT.

The Committee observed that as per Proviso 4 to Rule 19(2) of SEZ Rules, 2006, the Approval Committee may approve proposals for merger of Letters of Approvals of two or more Units of the same company or firm subject to certain condition. The conditions are that these units fall within the same Special Economic Zone and after merger, block period for calculation of Net Foreign Exchange shall be from the date of commencement of production of the Unit which commenced first. Moreover, the Income Tax exemption shall be considered from the date of start of operation of the first unit.
- 5.1.3. Shri Parthasarathy K, Sr. Manager of M/s. Cognizant Technology Solutions India Private Limited joined the meeting through video conferencing and explained the proposal.
- 5.1.4. The Approval Committee discussed the proposal in detail and after due deliberations, the Committee <u>approved</u> the proposal for merger LOA No. 10/23/2019-SEZ/7515 dated 04.07.2019 into LOA No. 10/25/2014-SEZ/3994 dated 24.04.2014, in terms of Proviso 4 to Rule 19(2) of SEZ Rules, 2006. This approval is subject to the condition that after merger, block period for calculation of Net Foreign Exchange shall be from the date of commencement of production of the Unit which commenced first i.e. w.e.f. 22.10.2014 and the Income Tax exemption shall be considered from the date of start of operation of the first unit i.e. w.e.f. 22.10.2014. The current block period of

merged LOA shall be from 22.10.2019 to 21.10.2024. This approval is further subject submission of following documents:-

- The unit needs to submit authorised operations they want to retain after merger of LOAs.
- ii. The unit needs to submit combined projections for Imported & Indigenous capital goods as well as Imported & Indigenous input services upon merger of LOA. List of imported & indigenous input services giving description as per default list of 67 services also required to be submitted.
- iii. In APRs for FY 2014-15 to 2022-23 of Unit-I, the unit has shown DTA Sale of Rs.213.81 lakhs. Hence, the unit needs to provide details of sale of services in DTA against payment received in INR during that period.
- iv. The matter of Sale of Services in DTA for Rs 171.91 lakhs against INR during the period 2019-20 in respect of Unit-II has been adjudicated vide OIO dated 04.10.2021. The unit has deposited penalty amount of Rs.17,191/-. However, as per APRs for FY 2020-21 to 2022-23, the unit has further shown DTA sale of Rs.2916.29 lakhs. Hence, the unit needs to provide details of sale of services in DTA against payment received in INR during FY 2020-21 to 2022-23.
- v. Copies of valid registered lease deed in respect of premises of both the units required to be submitted.
- vi. The unit needs to submit 'NOC' from the SEZ Developer for merger of LOAs.

  - iii. Requirement of built-up area mentioned as '0.00' in Para VIII(2) of Form-F, as developer has given provisional offer of space for allotment of 34567 Sqft. built-up area at 6<sup>th</sup> floor, Tower No. 6.
  - iv. Requirement of land shall be removed from Para VIII(1) of Form-F, as developer has given provisional offer of space for allotment of 34567 Sqft. built-up area at 6<sup>th</sup> floor, Tower No. 6.
  - v. Reply in respect of para (XII) (ii) & (iv) of Form-F should be given in Yes or No.
  - vi. Breakup of proposed foreign exchange outgo of Rs.3984.61 lakhs required to be submitted.
  - vii. Value-wise list of indigenous input services of Rs.1832 lakhs giving description as per default list of 67 services, required to be submitted.
  - viii. List of imported & indigenous capital goods/lease hold assets, required to be submitted.
- 8.1.3. Mr. Anuj Jain, Senior Manager, Mr. Hridayesh Shukla, SCM, Mr Rahul Shekhar, Consultant and Mr Mohit Jhawar, Consultant of M/s. Airtel International LLP appeared before the Approval Committee. Besides, Shri Vivek Patni, Designated Partner of M/s.

Margo Impex Private Limited had received the letter dated 18.01.2024 of NSEZ on 24.01.2024.
