#### **NOIDA SPECIAL ECONOMIC ZONE**

Minutes of the Approval Committee meeting in respect of private SEZs located in Noida, Greater Noida & Khurja held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner, NSEZ at 11:00 AM on 07.07.2023.

The following members of Approval Committee participated in the meeting:-

- v. Shri Neeraj Kumar, Income Tax Officer, Noida.
- v. Besides, during the meeting i) Shri Rajesh Kumar, DDC, ii). Shri Amit Gupta, Specified Officer, iii) Shri Prakash Chand Upadhyay, ADC, iv) Shri Pramod Kumar, ADC and; iv) Shri Anuj Dixit, UDC, and were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.
- w. At the outset, the Chairman welcomed the participants. After a brief introduction, each item included in the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, wherever required, the following decisions were taken unanimously:-

## Item No. 1. Ratification of the Minutes of the Approval Committee meeting held on 01.06.2023:-

As no reference in respect of the decisions of the Approval Committee held on 01.06.2023 was received from any of the members of the Approval Committee or trade, therefore, Minutes of the Meeting held on 01.06.2023 were ratified.

#### Item No.2: Proposal for setting up of new unit:-

#### 2(i). M/s. Dancenter A/S.

2(i).1. M/s. Dancenter A/S, a company incorporated under laws of Denmark,has submitted proposal for setting up a unit (Branch Office) over an built-up area of 929.03 Sqmt. (10000 Sqft.) in the Artha Infratech Pvt. Ltd. IT/ITES SEZ at Plot No.21, Sector-Techzone IV, Greater Noida (Uttar Pradesh) to undertake service activities i.e. "Data processing services in relation to human resource, finance and other support services(CPC-843), Information Technology support services including software consulting(CPC-842) & Back-office operations, computer software services, call center services, business services, professional services (CPC-866)". The applicant has proposed export of Rs. 25879.00 lakhs and cumulative NFE of Rs. 25659.00 lakhs over a period of five years. Projected investment of Rs. 100.00 lakhs toward imported capital goods and Rs.384.28 lakhs toward indigenous capital goods have been proposed. The applicant has also proposed imported & indigenous input services of Rs.120.00 lakhs & Rs.4381.00 lakhs, respectively. The applicant has submitted provisional offer of space dated 19.06.2023 issued by M/s. Artha Business Park LLP, Co-developer for allotment of

proposed space.

- 2(i).2. It was informed to the Committee that following shortcomings have been observed in the application in the first instance, which has been communicated to the applicant:
  - i. Company's registered office at Denmark is required to be mentioned at Para I of Form-F. Applicant has mentioned proposed SEZ location in place of registered office address.
  - ii. In Form-F, Company's PAN Card NOTAV9999V has been mentioned. Hence, copy of the same required to be submitted.
  - iii. The applicant has submitted copy of Certificate of Registration dated 15.06.2023 issued by Danish Business Authority. Whereas, copies of Annual Report (Denmark) of the company for FY 2019-20, 2020-21 & 2021-22 have been submitted. This proves that the company had incorporated prior to 2019-20. Hence, the applicant needs to submit copy of Certificate of Incorporation of the company. Further, as per project report, company was established on 06.05.1982 and there are five directors in the Board of the company whereas only two directors are shown in Form-F.
  - iv. Correct CPC Codes need to be indicated as per CPC version 2.1.
  - v. Proposed location of unit i.e. name of floor, Building / Tower No. not mentioned in the provisional offer of space dated 19.06.2023 issued by M/s. Artha Business Park LLP, Co-developer.
  - vi. Separate list of proposed imported & indigenous input services of Rs.120.00 lakhs & Rs.4381.00 lakhs, respectively, required to be submitted giving number & description as per default list of 67 services.
  - vii. Separate list of imported & indigenous capital goods required to be submitted.
- viii. Reply in respect of Para XII(ii & iv) for Form-F may be given as "Yes or No'.
- ix. Documentary evidence in support of appointment of directors required to be submitted.
- x. Information related to Income Tax Deptt. required to be submitted.
- 2(i).3. The Committee observed that as per RBI Master Circular No. 7/2015-16 dated 01.07.2015 (updated as on 30.10.2015), as amended vide Notification No. FEMA 22(R) /RB-2016 dated March 31, 2016 issued by the Reserve Bank of India, there is a general permission to non-resident companies for establishing BO in the Special Economic Zones (SEZs) to undertake manufacturing and service activities subject to the branch complying with the following conditions:
  - a. such branch offices are functioning in those sectors where 100% FDI is permitted;
  - b. such branch offices comply with Chapter XXII of the Companies Act, 2013; and;
  - c. such branch offices function on a stand-alone basis.
- 2(i).4. Ms. Ranju, AVP, Shri Rajiv Chugh, authorised representative & Shri Tejasvi Anand, authorised representative of M/s. DanCenter A/S appeared before the Approval Committee and explained the proposal.
- 2(i).5. The Approval Committee discussed the proposal in detail and after due deliberations <u>approved</u> the proposal. This approval is subject to submission of documents as pointed out at Para 2(i).2 above.

## 2(ii). M/s. CRM Services India Private Limited.

2(ii).1. M/s. CRM Services India Private Limited has submitted proposal for setting



up a unit over a built-up area of 7595.84 Sqmt. (81761 Sqft.) at 4th floor, Tower-8 & 4<sup>th</sup> floor, Tower-9, in the Seaview Developers Pvt. Ltd. IT/ITES SEZ at Plot No.20 & 21, Sector-135, Noida (Uttar Pradesh). The unit would undertake service activities i.e. "ITES (Financial Auditing Services) (CPC-86221), ITES (Revenue Accounting Services. Financial compilation)(CPC-86213), ITES Accounting Services)(CPC-86212), ITES (Revenue Accounting Services other accounting services) (CPC-86219), ITES (Human Resource Services)(CPC-86504), ITES (Other data processing services)(CPC-86504)". The applicant has projected exports of Rs.9240.00 lakhs with a cumulative NFÉ of Rs.8240.00 lakhs over a period of five years. The projected investment of Rs.1000.00 lakhs towards imported capital goods & Rs.3000.00 lakhs towards indigenous capital goods The applicant has also proposed indigenous input services of Rs.500.00 lakhs. The applicant has submitted provisional offer of space dated 23.06.2023 issued by the SEZ developer for allotment of proposed space.

- 2(ii).2. It was informed to the Committee that following shortcomings have been observed in the application in the first instance:
  - i. Separate value-wise list of indigenous input services required to be submitted giving number & description as per default list of 67 services.
  - ii. Undertaking to fulfill Environmental control norms required to be submitted.
  - iii. Copies of Form-32, DIR-12 for appointment of directors namely Shri Bhupender Singh, Shri Anish Mukker & Shri Vinod Mehta and copy of form-32 / DIR-12 for cessation of all earlier directors, required to be submitted.
  - iv. Information related to Income Tax Deptt. required to be submitted.
  - v. There is a difference in the registered office address of the unit in ROC & IEC.
  - vi. CA certified shareholding pattern of the company is also required.
  - vii. In the list of imported goods, Carpet is mentioned with a value of Rs.1,35,00,000/-seems on the higher side.
  - viii. CPC Codes mentioned by the applicant needs to be rechecked / provided correctly by applicant taking into account the CPC version 2.1.
  - ix. Copies of PAN Cards of directors need to be submitted.
  - x. Copy of complete audited balance sheet of company for last three years are required to be submitted.
- 2(ii).3. Shri Devendra Singh, Director & Shri Sandeep Vahrani, VP ofM/s. CRM Services India Private Limited appeared before the Approval Committee and explained the proposal.
- 2(ii).4. The Approval Committee discussed the proposal in detail and after due deliberations <u>approved</u> the proposal. This approval is subject to submission of documents as pointed out at Para 2(ii).2 above.

## 2(iii). M/s. We Spirits Inc.

2(iii).1. M/s. We Spirits Inc. has submitted application for setting up a unit in Arshiya Northern FTWZ Ltd. Free Trade and Warehousing Zone at Village Ibrahimpur, Junaidpur urf Maujpur, Distt- Bulandshahr (U.P.) to undertake "Warehousing, Trading with or without labeling, packing or re-packing without any processing, Assembly of Completely Knocked Down or Semi Knocked Down kits for the items as per list attached except 'Restricted' & Prohibited' items". The



applicant has attached list of 12 Nos. of 4 digit HS Codes with item description. The applicant projected exports of Rs.67178.00 lakhs and cumulative NFE of Rs.42906.00 lakhs over a period of five years. The applicant submitted a copy of letter of consent for space admeasuring 100 Sqmt. (1076 Sqft.) in Arshiya FTWZ, issued by FTWZ Developer vide letter dated 16.06.2023.

2(iii).2. Following shortcomings have been observed in the application in the first instance:-

- i. Copy of registered partnership deed required to be submitted.
- ii. Breakup of proposed foreign exchange outgo of Rs.24272.00 lakhs required to be submitted.
- 2(iii).3. Shri Jaskaran Singh Dhaliwal, Director, Ms. Manmeet Kaur Bedi, VP Corp. Affairs, & Shri Anshul Bhardwaj, Chartered Accountant of M/s. We Spirits Inc. appeared before the Approval Committee and explained the proposal. The representatives informed that We Spirits Inc. is a part of group, Whistler Spirits that has more than 2 decades of experience of working in the retail and the wholesale liquor sector. They further informed that 60% business of the proposed FTWZ unit shall be from Whistler Spirits and 40% business from Diageo & others.
- 2(iii).4. The Approval Committee discussed the proposal in detail and after due deliberations approval the proposal for setting up of unit to undertake authorised activities strictly in accordance with Rule 18(5) of SEZ Rules, 2006 read with Instruction No. 49 dated 10.03.2010 for the proposed items under HS Code 1107, 1806, 1905, 2202, 2208 (only whisky) & 2209, subject to submission of documents pointed out at Para 2(iii).2. The approval of items under HS Code 2208 (only whisky) has been allowed keeping in view the production undertaken by the unit thereby facilitating manufacturing from the country. Moreover, no products which are 'Restricted' & 'Prohibited' for imports & exports' would be allowed. The applicant shall submit copy of Excise License of M/s. Whistler Spirits, Punjab & its other unit in Himachal Pradesh. The approval is subject to the following terms & conditions:
  - i. Products which are "Prohibited/Restricted" for imports and exports under Foreign Trade Policy (FTP) would not be permitted.
  - ii. The scope of authorized operations of the unit will be strictly as per Rule 18(5) of SEZ Rules, 2006 read with Instruction No. 49 dated 10.03.2010 and other instructions/orders on the subject.
  - iii. No DTA Sale of goods under HS Code 2208 shall be allowed.
  - iv. All transactions, including any sale in DTA shall be only in convertible foreign currency in terms of proviso to Rule 18(5) of SEZ Rules, 2006.
  - v. Port restrictions as per DGFT Notifications / Public Notice / Instructions issued from time-to-time, shall be applicable.
  - vi. The unit shall obtain necessary 'NOC' from the concerned departments, whenever required as per Import Policy of DGFT or excise policy of the State Government.
