8.1.1. M/s. Siddhartha Logistics FTWZ Pvt. Ltd. has submitted proposal for setting up a unit

in the Free Trade & Warehousing Zone of M/s. Arshiya Northern FTWZ Ltd. at Village-Ibrahimpur, Junaidpur urf Maujpur, Khurja Distt- <u>Bulandshahr</u> (U.P.). Projected exports are Rs. 714.87 lakhs and the cumulative NFE is Rs. 504.70 lakhs over a period of five years. No investment on Plant & Machinery have proposed. Applicant has proposed requirement of indigenous Raw Materials, components, consumables etc. for Rs. 299 lakhs. In Form-F, the applicant has mentioned 455 Nos. Exim Codes & item description with capacity.

- 8.1.2. Following discrepancies ware observed in the proposal in first instance:
 - i. Form-F has not signed by the applicant.
 - ii. Activities to be carried out in the proposed FTWZ unit has not mentioned in Para V of Form-F.
 - iii. Details of existing SEZ units required to be mentioned in Para XII(ii) of Form-F and copies of existing LOAs required to be submitted.
 - iv. Project Report not submitted.
 - v. Date of application not mentioned in the Affidavit submitted by the applicant.
 - vi. Projected profitability statement required to be submitted.
 - vii.Residential address of Mr. Siddhartha Sen does not match with the address mentioned in his passport.
 - viii.Personal profile / Background of the directors of the company along with their experience in the proposed activities, required to be given.
 - ix.CA certified shareholding pattern of the company required to be submitted.
 - x. Details pertaining to Income Tax Deptt. required to be submitted.
- 8.1.3. Further, it was observed that the promoters of the company had obtained LOA No. 10/26/2012-SEZ/4226 dated 08.06.2012 in the name of M/s. Siddhartha Logistics Co. Pvt. Ltd. for setting up of unit in Arshiya Northern FTWZ Ltd. FTWZ, Khurja (U.P). The validity of the said LOA was extended upto 07.06.2015. However, the said unit was not implemented. The unit vide its letter dated 16.07.2014 had applied for exit from SEZ Scheme. Accordingly, the unit was requested vide this office letter dated 09.09.2014 to submit requisite documents. However, the unit did not submit the documents. Thereafter, the unit vide its letter dated 08.05.2017 came for extension of LOA. In this regard, a PH before DC, NSEZ was held on 22.11.2017 wherein the representative of the unit was directed to submit requisite documents. However, the unit did not submit the required documents. Now, they have submitted a fresh application for setting up a new unit in the name of M/s. Siddhartha Logistics FTWZ Pvt. Ltd.

After due deliberations, the Approval Committee unanimously approved the proposal to undertake authorized activities strictly in accordance with Rule 18(5) of SEZ Rules, 2006 read with Instruction No. 49 dated 10.03.2010 (as per proposed list of items as mentioned in Form-F, except HS Code 8710, all products under HS Chapter 93 (i.e. HS 9301, 9302, 9303, 9304, 9305, 930 and 9307), 9706, 9801 and 9802. Items _under HS Code 9608 are allowed except 'Pens and other articles with any part or plating of precious metals or rolled precious metals'. The approval is subject to submission of documents / information as pointed out at Para 8.1.2 above and further subject to the following terms & conditions:-

- i. No export / import of any item will be allowed which comes under "Prohibited/Restricted" items/Negative list under Import policy given in ITC(HS) Classification or any other law and/or covered under SCOMET list as per DGFT Notifications / Public Notice / Instructions issued from time-to-time.
- ii. In case import or export of any item is 'Restricted' by any conditions under FTP / Customs or any other rule / guidelines, such item should be imported / exported subject to such conditions.
- iii. Port restrictions as per DGFT Notifications / Public Notice / Instructions issued from time-to-time, shall be applicable.
- iv. Unit shall obtain necessary NOC from the concerned departments, whenever required as per Import Policy of DGFT.
- v. The scope of authorized operations of the unit will be strictly as per Rule 18(5) of SEZ Rules, 2006.
- vi. Any sale in DTA shall be only in convertible foreign currency in terms of proviso to Rule 18(5) of SEZ Rules, 2006.
