Besides, during the meeting i) Shri Vishal Gupta, Specified Officer (VC), ii) Shri Prakash Chand Upadhyay, ADC, (iii) Shri Mohan Veer Ruhella, ADC, (iv) Shri Rajendra Mohan Kashyap, Steno Gr-II, and (v) Sh. Anuj Dixit, UDC were also present to assist the Approval Committee. It was informed that the quorum is available and the meeting can proceed.
- 3. At the outset, the Chairman welcomed the participants. After brief introduction, each item included in the agenda was taken up for deliberations one by one. The life of these capacitors, are usually 5-to-7 years only and requires replacements in all towers, because their life, near to expiry. UPS comes under critical equipment category and direct related to business continuity.

- 3.7.2. Shri Raman Bhasin, Sr. AVP of M/s. Exl Service.com (India) Pvt. Ltd. joined the meeting through video conferencing and explained the proposal. He informed that the input services being availed by the unit are well covered under the default list of 67 services. They have prepares the list of input services with SAC Code and will submit the same.
- 3.7.3. After due deliberations, the Approval Committee unanimously took note of the revised projections of input services of the unit. The Approval Committed directed the representative of the unit to submit details of input services giving SL No. and description as per the default list of 67 services.

Item No. 4: Proposals for approval of additional input services (CAM Charges).

4.1: M/s. Optum Global Solutions (India) Pvt. Ltd.

- 4.1.1 The Approval Committee in its meeting held on 12.07.2021 had deferred the proposal of M/s. Optum Global Solutions (India) Pvt. Ltd. for inclusion of 'Common Area Maintenance ('CAM' or 'maintenance') charges' paid to the SEZ Developer for the area occupied by Cafeteria, in the default list of services to avail GST exemption in respect of its two units located in the Oxygen Business Park Pvt. Ltd. IT/ITES SEZ at Plot No. 07, Sector-144, Noida (U.P.), for greater deliberation on all aspects including practice in other SEZ's.
- 4.1.2 In this regard, Authorised Officer, Oxygen Business Park SEZ, Noida informed that the matter was discussed with the Authorised Officers of Seaview Developers Pvt. Ltd. SEZ, Sector-135, Noida, Golden Tower Infratech Pvt. Ltd. SEZ, Sector-144, Noida and Artha Infratech Pvt. Ltd. SEZ, Greater Noida. It has been communicated by them that in these SEZs all the "Common Area Maintenance" charges are being charged on invoices issued under LUT without payment of tax. Further, Specified Officer, Gurgaon SEZs has informed that in practice, the developer charges SEZ unit of CAM charges for common areas outside the premises at fixed rate which is also zero rated and no GST is charged on CAM (Common Area Maintenance).
- 4.1.3. Shri Harpreet Singh, Sr. Manager- Tax & Shri Tejasvi Anand, authorised representative of M/s. Optum Global Solutions (India) Pvt. Ltd. joined the meeting through video conferencing and explained the proposal.

4.1.4. After due deliberations, the Approval Committee, taking into account the practices being followed in other private SEZs under the jurisdiction of DC Noida SEZ in respect of levy of GST on Common Area Maintenance Charges and the fact that the common areas facilitated the operations of the SEZ, unanimously approved the proposal of M/s. Optum Global Solutions (India) Pvt. Ltd. for inclusion of 'Common Area Maintenance charges', being paid by the Unit to the SEZ Developer, as additional authorised service to the Unit to avail GST exemption on it, in respect of its two units located in the Oxygen Business Park Pvt. Ltd. IT/ITES SEZ, Sector-144, Noida (U.P.).

Item No. 5: Cases of Sale of services in DTA against payment in INR.

5.1. Ws. Saasforce Consulting Private Limited.

- 5.1.1 M/s. Saasforce Consulting Private Limited has submitted details of DTA sales of Rs.173,28,572/- in INR during FY 2019-20 by its unit located in the Seaview Developers Pvt. Ltd. IT/ITES SEZ at Sector-135, Noida (Uttar Pradesh). Out of total DTA sales of Rs.173,28,572/-, the unit has made sale of services in DTA for Rs.171,90,597/- (approx. Rs.171.91 lakhs) against payment in INR and scrap sale of Rs.1,37,975/-.
- 5.1.2. The Approval Committee observed that the services rendered by the unit in Domestic Tariff Area amounting to Rs.171.91 lakhs during FY 2019-20, are not as per the provisions of Section 2(z) (iii) of SEZ Act, 2005 whereby the services rendered by the SEZ unit should be paid in free foreign exchange only.
- 5.1.3. After due deliberations, the Approval Committee empowered the Development Commissioner, NSEZ to issue Show Cause Notice and adjudicate in terms of Section 11(2) of the Foreign Trade (Development & Regulation) Act, 1992, for effecting DTA sale of services in INR in violation of Section 2(z) of the SEZ Act, 2005.

Item No. 06. Alleged misuse of Letter of Approval:

6.1 Ms. Cricplex Sports Management Private Limited.

- 6.1.1 The Specified Officer, NSEZ forwarded an incident report on 06/08/2021 in respect of M/s. Cricplex Sports Management Private Limited and M/s. Aannya Software Private Limited, both the unit located in the Artha Infratech Pvt.Ltd. IT/ITES SEZ at Plot No.21, Sector Tech Zone-IV, Greater Noida (U.P), that:
 - "(i) It is to bring to your kind notice that last Night local police conducted a raid in the premises of M/s. Aannya Software (P) Ltd. & Cricplex Sports Management (P) Ltd both working as SEZ units under LOA no. 10/60/2019-SEZ/692 dated 16/01/2020 and LOA No. 10/59/2019-SEZ/937 dated 20/01/2020 respectively in the Artha Infratech (P) Ltd. (SEZ)
 - (ii) During the raid, police found that the said units were involved in clandestinely running a fake call center through which they were cheating US Citizens. In the process the Police has seized their Laptops and Desktops.
- 6.12. In this regard, a Show Cause Notice dt.10.08.2021 issued by DC, NSEZ to the unit as to why the LOA granted to the unit should not be cancelled under section 16 of the SEZ Act, 2006 for undertaking the alleged activities causing police action. The LOA of the unit was also suspended with immediate effect. The unit was also given opportunity to be heard in person before the Development Commissioner, to explain their case on Monday, 16th August and subsequently on 19th August, 2021 at 10:30 am through

video conferencing, however, no one appeared from the unit's side.

- 6.13. The SEZ Developer, M/s. Artha Infratech Pvt. Ltd. forwarded a copy of the FIR lodged against the SEZ unit after police raid in the unit's premises in the SEZ. The Developer mentioned that the furniture and fit-outs in the space occupied by the company is owned by Artha Infratech. The Police Officials have taken in their custody all the computers, records and other belongings of these companies. As a result nothing owned by the company remain lying in the office space it was operating from. The keys of unit's office have been handed over by the unit, now these spaces are under their control and their lock and keys. The Developer has requested to cancel the LOA issued to the unit with immediate effect.
- 6.1.4. As per copy of FIR received through the SEZ Developer, "the accused boys and girls spotted at SEZ unit premises making fraud with foreign citizens and cheating money from them. They would interact with the foreign citizens over internet and scare them by telling that their computer has got virus. Then the accused would got controlled their computer through remote access apps and informed them about some fake deficiencies in computer. The accused would then offer them a solution for virus removal and they used to ask for the codes of Google play cards from them and put them in other accounts and gives to their boss Mr. Deepak Aggarwal who gets converted it into cash and makes payment to its employees".
- 6.1.5. The unit has submitted a letter dt.17.08.2021, wherein the unit has mentioned that they surrender their LOA with immediate effect. The unit has also served Board Resolution dt.17.06.2021, authorizing Ms. Swati Yadav to represent the company and sign, submit and execute documents on behalf of the company.
- 6.16. Ms. Swati Yadav, HR of M/s. Cricplex Sports Management Private Limited and Shri Rajiv Baghel, Sr. Manager of M/s. Artha Infratech Pvt. Ltd. (SEZ Developer) joined the meeting through video conferencing. Ms. Swati Yadav informed that she was not aware about the activities being carried out in the SEZ unit. The directors of M/s. Cricplex Sports Management Private Limited and M/s. Aannya Software Private Limited are not in her contact. She further informed that no assets are left in unit's premises and they have handed over the keys of SEZ premises to the SEZ Developer. Shri Rajiv Baghel, representative of SEZ Developer informed that lease rent for 1 month is due against the unit. The representative of the Unit informed that the Management has decided to exit out the SEZ scheme.
- 6.17. After due deliberations, the Approval Committee directed to write to the Police Commissioner, G.B. Nagar/ Greater Noida to get information on the present status of the police case against the company and to also inform that the Unit has expressed its desire to exit out of the SEZ scheme. If the Police have any objection to the proposal of the Unit to exit out of the Unit, the same may be communicated to the office of Development Commissioner within 15 days of the receipt the letter otherwise it may be presumed that the Police authorities have no objection to the proposal of the Unit to exit from the SEZ scheme. It was also directed to take up the matter with GST department, SEZ developer and other concerned Govt. departments to indicate their dues, if any, against the company to decide further course of action in the matter.

6.2. Ws. Aannya Software Private Limited

6.2.1 The Specified Officer, NSEZ forwarded an incident report on 06/08/2021 in respect of M/s. Cricplex Sports Management Private Limited and M/s. Aannya Software Private Limited, both the unit located in the Artha Infratech Pvt.Ltd. IT/ITES SEZ at Plot No.21, Sector Tech Zone-IV, Greater Noida (U.P), that:

"(i) It is to bring to your kind notice that last Night local police conducted a raid in the premises of Ms. Aannya Software (P) Ltd. & Cricplex Sports Management (P) Ltd both working as SEZ units

under LOA no. 10/60/2019-SEZ/692 dated 16/01/2020 and LOA No. 10/59/2019-SEZ/937 dated 20/01/2020 respectively in the Artha Infratech (P) Ltd. (SEZ)

- (ii) During the raid, police found that the said units were involved in clandestinely running a fake call center through which they were cheating US Citizens. In the process the Police has seized their Laptops and Desktops.
- 6.2.2. In this regard, a Show Cause Notice dt.10.08.2021 issued by DC, NSEZ to the unit as to why the LOA granted to the unit should not be cancelled under section 16 of the SEZ Act, 2006 for undertaking the alleged activities causing police action. The LOA of the unit was also suspended with immediate effect. The unit was also given opportunity to be heard in person before the Development Commissioner, to explain their case on Monday, 16th August and subsequently on 19th August, 2021 at 10:00 am through video conferencing, however, no one appeared from the unit's side.
- 6.2.3. The SEZ Developer, M/s. Artha Infratech Pvt. Ltd. forwarded a copy of the FIR lodged against the SEZ unit after police raid in the unit's premises in the SEZ. The Developer mentioned that the furniture and fit-outs in the space occupied by the company is owned by Artha Infratech. The Police Officials have taken in their custody all the computers, records and other belongings of these companies. As a result nothing owned by the company remain lying in the office space it was operating from.
