Item No. 1. Ratification of the Minutes of the Approval Committee meeting held on 24.04,2023:-

As no reference in respect of the decisions of the Approval Committee held on 24.04.2023 was received from any of the members of the Approval Committee, therefore, Minutes of the Meeting held on 24.04.2023 were unanimously ratified.

Item No.2: Proposal for setting up of new unit:-

2.1. M/s. Gyro Web Services LLP

2.1.1. M/s. Gyro Web Services LLP has submitted proposal for setting up a unit over land area of '1000 Sqmt.' at Plot No. 6 in the Ansal IT City & Parks Limited IT/ITES SEZ at Sector-Techzone, Greater Noida (Uttar Pradesh) to undertake service activities i.e. "R&D in Artificial Intelligence and Machine Learning (CPC-8144), Digital Marketing (CPC-8313), Application Development (CPC-8314), e-Commerce Solutions(CPC-8314), Integration and Maintenance (CPC-8314), Software Development & Consulting (CPC-8314), Websites and Web Apps (CPC-8314), Web Hosting, VPS and Dedicated Servers (CPC-8315), Scientific and technical consulting services (CPC-8393)". The applicant has proposed an export of Rs.785.00 lakhs and cumulative NFE of Rs.785.00 lakhs over a period of five years. Projected investment of Rs.20.00 lakhs toward imported capital goods and Rs.20.00 lakhs towards indigenous capital goods has been proposed. The SEZ

Developer has allotted a Plot measuring 1000 Sqmt. at Plot No.PD-7B in SEZ for the unexpired period of the lease executed between M/s. Ansal IT City & Parks Ltd. (lessee) and GNIDA.

2.1.2. Following shortcomings have been observed in the application in the first instance:-

i. Form-F not signed at each page, but only at last page;

ii. Applicant has mentioned 'NA' at column XII (IV) of the Form-F. Reply has to be given in 'Yes' or 'No'.

iii. The LLP Agreement and Supplementary Agreements submitted by the applicant do not appear to be Registered. You are advised to submit copy of registered LLP Agreement and Supplementary Agreement;

iv. Copies of Aadhar, Passport and Voter ID Card have been provided in respect of the partners of the Unit. However, the addresses mentioned in Form-F do not matched with any of these documents. Hence, applicant needs to submit documents for address proof of the partners;

v. Cost of the Project not mentioned in the Detailed Project Report; and

vi. Details of source of funding with supporting documents required to be submitted.

vii. Correct details of Income tax Deptt. related information is required to be submitted.

Applicant has mentioned 'Not Applicable'.

- viii. In the Letter of Intent signed by the Developer with the Unit, at Sr. No. 19 of the table it has been reflected that Unit has to be operational in 3 years + 1 year extension. It is not clear representation of the Rule position in this regard.
- ix. List of imported and indigenous capital goods required to be submitted.
- 2.1.3. Ms. Kalpana Singh, Partner of M/s. Gyro Web Services LLP appeared before the Approval Committee and explained the proposal. She informed that she and Mr. Yogesh Singh were working as IT Advisory freelancers in a company at Malabo, Equatorial Guinea. In the year 2016 they incorporated this as an LLP firm, though no business has been undertaken. The SEZ plot was taken in 2018 for Rs.83 lakhs from M/s. Ansal IT City & Parks Ltd on a 99 year's lease. They have targeted to shift their IT advisory business to the SEZ. She further informed that the total cost of the project will be approx. Rs 6 crores which will be met from partners own fund.
- 2.1.4. After due deliberations, the Approval Committee unanimously granted inprinciple approval for the proposal. The Unit will submit documents as pointed out at Para 2.1.2 above along with Financial & technical statement, in the format to be provided and a final decision be taken on file. The Developer may also be sensitized that they have to initially provide provisional offer of space and lease of the land with Unit happens after the LOA is issued to the Unit.

- 3.1.2. The developer had informed there was a typo error in their application. The shipment of battery was under transit and will reach to port within next 2-3 days. The developer had furnished copy of an undated Invoice for import of 256 Batteries from Poland. The developer had further mentioned that this is a very critical shipment for their business. The developer had requested to allow to clear this import shipment against the aforesaid UAC approval dated 23.12.2022.
- 3.1.3. The request of the developer was considered on file and Competent Authority has approved the request of the developer for change of source of aforesaid items from 'Indigenous' to 'Import', subject to its ratification by the Approval Committee. The approval had been conveyed to the developer vide this office letter No. 15/139/2005-SEZ/2709 dated 06.04.2023.
- 3.1.4. After due deliberations, the Approval Committee unanimously took note of the approval for change of source of aforesaid items granted to the developer vide letter No. 15/139/2005-SEZ/2709 dated 06.04.2023.
