Minutes of meeting of the Approval Committee of Moradabad SEZ held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner (DC), Noida SEZ at 01:00 PM on 08/12/2022 through video conferencing.

- **A.** The following members of the Approval Committee were present through video conferencing during the meeting:-
 - Shri Rajesh Kumar, Dy. Development Commissioner, NSEZ (Nominee of Deptt. of Commerce in terms of letter dated 23/09/2008).
 - 2. Shri Chaman Lal, ADG (FT) O/o Addl. DGFT, CLA, New Delhi.
 - Shri Yogesh Kumar, Jt. Commissioner (Industries), DIC, Moradabad (Rep. of Principal Secretary, Industry, Govt. of UP.).
 - 4. Shri Nagendra Sirohi, Superintendent, CGST Moradabad.
 - 5. Shri Bhupendra Kumar Martolia, Inspector, Customs, ICD Moradabad.
 - 6. Shri Jitendra Kumar, Income Tax Officer, Income Tax Department, Moradabad.
- **B.** The other officers present in the Committee were S/Shri (i) Vikas, Assistant Development Commissioner, Moradabad SEZ, (ii) Lal Babu Prasad, Superintendent (Customs), Moradabad SEZ, (ii) and (iii) Joseph Upadhyay, Stenographer, Moradabad SEZ. Since the quorum was reached, the meeting proceeded forthwith.
- C. At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, the following decisions were unanimously taken:-
- 01. Ratification of Minutes of last meeting of the Approval Committee held on 10/11/2022.

There were no references or objections against the decisions of the Approval Committee meeting held on 10/11/2022. Hence, the Approval Committee took note of the same and accordingly, Minutes of the meeting held on 10/11/2022 were unanimously ratified.

02. Proposal for monitoring of NFE/Performance and inclusion of additional authorised operations.

2.1 M/s Shaila Exports

- The proposal of M/s Shaila Exports for revision of ITC(HS) codes for its authorised operations was placed before the Approval Committee for consideration.
- 2. No one from the unit appeared before the Approval Committee.
- 3. The Approval Committee, after due deliberations, noted that the ITC(HS) codes submitted by the unit are as per HS 2022 and covered under the authorised operations nomenclature mentioned in their LOA. Hence, the Committee approved the inclusion of ITC(HS) codes for authorised operations in LOA of M/s Shaila Exports India as under:

2.2 M/s Connect India Inc.

- The proposal of M/s Connect India Inc. for inclusion of additional authorised operations and addition of trading activities as authorised operations in LOA was placed before Approval Committee for consideration.
- 2. Shri Sandeep Garg, Partner of unit appeared before the Approval Committee and explained his proposal. He informed that additional authorised operations for manufacturing activities were requested due their demand in the international market. He also informed that the request for 'trading activities' as authorised operations were to source and supply finished lighting products to their existing buyers. Shri Garg further informed that the products enlisted for 'trading activities' won't be procured from DTA and will only be imported from overseas markets like China and USA. These would then be supplied domestically as deemed exports to other SEZ /EOU units and DTA Exporters against advance authorization.
- 3. The Approval Committee, after due deliberations, approved the inclusion of additional authorised operations under manufacturing activities in LOA of M/s Connect India Inc. as under:

4. The Committee further decided to accord 'in-principle' approval for proposal of unit for inclusion of 'trading activities' as authorised operations in its LOA. This approval is subject to submission of correct/revised 08 digit ITC(HS) codes as per HS 2022 nomenclature and examination of the same on file.

03. Proposal for permission for Import/ Job-work and renewal of LOA.

3.1 M/s Global Export House

- The proposal of M/s Global Export House for permission of Job-work on Sandalwood Wastage (imported), permission for import of Sandalwood from Mauritius, Madagascar, Australia and UAE as well as renewal of LOA No. NSEZ/4-367/2003-MBD/5879 dated 19.09.2014 were placed before Approval Committee for consideration.
- 2. Shri Mohan Maheshwari, Authorised Representative of the unit appeared before the Approval Committee and explained the proposal. He informed that he was given permission for import of 45.235 M. Tons of Sandalwood out of which 22.275 is already imported and the remaining is in transit. He claimed to have received fresh orders for which imports of Sandalwood is required. Shri Maheshwari informed that handicraft and sandalwood finger chips would be manufactured out of the imported Sandalwood. Subsequently, the waste such as chips, powder, sap-wood are used to extract Sandalwood Oil as well as manufacture Attar and Odoriferous powder. He further informed that for distillation of sandalwood oil, they are in process of setting up a separate unit in Moradabad SEZ within a span of 8-10 months. In the interim, he sought permission for taking out the Sandalwood Waste to the DTA at Kannauj, Uttar Pradesh for undertaking sub-contracting/jobwork. Shri Maheshwari also requested that their LOA is expiring on 31.12.2022 which may be renewed for the remaining period of its 2nd block i.e. up to 2026.
- 3. The Approval Committee, after due deliberations, decided as under:
- Renewed the LOA of M/s Global Export House for remaining period of 2nd block up to 19.01.2026.
- ii. Approved the request of the unit for Sandalwood import subject to following conditions as per SOP framed by this office for import of Sandalwood:
- **a.** The unit will make an application to O/o the DC, NSEZ seeking permission for import of Sandalwood prior to generation of bill of lading (B/L) at exporting port.
- b. DTA sales, sub-contracting /jobwork, Deemed Export or export to other SEZ units shall not be allowed for products originating from or having any content of the Imported Sandalwood or its waste/by-products.
- c. No DTA sale of Raw material, intermediate product or finished goods will be allowed except with prior permission and on production of Import License by the DTA buyer.
- **d.** 100% examination of Import and export of goods originating from the imported Sandalwood. The Export goods must be Handicraft items, which are freely exportable and recognized as Handicrafts by EPCH.
- e. Performance monitoring for the unit to be done annually and stock taking to be done

Quarterly basis.

- f. The waste generated is not allowed to be sold in DTA except with prior permission and on production of Import license by the DTA buyer; otherwise the same will be destroyed in presence of Officer of Customs.
- iii. The proposal for subcontracting/job-work of Sandalwood waste to DTA, will be examined separately on file in consultations with relevant agencies.
