Besides, during the meeting (i) Shri Tapan Bhattacharyya, Specified Officer, Moradabad SEZ and (ii) Dr. V. P. Sharma, Asstt. Development Commissioner, Moradabad SEZ also participated in the meeting through Video Conferencing to assist the Approval Committee. It was informed that the Quorum is complete and the meeting can be convened.

At the outset, the chairman welcomed the participants. After brief introduction, each items included in the agenda were taken up for deliberation one by one. After detailed deliberations among the members of the Approval Committee as well as interaction with the applicants/representatives of the units, the following decisions were taken:-

1 Ratification of Minutes of last meeting of the Approval Committee held on 27/05/2021

As no reference in respect of the decisions of the Approval Committee held on 27.05.2021 was received from any of the members of the Approval Committee or Trade, Minutes of the meeting held on 27/05/2021 were unanimously ratified.

2 Setting up of new unit in MSEZ

2.1 Proposal of M/s Ahmad Brass Inc. :-

- i) It was informed to the Approval Committee that the applicant has proposed to set up a new unit in Moradabad SEZ for manufacturing & export of handicrafts items made of Aluminium, Copper, Brass, Tin, Iron, Steel, Glass, Stone, Home Décor & Home Furnishing, Textile and Wooden & MDF Board Artwares with projected exports of Rs. 2143.76 Lakhs and the NFE of Rs. 1823.50 Lakhs over a period of five years.
- ii) It was also informed to the Approval Committee that the unit was previously granted LOA No. NSEZ/4-343/2003-MBD/7583 dated 17.10.2013 for Manufacturing & export of Handicrafts made of Stainless Steel, Copper, Iron, Aluminium, Brass, Glass and Wood but the unit failed to start production. The unit did not apply for extension of LOA for 3rd year beyond its expiry i.e. 16.10.2015, therefore initial LOA of the unit stands lapsed on 16.10.2015. Now M/s Ahmad Brass Inc. has submitted fresh proposal for setting up a new unit in Moradabad SEZ for manufacturing & export of handicrafts items.
- iii) Approval Committee enquired about the offer of allotment of space by the developer i.e. UPSIDA. Shri Sanjeev Kumar Bedi, Area Manager, UPSIDA informed that the unit is already in possession of Plot No. M-68, M-69 & M-70, Pocket-'B' which is valid till 27.07.2021. Representative of UPSIDA also informed that the unit has pending time extension and lease rent dues of approximately Rs. 1.47 Crores which unit should clear immediately.
- iv) Shri Tasleem Ahmad, partner appeared before the Approval committee to explain the project. He informed that he is already in handicrafts export business since 1983 and is having 02 DTA units namely M/s Ahmad Brass Corporation and M/s Progetto Inc. having cumulative export turnover of Rs. 63.50 Crores and Rs. 22.68 Crores respectively in last 03 financial years (2017-18 to 2019-20). He further informed that the proposed SEZ unit is a partnership firm having Shri Tasleem Ahmad and Shri Junaid Ahmad as partners. He further informed that their estimated project cost of Rs. 598.00 Lakhs would be financed through partners own funds. He further informed that they already have some of the construction work (boundary wall and Hall of approx. 5000.00 sq. ft.) done at the SEZ premises and will commence in production soon. He also informed that they have tie-ups with retail chains in USA, Europe, Germany and Italy and are

mainly exporting metal & glass combination products to these markets. At initial stage they will export metal and glass combination products to their existing buyers from SEZ premises and will diversify their product range in future as per demand. Shri Tasleem also informed the committee that they have already prepared bank DD for the pending dues of UPSIDA and will clear all dues of developer in 1-2 days.

- v) The Approval Committee, after due deliberations, approved the proposal of M/s Ahmad Brass Inc. for setting up a new unit in Moradabad SEZ for Manufacturing & Export of Handicrafts items made Aluminium, Copper, Brass, Iron & Steel, Glass and Home Décor & Home Furnishing as per ITC(HS) code mentioned below subject to the following conditions:
 - a. Payment of dues of developer i.e. UPSIDA amounting to Rs 1.47 Crores towards time extension and Rs. 1.37 Lakhs towards maintenance.
 - b. No restricted / prohibited items shall be allowed to import/ export.

2.2 Proposal of M/s Roots Agro Inc. :-

i) It was informed to the Approval Committee that the applicant has proposed to set up a new unit in Moradabad SEZ for manufacturing & export of Walnut Oil & Almond Oil with projected exports of Rs. 1727.76 Lakhs and the NFE of Rs. 502.23 Lakhs over a period of five

years.

- It was also informed to the Approval Committee that Shri Sumit Garg is already partner in ii) 02 units in Moradabad SEZ namely M/s Goldmine Overseas and M/s Shree Bankey Bihari International having cumulative export turnover of Rs. 16.02 Crores and Rs. 59.16 Crores in last 03 financial years (2017-18 to 2019-20).
- Approval Committee enquired about the offer of allotment of space by the developer i.e. iii) UPSIDA. Shri Sanjeev Kumar Bedi, Area Manager, UPSIDA informed that the unit is allotted plot no H-01, Pocket-'A', Moradabad SEZ.
- Shri Ankush Kaushal & Shri Sumit Garg, partners appeared before the Approval iv) committee to explain the project. Shri Sumit informed that he is already in handicrafts export business in SEZ. He further informed that the proposed SEZ unit is a partnership firm of Shri Sumit Garg and Shri Ankush Kaushal. They further informed that their estimated project cost of Rs. 59.00 Lakhs would be financed through partners own funds. They also informed that if additional funds are needed in future during implementation of their SEZ project then they will arrange for the same from their family members. The partners of the unit informed the Committee that they will be able to get a yield of approx. 185.00 Litres of Walnut Oil from 1000.00 Kg of Shelled Walnuts and a yield of approx. 400.00 Litres Almond Oil from 1000.00 kg of Shelled Almonds. Shri Sumit further informed that in last 03 years he has exported to the tune of Rs. 75.18 Crores from his SEZ units and does not have any Forex pending for realization.
- The Approval Committee, deliberated the proposal in detail and observed as under: v)
 - a. Fund flow to be provided as per format and subsequently forwarded to Shri Jayant Mishra, Pr. Commissioner, Income Tax (member of Approval Committee).
 - b. Check if it is on DEL list of DGFT & adverse list of DRI.
 - c. APEDA be approached for verifying the Walnut/ Almond Oil yield projections submitted by the unit.
- The Approval Committee, unanimously decided to defer the case and directed that the vi) case be placed again before Approval Committee only on receipt of full facts as observed above.

3 Review of deferred proposal for setting up of new unit in Moradabad SEZ

3.1 | Proposal of M/s East Elm:

- i) Approval Committee was informed that the proposal of M/s East Elm was again placed before Approval Committee in its meeting held on 27.05.2021 wherein the Approval Committee, deliberated the proposal and observed the following:
 - a) Unit must obtain time extension from developer i.e., UPSIDA for plot no H-26 allotted to them and submit the same to ADC, Moradabad SEZ.
 - b) Verification of DTA unit of Shri Shailendra Pal Singh namely M/s The Eastelm to be done by ADC, Moradabad SEZ.
 - c) Recent bank statements of all the individuals (Partners of unit and friends/family members who have agreed to provide unsecured loan to unit) be submitted by the unit.
 - d) An affidavit to the effect that what manufacturing processes to be done in SEZ premises and value addition in the final product by the processes involved.
 - e) Detailed manufacturing process flow charts for all the items proposed to be manufactured and exported (as per format already provided to unit through email).
- ii) It was informed to the Approval Committee that after due deliberations, Committee in its meeting held on 27.05.2021 unanimously decided to defer the case and directed that the case be placed again before Approval Committee with full facts after submission of requisite documents by the unit. Accordingly, ADC, Moradabad SEZ vide this office letter dated 01.06.2021, communicated the observations of Approval Committee.
- iii) Approval Committee was informed that ADC, Moradabad SEZ was taken to his DTA unit (M/s The Eastelm) premises by Shri Shailendra Pal Singh (Partner of M/s East Elm) on 02.06.2021 for verification purpose which was situated behind Mahi Lal Public School, Preet Vihar, Khushalpur road, Moradabad. On the gate of said premises there was no board or signage in the name of M/s The Eastelm, on being asked Shri Shailendra Pal Singh said that the signage is removed since the area is residential and commercial activities are not allowed here. It was observed that operations were going on at that time in the premises. There was raw material, semi-finished goods, finished products available as well as multiple machines were installed which are used in production of handicrafts/ metal products. Workers were engaged in different work, Smt. Renu Singh w/o Shri Shailendra Pal Singh (partner in M/s East Elm) was also present

in the office and looking after the work going on in the premises. <u>Further, response of unit including all the information/ documents sought vide this office letter dated 01.06.2021 is still awaited.</u>

- iv) Shri Sanjeev Kumar Bedi, Area Manager, UPSIDA informed the Approval Committee that the unit has not sought time extension from the developer yet and they have pending dues of approximately Rs. 1.10 Lakhs payable on the plot.
- v) Shri Shailendra Pal Singh, Partner appeared before the Approval Committee in its meeting held on 10.06.2021. He stated that he will submit all the information/ documents sought vide letter dated 01.06.2021 including time extension from developer in the meantime. Shri Shailendra also informed that since his DTA unit is in residential area, he is seeking LOA so that he can shift to industrial area SEZ.
- vi) The Approval Committee, deliberated the proposal and showed its displeasure on the fact that unit has not submitted requisite documents even after being directed by the Committee to submit the same multiple times. Further, Approval Committee observed as under:
 - a) Unit must obtain time extension from developer i.e., UPSIDA for plot no H-26 allotted to them and submit the same to ADC, Moradabad SEZ.
 - b) Recent bank statements of all the individuals (Partners of unit and friends/family members who have agreed to provide unsecured loan to unit) be submitted by the unit.
 - c) Unit must submit Financial fund flow as per format.
 - d) Detailed manufacturing process flow charts for all the items proposed to be manufactured and exported (as per format already provided to unit through email). Value addition would be mentioned and attested by unit.
- vii) The Approval Committee, unanimously decided to defer the case and directed that the case be placed again before Approval Committee with full facts only after submission of requisite documents by the unit.

3.2 | Proposal of M/s Adprint Product Ind. :-

i) Approval Committee was informed that the proposal of M/s Adprint Product Ind. was again placed before Approval Committee in its meeting held on 12.03.2021 wherein the

Approval Committee, deliberated the proposal and observed the following:

- a) The unit must submit NOC from UPSIDA with respect to the plot related issues reported by Regional Manager, UPSIDA.
- b) Recent bank statements of all individuals (Partners of unit and friends/family members who have agreed to provide unsecured loan to unit) be submitted by the unit.
- c) Detailed manufacturing process flow charts for all the items proposed to be manufactured and exported (as per format shared through email).
- d) Revised Form-F as per revised Project report submitted.
- ii) It was informed to the Approval Committee that after due deliberations, Committee in its meeting held on 12.03.2021 unanimously decided to defer the case and directed that the case be placed again before Approval Committee with full facts after submission of requisite documents by the unit. Accordingly, ADC, Moradabad SEZ vide this office letter dated 26.03.2021, communicated the observations of Approval Committee.
- iii) Approval Committee was informed that recently the unit vide its email dated 02.06.2021 submitted response w.r.t. above observations of Approval Committee. On scrutiny it was found that the response dated 02.06.2021 received from the unit does not include all the information/documents sought vide this office letter dated 26.03.2021. It was further informed that this office vide email dated 08.06.2021 asked the unit to submit the following information which is still awaited from the unit:
 - a. Unit has submitted a letter dated 27.10.2020 issued by UPSIDA which is for reconstitution of plot i.e. change from proprietorship to partnership and hence is not relevant to the observation of UAC. Unit must submit NOC from UPSIDA regarding issues with building plan/ amalgamation of plots raised by RM, UPSIDA in UAC dated 12.03.2021.
 - b. Unit has submitted an Affidavit to the effect that Shri Muti-ur-Rehman has a property in Lajpat Nagar, Moradabad measuring 16.71 sq. metres which he will sell to fund the project which is claimed to be valued at Rs. 80.00 Lakhs. It may be mentioned here that in the project report unit has mentioned Unsecured loans from Family members amounting to Rs. 18.60 Lakhs for which unit must submit recent bank statements for all those individuals willing to provide unsecured loans to fund their project.

- c. Unit has submitted revised flow charts but none of them have any ITC(HS) code for capital goods/ machines. Also it is observed that in most cases, the ITC(HS) code for Raw material and final product is same. Unit is therefore again requested to please provide revised/ correct Manufacturing flow charts for all items (as per format shared by email).
- iv) Shri Sanjeev Kumar Bedi, Area Manager, UPSIDA informed the Approval Committee that the unit has not applied for amalgamation of plots with the developer yet and they have pending dues of approximately Rs. 46,000.00 payable on the plot.
- v) Shri Kishor Kumar Singh, partner appeared before the Approval Committee in its meeting held on 10.06.2021. He stated that their plots were allotted more than a decade ago and they were not asked for amalgamation by the developer then. Shri Bedi, Area Manager, UPSIDA informed Shri Kishor that he has recently joined Moradabad SEZ site office and is unaware why the unit was not asked for amalgamation of plots earlier. Shri Bedi further informed that as of current policy of the developer Shri Kishor needs to gets the plots amalgamated.
- vi) The Approval Committee, deliberated the proposal and showed its displeasure on the fact that unit has not submitted requisite documents even after being directed by the Committee to submit the same multiple times. Further, Approval Committee observed as under:
 - e) Unit must submit NOC from UPSIDA regarding issues with amalgamation of plots raised by the developer and submit the same to ADC, Moradabad SEZ.
 - f) Unit must submit Financial fund flow as per format. Unit must also submit recent bank statements of all the individuals (friends/family members who have agreed to provide unsecured loan of Rs. 18.60 Lakhs to unit).
 - g) It is observed that flow charts submitted by the unit does not have any ITC(HS) code for capital goods/ machines and in most cases the ITC(HS) code for Raw material and final product is same. Unit must therefore submit revised/ correct Manufacturing flow charts for all items (as per format shared by email).
- vii) The Approval Committee, unanimously decided to defer the case and directed that the case be placed again before Approval Committee with full facts only after submission of requisite documents by the unit.

3.3 Proposal of M/s Green Overseas :-

- i) Approval Committee was informed that the proposal of M/s Green Overseas was placed before Approval Committee in its meeting held on 12.03.2021 wherein the Approval Committee, after due deliberations, unanimously decided to defer the case and directed that the unit must submit the following documents at the earliest so that the case be placed again before Approval Committee with full facts:
 - a) Proposed country of import of raw material and country for export of finished products.
 - b) Correct ITC(HS) codes for the items of export (Mouth Freshner, Flavored supari and Walnut Giri) and ITC(HS) codes for all the raw materials needed for manufacturing process.
 - c) Detailed manufacturing process flow charts for all the items proposed to be manufactured and exported.
 - d) Unit must complete all the formalities and obtain all due approvals from concerned departments/ authorities so as to prove their claim that Shri Zubair Siddiqui is a partner in M/s Dollar Industries situated in Moradabad SEZ.
 - e) Revised Form-1 with annexure from Registrar of Firms w.r.t. the revised Partnership deed.
 - f) Supporting documents for sources of funding as claimed by partners of the firm.
 - g) Proper layout plan of the proposed unit.
- ii) Accordingly, ADC, Moradabad SEZ vide this office letter dated 26.03.2021, communicated the observations of Approval Committee meeting dated 12.03.2021.
- iii) Approval Committee was informed that recently the unit vide its email dated 02.06.2021 and 09.06.2021 submitted response w.r.t. above observations of Approval Committee. On scrutiny it was found that the response dated 02.06.2021 received from the unit does not include all the information/ documents sought vide this office letter dated 26.03.2021.
- iv) Shri Sanjeev Kumar Bedi, Area Manager, UPSIDA informed the Approval Committee that the unit has pending dues of approximately Rs. 1.21 Lakhs payable on the plot.
- v) Shri Zubair Siddiqui, partner appeared before the Approval Committee in its meeting held on 10.06.2021. He stated that he is unable to find exact ITC(HS) codes for export products but he will surely do more research and submit correct ITC(HS) codes. When asked about funding of project he stated that he will use his own capital to fund the project for which he will dissolve

some of his capital investment in his two firms namely M/s Dollar Industries, a SEZ unit and M/s Maars Impex. It was also observed by the committee that since M/s Maars Impex is already out of business and M/s Dollar Industries has an outstanding Forex realization of approximately Rs. 31.44 Crores, so Shri Zubair will not be able to dissolve any of his capital investment in any of the two firms for funding of M/s Green Overseas as claimed by him earlier.

- vi) The Approval Committee, deliberated the proposal and observed as under:
 - a) Unit must submit NOC from UPSIDA w.r.t. dues on the plot and submit the same to ADC, Moradabad SEZ.
 - b) Unit must submit correct ITC(HS) codes for the items of export (Mouth Freshener, Flavoured supari and walnut Giri).
 - c) Detailed manufacturing process flow charts for all the items proposed to be manufactured and exported (as per format shared by email) attested by unit.
 - d) Unit must complete all due compliances w.r.t. M/s Dollar Industries situated in Moradabad SEZ and obtain approvals from Moradabad SEZ office, UPSIDA and Registrar of firms.
 - e) Unit must submit financial fund flow as per attachment and supporting documents for sources of funding as claimed by partners of the firm.
- vii) The Approval Committee, unanimously decided to defer the case and directed that the case be placed again before Approval Committee with full facts only after submission of requisite documents by the unit.

4 Monitoring of performance for following units

4.1 M/s Global Export House :-

- It was informed to the Approval Committee that M/s Global Export House was granted LOA dated 19.09.2014. The unit commenced commercial production w.e.f. 20.01.2016 and completed their 1st block five years term on 19.01.2021. The unit has made exports to the tune of Rs. 235.52 Lakhs (2015-16 to 2019-20) and total Foreign Exchange Outgo is 127.18 Lakhs. The net Foreign Exchange Earnings by the unit stand at Rs. 108.14 Lakhs. The Foreign Exchange pending on the unit for realization beyond stipulated period of nine months is Rs. 86.31 Lakhs as on 01.06.2021.
- ii) Shri Sanjeev Kumar Bedi, Area Manager, UPSIDA informed the committee that the unit

has Rs. 24,417.00 pending dues of the developer which they must clear immediately.

- iii) Shri Mohan Lal Maheshwari, CEO appeared before Approval Committee in its meeting held on 10.06.2021. He informed the committee that they are in the business of manufacturing and export of Handicrafts made of Sandalwood and Attars. Their business last year was good and they have exported to the tune of Rs. 3,18,88,454.00 in 2020-21. He also informed that he will clear dues of UPSIDA when he received a letter or bill from developer. Shri Maheshwari further informed that w.r.t. the Forex realization, they have already realized 5 Shipping Bills and current outstanding stands at Rs. 41.00 Lakhs which is expected to be realized by July 2021. He stated that he has submitted Bank certified report for the above mentioned 5 SBs which have been realized since there is delay from AD Bank in uploading of e-BRC due to COVID. Shri Maheshwari further requested to renew his LOA which has expired on 31.05.2021.
- iv) The Approval Committee noted that the unit has achieved positive NFE. The committee, after due deliberations, satisfactorily monitored the performance of the unit and extended the LOA of the unit for 01 year i.e. up to 31.05.2022, subject to clearance of outstanding UPSIDA dues. The Approval Committee directed that the case of unit for monitoring of pending Forex be again put-up before it in Aug 2021 meeting.

5 Change in partnership of firm and incorporation of the same in their Letter of Approval

5.1 M/s Guildart Unit-II:-

- i) It was informed to the Approval Committee that M/s Guildart Unit-II was granted LOA No. NSEZ/4-169/2003-MBD/443 dated 05.07.2005 for manufacturing and export of Handicrafts made of Brass, Iron, Aluminium, Copper, EPNS, Glass, Wood, Fabric, Partly Leather and Combination of these articles and other Indian handicrafts the unit commenced in production on 19.05.2009. The unit has made exports to tune of Rs. 2389.10 Lakhs (01.04.2019 to 30.04.2021) and the total Foreign Exchange Outgo is Rs.100.16 Lakhs. The net Foreign Exchange Earnings by the unit stand at Rs. 2288.94 Lakhs and Foreign Exchange pending for realization beyond stipulated period of nine months is 1.41 lakhs as on 01.06.2021.
- ii) The Committee was further informed that the unit vide their letter dated 30.04.2021 received in this office on 17.05.2021 has requested this office for approval of change in partnership of firm and incorporation of the said change in their Letter of Approval. The unit has intimated that two partners viz. Mr. Vishal Arora & Smt. Santosh Arora holding a total of 70%

shares got retired from the unit. Now, Mr. Vikas Arora has 40% shares and two new partners i.e. Smt. Lata Arora holding 30% shares and Mr. Sidhharth Arora holding 30% shares got entered in the unit vide partnership deed dated 01.04.2021. M/s Guildart Unit-II has submitted registered partnership deed with registrar office, copy of PAN, Aadhar of both new partners are received. The ITRs for last 03 years for new partners (except for ITR of Smt. Lata Arora for F.Y. 2019-20) are also received.

- iii) Shri Sanjeev Kumar Bedi, Area Manager, UPSIDA informed the committee that the unit has Rs. 1.66 Lakhs pending dues of the developer which they must clear immediately.
- iv) The Approval Committee, after due deliberations, decided to approve the proposal of M/s Guildart Unit-II for change in partnership of the firm. The Committee further directed the unit to obtain necessary approval from UPSIDA regarding change in partnership and must clear pending dues of developer i.e. UPSIDA immediately. Details of shareholding of the unit before and after change are as under:

4 Inclusion of additional manufacturing activities as authorised operations in LOA

4.1 | Sainik Lifestyle Pvt. Ltd. :-

- i) Approval Committee was informed that Sainik Lifestyle Pvt. Ltd. was granted LOA No. NSEZ/4-394/2003-MBD/9656 dated 16.06.2016 for manufacturing and export of handicrafts items. The unit commenced its production on 12.02.2020. The unit has made exports to the tune of Rs. 948.50 Lakhs in their last two years of operation (i.e. from 12.02.2020 up to 28.02.2021) and the Forex outgo of unit stands at Rs. 74.39 Lakhs. The NFE achieved by unit for the period is to the tune of Rs. 874.11 Lakhs. The LOA of the unit is valid up to 11.02.2025.
- ii) It was informed that Sainik Lifestyle Pvt. Ltd. vide their letter received on 19.05.2021 requested for inclusion of additional manufacturing items as authorized in LOA. In this regard, the unit has submitted all the requisite documents with their application. The final list submitted by the unit containing a total of 45 ITC(HS) codes was verified with Export/ Import Policy in

effect and it was found that no restricted/ prohibited items are included in the list. All the items mentioned in the list fall in approved list of Handicraft items as approved by EPCH.

- iii) Shri Sanjeev Kumar Bedi, Area Manager, UPSIDA informed the committee that the unit has Rs. 5.02 Lakhs pending dues of the developer which they must clear immediately.
- iv) Shri Saurabh Mangla, director appeared before approval committee to explain his proposal. He informed the committee that their business is good and they expect to perform beyond their targets for 2021-22. It was informed to Shri Mangla that the ITC(HS) codes viz. 94038900, 44219060, 69120040, 42050350 & 94119429 in their list of approved ITC(HS) codes are either wrong or does not exist which needs to be revised by the unit. Also the description of ITC(HS) codes viz. 70134100 & 70134900 in their proposed list of ITC(HS) codes is not complete. Shri Mangla informed the committee that he will submit the revised list of ITC(HS) codes to this office.
- v) The Approval Committee, after due deliberations, decided to approve the proposal of Sainik Lifestyle Pvt. Ltd. for inclusion of additional manufacturing items as authorized in LOA subject to (i) submission of correct/ revised ITC(HS) codes and their description, (ii) approval from UPSIDA regarding broad-banding and (iii) clearance of pending dues of developer i.e. UPSIDA.
