Minutes of meeting of the Approval Committee of Moradabad SEZ held under the Chairmanship of Shri A Bipin Menon, Development Commissioner (DC), Noida SEZ at 11:00 AM on 27/07/2022 through video conferencing.

**B.** Besides, during the meeting S/Shri (i) Pramod Kumar, Assistant Development Commissioner (in-charge), MSEZ (ii) Lal Babu Prasad, Supdt. (in-charge), MSEZ and (iii) Arun Singh Parihar, Stenographer, Project Section, NSEZ were also present to assist the Approval Committee. It was informed that the stipulated quorum for holding the meeting is available and meeting can proceed.

C. At the outset, the Chairman welcomed the participants. After brief introduction, items included in the agenda were taken up for deliberation one by one. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, the following decisions were unanimously taken:-

D. Item wise decisions on proposals included in agenda:

## 01. Ratification of Minutes of last meeting of the Approval Committee held on 07/02/2022.

It was informed that no reference against the decisions of the Approval Committee meeting held on 07/02/2022 has been received. The Approval Committee took note of the same and accordingly, Minutes of the meeting held on 07/02/2022 were unanimously ratified by the Approval Committee.

It was informed by Shri Lal Babu Prasad, Superintendent (customs), Moradabad SEZ that the SEZ units are reluctant in filing of transactions on SEZ Online system due to transaction charges of NSDL. Moreover, these are cases where no incentives are being claimed.
- 3. The Committee directed that the correctness of data may be confirmed through NSDL and necessary directions be issued to all SEZ units to adhere to the Rule 78 of SEZ Rules 2006 and file all transactions on SEZ Online system without fail for import/export/DTA Procurement/DTA Sale of all goods. The Committee further directed that Customs officials shall ensure that no goods (capital goods or raw materials) shall enter or leave SEZ without proper filing/processing of transaction on SEZ Online system.
