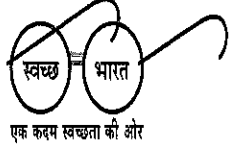

**Minutes of meeting of the Approval Committee of Noida SEZ held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner (DC), Noida SEZ at 11:00 AM on 25/02/2021 through video conferencing.**

The following members of the Approval Committee were present through video conferencing during the meeting:-

- 1) Shri Nitin Gupta, Dy. Development Commissioner, NSEZ (Nominee of Deptt. of Commerce in terms of letter dated 23/09/2008).
- 2) Shri Ashok Kumar, Superintendent, Customs, Noida Commissionerate.
- 3) Shri Rakesh Kumar, FTDO, O/o Addl. DGFT, CLA, New Delhi.
- 4) Shri Manish Kumar, Income Tax Officer, Income Tax Deptt., Noida.
- 5) Shri Mukesh Goyal, Manager, New Okhla Industrial Development Authority, Noida.
- 6) Shri Garima Mishra, DIC, Noida (Rep. of Principal Secretary, Industry, Govt. of UP.).

2. Besides, during the meeting S/Shri (i) Amit Kumar Gupta, Specified Officer, NSEZ, (ii) Pramod Kumar, Asstt. Development Commissioner, NSEZ, (iii) Arun Singh Parihar, Stenographer, Project Section, NSEZ, (iv) Praveen Kumar, RO, UPPCB, Noida, (v) S.K. Bharti, JE, UPPCL, Noida were also present to assist the Approval Committee. It was informed that the stipulated quorum for holding the meeting is available and meeting can proceed.

3. At the outset, the Chairman welcomed the participants. After brief introduction, items included in the agenda were taken up for deliberation one by one. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, the following decisions were unanimously taken:-

**(i) Ratification of Minutes of last meeting of the Approval Committee held on 04/02/2021.**

It was informed that M/s. Onnsynex Ventures Pvt. Ltd. vide its letter dated 12/02/2021 has stated that the Approval Committee held on 04/02/2021 was of the view that warehousing of liquor could be considered provided it was for exports or sales to duty free shops and accordingly, the Approval Committee, decided to forward the request of unit for consideration of inclusion of liquor in its LOA to the Board of Approval. The unit has requested to add supply of liquor to the bonded warehouse as well while forwarding the proposal to BOA



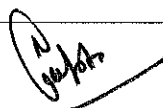

for consideration. The Approval Committee decided that supply of liquor to bonded warehouse may also be added in the proposal while forwarding the request to BOA. It was informed that no other reference against the decisions of the Approval Committee held on 04/02/2021 was received. The Approval Committee took note of the same and accordingly, Minutes of the meeting held on 04/02/2021 were unanimously ratified by the Approval Committee with the aforementioned modification.

**(ii) Item wise decisions on proposals included in agenda:**

1.	<p><b>Enphase Solar Energy Private Limited – Setting up a new unit in NSEZ.</b></p> <p>1.1 It was informed that M/s. Enphase Solar Energy Pvt. Ltd. has submitted a proposal for setting up a unit in NSEZ for “Solar Energy Engineering Services” with projected exports of Rs. 41412 Lakhs and NFE earnings worth Rs.41305 Lakhs and proposed investment of Rs. 315.00 Lakhs in indigenous plant &amp; machinery/capital goods and employment of 754 persons, over a period of five years.</p> <p>1.2 It was further informed that the said proposal was also considered in the last meeting held on 04/02/2021 wherein it was observed that along with setting up a new unit in NSEZ, applicant had also proposed to take over the solar engineering business division of M/s. DIN Engineering Services LLP along with some SDFs allotted to them. It was also observed that the premises already in possession of DIN LLP and the premises allotted to the unit but yet to be taken over by the unit were made part of Business Transfer Agreement (BTA) dated 01/02/2021 which is not correct as the SDFs are the assets of the NSEZ Authority. Further, the BTA was also not signed by all the partners/directors of both parties. Accordingly, the proposal was deferred with a direction to the applicant to submit revised proposal without mentioning the property and along with duly signed Business Transfer Agreement for consideration.</p> <p>1.3 It was further informed that in compliance with the decision of Approval Committee, the applicant vide its letter dated 15/02/2021 has submitted</p>

revised BTA dated 09/02/2021 stating that they have acquired the business of solar engineering service from DIN Engineering LLP. Consequently they intend to set-up a new SEZ unit at Noida SEZ on the basis of the available space in NSEZ. Applicant has also undertaken that they will apply for the allotment of space in accordance with extant rules/ procedures of NSEZ for set-up of unit.

1.4 Shri S. Thamaran, Director of M/s. Enphase Solar Energy Pvt. Ltd., Shri Ravi Joshi & Shri Rajaram, representative of Enphase Solar Energy Pvt. Ltd. and Shri Anuj Gupta, partner of DIN Engineering Services LLP appeared before the Approval Committee through video conferencing. Shri Thamaran informed that they will take over the business of Solar Energy Engineering Services from DIN and post take over will provide Solar Design Services, specifically Solar PV Installation Design & Drawing Services to the customers of Enphase Inc. who are primarily located in United States, Australia etc. He further mentioned that their proposed authorized operations will fall under CPC Code 8672 (Engineering Services).

1.5 Shri Thamaran further informed that Enphase Solar Energy Private Limited in India is a fully owned subsidiary and 100% Foreign holding company of M/s. Enphase Energy Inc., USA. The India group provides business support service and software and hardware engineering services to its parent company.

1.6 The Approval Committee, after due deliberations, approved the proposal of M/s. Enphase Solar Energy Pvt. Ltd. for setting up a unit in NSEZ for "Solar Energy Engineering Services".

**2. DIN Engineering Services LLP – Application for transfer of Solar Energy Engineering Business Division located at Noida SEZ to Enphase Solar Energy Private Limited.**

2.1 It was informed that M/s. DIN Engineering Services LLP has submitted a proposal for transfer of its Solar Energy business division to M/s. Enphase

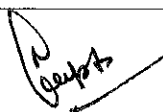
Solar Energy Pvt. Ltd. under revised Business Transfer Agreement dated 09 February 2021.

2.2 It was further informed that the said proposal was also considered in the last meeting held on 04/02/2021 wherein it was observed that the premises already in possession of DIN LLP and the premises allotted to the unit but yet to be taken over by the unit were made part of Business Transfer Agreement (BTA) dated 01/02/2021 which is not correct as the SDFs are the assets of the NSEZ Authority. Further, the BTA was also not signed by all the partners/directors of both parties. Accordingly, the proposal was deferred with a direction to the applicant to submit revised proposal without mentioning the property and along with duly signed Business Transfer Agreement for consideration.

2.3 It was also informed that in compliance with the decision of Approval Committee in compliance with the said decision of the UAC, vide its letter dated 15/02/2021 has submitted revised BTA dated 09/02/2021 stating that only the business of solar energy will be transferred to Enphase Solar Energy Private Limited and they would continue the remaining business under the present LOA.

2.4 Shri Anuj Gupta, partner of DIN Engineering Services LLP, Shri S. Thamaran, director of M/s. Enphase Solar Enrgy Pvt. Ltd. and Shri Ravi Joshi and Shri Rajaram, representatives, appeared before the Approval Committee through video conferencing. Shri Gupta informed that DIN LLP would transfer the solar energy engineering services business as per BTA to Enphase India on going concern basis and continue the remaining business under present approved LOA. He further stated that post the approval, they intend to surrender the premises pertaining to solar engineering business division by following necessary extant rules/ procedures of Noida SEZ.

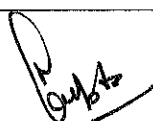
2.5 The Approval Committee, after due deliberations, unanimously decided to approve the proposal of M/s. DIN Engineering Services LLP for transfer of "IT/IT Enabled services for solar energy" to M/s. Enphase Solar Energy Pvt.

Knoldus Software LLP.</b></p> <p>3.1 It was informed to the Approval Committee that M/s. Braahmam Net Solution Pvt. Ltd. has submitted a proposal dated 05/11/2019 for exit from SEZ scheme and transfer of it's assets &amp; liabilities at SDF No. L-7(A), NSEZ in favour of M/s. Knoldus Software LLP (transferee).</p> <p>3.2 It was also informed that M/s. Braahmam Net Solution Pvt. Ltd. had earlier applied for exit from SEZ scheme and accordingly vide this office letter dated 28/03/2018, they were requested to complete exit formalities. Exit compliance are awaited from the unit. Now, unit has applied for exit as well as transfer of its assets &amp; liabilities to M/s. Knoldus Software LLP in terms of Rule 74A of SEZ Rules, 2006.</p> <p>3.3 Shri Pradeep Kumar Satpathy, CFO of M/s. Braahmam Net Solutions Pvt. Ltd. and Shri Bhavya, representative of M/s. Knoldus Software LLP appeared before the Approval Committee through video conferencing. Shri Satpathy informed that due to less business orders they have decided to exit from SEZ scheme.</p> <p>3.4 Shri Bhavya informed that they are engaged in IT/ITES business and due to increasing business they are looking more space in NSEZ.</p> <p>3.5 The Approval Committee was informed that Rule 74A of the SEZ Rules, 2006 inter alia provides as under:-</p> <p>“The unit may opt out of Special Economic Zone by transferring its assets and liabilities to another person by way of transfer of ownership including sale of Special Economic Zone units inter alia subject to the following conditions:-</p> <p>(i) The unit has held a valid Letter of Approval as well as lease</p>

(ii) The unit has been operational for a minimum period of two years after the commencement of production as on the date of transfer.

(iii) Such sale or transfer transactions shall be subject to the approval of the Approval Committee;

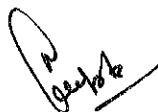
(iv) The transferee fulfils all eligibility criteria applicable to a unit; and

(v) The applicable duties and liabilities, if any, as calculated under Rule 74, as well as export obligations of the transferor Unit, if any, shall stand transferred to the transferee Unit which shall be under obligation to discharge the same on the same terms and conditions as the transferor Unit.”

3.6 The Approval Committee observed that exports worth Rs. 5.36 Lakhs has been shown pending for realization as on 31/03/2020. Shri Satpathy informed that they are trying hard to realize the said amount and assured to provide the updated status of the said pending forex within 6 months.

3.7 The Approval Committee observed that the transferor unit has held a valid LOA and lease deed is valid upto 30/11/2025 and has been in operation for more than two years. The Approval Committee also observed that transferee unit has also valid LOA and has given an undertaking on Rs.100/- non-judicial stamp paper to take over all the assets & liabilities of transferor unit. Thus, the Approval Committee observed that the proposal meets all the conditions of Rule 74A.

3.8 The Approval Committee, after due deliberations, decided to approve in-principle the proposal of M/s. Braahmam Net Solutions Pvt. Ltd. for exit from SEZ scheme and transfer of assets & liabilities at SDF No. L-7(A), NSEZ to M/s. Knoldus Software LLP in terms of Rule 74A of SEZ Rules, 2006 and directed the unit to submit updated status of pending forex of Rs. 5.36 Lakhs. The Approval Committee also decided to cancel the previous in-principle exit approval dated 28/03/2018. The Approval Committee further

directed M/s. Knoldus Software LLP to submit the description of the authorized operations they are carrying out as per Rule 76 of SEZ Rules, 2006 along with their CPC Code.

4. **H & S Industries – Exit & Transfer of assets & liabilities including building at Plot No.151, NSEZ under Rule 74A to M/s. Ritzy Hardware Pvt. Ltd.**

4.1 It was informed to the Approval Committee that M/s. H & S Industries (transferor) has submitted a proposal dated 23/11/2020 for exit from SEZ scheme and transfer of it's assets & liabilities including building at Plot No. 151, NSEZ in favour of M/s. Ritzy Hardware Pvt. Ltd. (transferee).

4.2 Shri Satinder Singh, Partner, in H& S Industries and Shri Harshvardhen Sharma, director of Ritzy Hardware Pvt. Ltd. appeared before the Approval Committee through video conferencing. Shri Singh informed that due to Covid pandemic their business was badly hit and now they could not manage the business. Hence, they have decided to exit from SEZ scheme.

4.3 The Approval Committee was informed that Rule 74A of the SEZ Rules, 2006 inter alia provides as under:-

“The unit may opt out of Special Economic Zone by transferring its assets and liabilities to another person by way of transfer of ownership including sale of Special Economic Zone units inter alia subject to the following conditions:-

(i) The unit has held a valid Letter of Approval as well as lease of land or SDF for not less than a period of five years on the date of transfer.

(ii) The unit has been operational for a minimum period of two years after the commencement of production as on the date of transfer.

(iii) Such sale or transfer transactions shall be subject to the approval of the Approval Committee;

(iv) The transferee fulfils all eligibility criteria applicable to a unit; and

(v) The applicable duties and liabilities, if any, as calculated under Rule 74, as well as export obligations of the transferor Unit, if any, shall stand transferred to the transferee Unit which shall be under obligation to discharge the same on the same terms and conditions as the transferor Unit.”

4.4 The Approval Committee observed that LOA of M/s. Ritzy Hardware Pvt. Ltd. was valid till 18/12/2020. The unit has submitted application for extension of validity of LOA for which they have been granted personal hearing by Development Commissioner on 25/02/2021. The Approval Committee decided to hear the promoter of Ritzy Hardware Pvt. Ltd. in the meeting itself.

4.5 Shri Harshvardhen Sharma informed that they could not find suitable space in NSEZ and soon after getting the LOA, lockdown was imposed due to sudden outbreak of COVID-19 pandemic, hence, all the work was halted and they could not implement the project as desired. In between, their LOA also expired. Shri Sharma further stated that they have good orders from Customers in Germany, UK and USA. He also stated that there is big boom in construction business in USA and they have done sample development for some of their customers in USA. He requested to extend their LOA and also approve transfer of assets & liabilities of M/s. H & S Industries so that they can implement the project at the earliest.

4.6 The Approval Committee observed that M/s. H & S Industries has not submitted APR for the year 2019-20 till date. Further, lease rent amounting to Rs. 2,08,913/- is also outstanding against the unit.

4.7 The Approval Committee observed that the transferor unit has held a valid LOA and lease deed is valid upto 24/07/2024 and has been in operation for more than two years. The Approval Committee also observed that transferee unit has given an undertaking on Rs.100/- non-judicial stamp paper to take over all the assets & liabilities of transferor unit.

4.8 The Approval Committee, after due deliberations, took following decisions:

- (i) The validity of LOA of M/s. Ritzy Hardware Pvt. Ltd. shall be extended for one year i.e. upto 18/12/2021 subject to submission of copy of orders received from overseas customer and sample development plan.
- (ii) M/s. H & S Industries shall submit APR for the year 2019-20 and clear entire outstanding lease rent within a week.
- (iii) The Approval Committee also approved in-principle the proposal of M/s. H & S Industries for exit from SEZ scheme and transfer of assets & liabilities including building at Plot No. 151, NSEZ to M/s. Ritzy Hardware Pvt. Ltd. in terms of Rule 74A of SEZ Rules, 2006 subject to receipt of above documents from H & S Industries and issuance of LOA extension to M/s. Ritzy Hardware Pvt. Ltd.

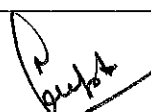
5. **Royalux Export – Amendment in Authorized operations and updation of ITC(HS) Code.**

5.1 It was informed to the Approval Committee that M/s. Royalux Export has been issued an LOA No. 02/04/2018-Proj/13853 dated 14/12/2018 for Manufacturing of LED Lighting. The unit commenced its export production w.e.f. 09/04/2019 and its LOA is valid till 08/04/2024.

5.2 It was further informed that unit vide its letter dated 27/01/2021 has requested to update ITC HS codes of their authorized operations of their items of manufacturing according to their LOA issued as under:

5.3 It was further informed that “*Fixture and parts thereof*” as given in the aforesaid table have not been mentioned in LOA. Further, ITC(HS) Chapter 8531 is against “Electric Sound or Visual Signalling Apparatus (For Example,

Bells, Sirens, Indicator Panels, (1) (2) (3) (4) (5) Section-xvi 793 Chapter-85 Burglar or Fire Alarms), Other Than Those Of Heading 8512 or 8530". Hence, the same does not appear to be directly related to the authorized operations allowed to the unit.

5.4 Shri Amit Gupta, authorized representative of the unit appeared before the Approval Committee through video conferencing. Shri Gupta informed that they are into manufacturing of LED Lights for Industries and Home. He further stated that they are also manufacturing LED lighting for other businesses and accordingly want to include the above ITC(HS) Codes in their LOA.

5.5 On specific query against ITC(HS) 8531, Shri Gupta informed that they are not engaged in any electric sound apparatus or in LCD. They will manufacture visual signalling apparatus i.e. indicator panel incorporating LED only.

5.6 The Approval Committee, after due deliberations, approved the proposal of M/s. Royalux Export for amendment in authorized operations and inclusion of ITC(HS) Codes as proposed by the unit.

**6. Proposals related to updation of ITC HS Codes of the authorized operations allowed under LOA of different units.**

6.1 It was informed that as per amendment of SEZ Rules, 2006 as published in Gazette Notification dated 19/09/2018, Rule 19(2) of the SEZ Rules, 2006 have been amended as under:

*"The Letter of Approval shall specify the items of manufacture [along with the corresponding Indian Trade Classification (Harmonised System) of Export and Import Items, 2017] or particulars of service activity, including trading or warehousing, projected annual export and Net Foreign Exchange Earning for the first five years of operations, limitations, if any on Domestic Tariff Area sale of finished goods, by-products and rejects and other terms and conditions, if any, stipulated by the Board or Approval*
