# Minutes of UAC meeting of Quarkcity India Pvt. Ltd., SEZ held on 01.02.2023 Noida Special Economic Zone

Since the quorum was available, the meeting proceeded sequentially as per the agenda. At the outset, the Chairman welcomed the participants. After detailed deliberations amongst Members as well as interaction with the applicants/representatives of the Units/Developers, the following decisions were taken: -

### Agenda Item No. 1: -

Sub: Ratification of the Minutes of the Meeting of the Unit Approval Committee held on 22.12.2022.

1.1 The Committee was informed that no reference against the decisions of the UAC held on 22.12.2022 was received from any of the Members of the Committee or Trade and therefore, Minutes of the Meeting held on 22.12.2022 were ratified.

### Agenda Item No 2: -

2.1 Sub: Addition of input service other than the services Specified under Notification F. No. D.12/19/2013-SEZ dated 2nd January 2018 of DOC:-

**2.1.1** It was informed to the Approval Committee that M/s Sunny View Estates Pvt. Ltd. (Co-Developer) of M/s Quarkcity India Pvt. Ltd. Vide its letter dated 29th November, 2022 applied for approval of following input services: -

- **2.1.2** The UAC in its meeting held on 22.12.2022 approved addition of only the "Property management services (SAC code 997221)" as input service to the co-developer.
- **2.1.3** M/s Sunny View Estates Pvt. Ltd. (Co-Developer) vide its letter dated 24.01.2023 has now submitted that their authorized operations are leasing out their SEZ premises to different SEZ units and the company would also be procuring services of real estate agents which assist them in leasing out their property in SEZ to different SEZ units. Therefore, these services are very much required for their authorized operations.
- **2.1.4** It was informed that services are categorized under "Real estate services on a fee/commission basis or contract basis" with SAC code 99722 subcategorized in SAC 997222 in Goods and Services tax ('GST') regime. SAC 997222 includes "real estate agency and brokerage services related to buildings, and similar intermediation services involving buying, selling and renting of buildings and associated land, on a fee or contract basis".
- **2.1.5** Mr. Jatinder Singh, Authorized representative of the Co- Developer appeared before the Approval Committee and explained the proposal. On being asked he informed that the this service pertain to companies providing service by finding Units who are interesting in taking up space in the SEZ.
- **2.1.8** The Approval Committee after due deliberations approved the addition of "Building sales on a fee/commission basis or contract basis (SAC Code 997222)" as an input service to the co-developer.

- **3.1.2** From the Developer, Mr. Sanjeev Kumar appeared before the Approval Committee and explained their proposal.
- **3.1.3** After detailed examination, the Approval Committee unanimously approved the proposal of M/s Quarkcity India Pvt. Ltd. (Developer) **except Ambulance and Tractor (not trolley)** mentioned under the authorized operation "Construction of all types of building in processing area as approved by the Approval Committee". The goods proposed will be used for authorized operations of the Developer within the SEZ only, failing which the Developer has to be pay back the benefit of duties and taxes availed on these items, as applicable. The Developer will re-submit the list of material for authorized



operations by expanding on the abbreviations used therein.
