Minutes of 7th meeting (2010 Series) of Unit Approval Committee for Joint Monitoring of EOUs held under the Chairmanship of Shri. S.C. Panda, Development Commissioner, NSEZ, Noida on 28.10.2010 at 11.30 AM at NSEZ, Noida.

7th meeting (2010 Series) of Unit Approval Committee for Joint Monitoring of EOUs (UAC) was held on 28.10.2010 under the Chairmanship of Shri S.C. Panda, Development Commissioner, Noida SEZ. List of participants is enclosed at Annexure I. The Chairman welcomed all participants of the UAC and thereafter agenda was taken up for discussion.

7.7 Joint monitoring of EOUs in terms of Appendix 14-I-G of HBP, as per the list of units (EOUs falling under jurisdiction of C.Ex. Commissionerate, Rohtak, Haryana)

The Committee deferred the Joint Monitoring of EOUs under C.Ex. Commissionerate, Rohtak on the request of the Commissioner of C.Ex. as there is monthly revenue meeting of all Commissioners of C.Ex. and other senior officers in Rohtak. Committee, however, requested the Asst. Commissioner of C.Ex., present during the meeting, that they may reconcile the figures of the units in respect of export-import, DTA Sale, etc. for next Joint Monitoring.

The Committee has noted that there are 24 EOUs under jurisdiction of Rohtak but only two representative of the unit has come for Joint Monitoring. The Committee took a strong view on the unit's representations for such meeting which not only evolve mechanism for monitoring their performance but also addresses any issue relating to the unit in the interest of trade and industry.

The Committee, therefore, directed to convey to all units that presence of a representative of the unit is mandatory and failing to attend such meeting would disentitle them from different permissions including import, DTA sale etc.

7.8 Joint monitoring of EOUs in terms of Appendix 14-I-G of HBP, as per the list of units (EOUs falling under jurisdiction of C. Ex. Commissionerate, Ghaziabad, U.P.)

1. **Allied Nippons Ltd:** Unit's representative attended the meeting. Performance found satisfactory.
2. **B.C. Exports:** No representative of unit attended the meeting. Committee directed the ADC concerned to inform the unit that not attending the joint monitoring would disentitle them from different permission including import and DTA sale etc.

3. **Chaudhary Hammer Works Ltd:** Committee noted that during the last joint monitoring on 02.03.2009, it was decided that C. Ex. Officials would visit the premise of the unit and submit the report. This report is still awaited. Performance found satisfactory

(Action: C.Ex., Ghaziabad)

4. **Global Signal Cables (I) Pvt Ltd:** No representative of unit attended the meeting. Committee directed the ADC concerned to inform the unit that not attending the joint

monitoring would disentitle them from different permission including import and DTA sale etc. However, base on the figures of DC's office, the Committee directed the C. Ex. Officer to examine the DTA sale of the unit and send report in this regard. Committed noted that similar decision was also taken during the last joint monitoring on 02.03.2009. Committee thus emphasized on the C. Ex. Officer to ensure examination and report as decided during joint monitoring.

- 5. Global Signal Cables (I) Pvt Ltd:** Committee noted that unit has not undertaken any export and import as well not submitted quarterly and annual performance report. In view of non-performance and non-observance of statutory obligation by the unit, the Committee directed that cancel the LOP of the unit.

- 6. Sage Metals Ltd:** Unit's representative attended the meeting. Performance found satisfactory.

- 7. Samtel Display Systems Pvt Ltd (two units):** Committee noted that performance of the unit is not satisfactory. The unit's representative explained that theirs' physical export is decreasing over the years. However, they are undertaking demmed export to M/s TeleTube Electronics Ltd. ADC concerned informed that M/s Teletube is not working from last three years and thus clearance to the unit, as stated, is doubtful. Committee then directed C. Ex, officer to visit M/s Teletube to assess correct position and examine the transaction between two units. Committee directed that report in this regard may be send to DC's office at the earliest.

(Action: C.Ex., Ghaziabad)

- 8. Teletube Electroncs Ltd:** Committee noted that unit has not undertaken any export and import as well not submitted quarterly and annual performance report. In view of non-performance and non-observance of statutory obligation by the unit, the Committee directed initiate proceeding for cancelation of the LOP of the unit. Simultaneously, the Committee directed C. Ex. Officer to examine and verify the advance DTA sale and any discrepancy may be dealt with in accordance with law.
