Minutes of 2nd Meeting (2010 Series) of Unit Approval Committee for EOU Scheme held under the Chairmanship of Shri. S.C. Panda, Development Commissioner, NSEZ, Noida on 25.03.2010 at 12.30 PM at NSEZ, Noida.

2nd Meeting (2010 Series) of Unit Approval Committee for EOU scheme was held on 25.03.2010 under the Chairmanship of Shri S.C. Panda, Development Commissioner, Noida SEZ. List of participants is enclosed at Annexure I. The convener of the UAC has informed the Committee this meeting is being convened after constitution of the UAC for EOUs by DGFT under Para 6.31 of HBP in terms of powers delegated for grant of any license and permission in respect of Export Oriented Unit vide notification No. 64(E) dated 12.01.2010 issued by the Ministry of Commerce & Industry. The Chairman welcomed all the participants of the UAC and thereafter agenda was taken up for discussion.

2.0 Confirmation of minutes of 1st meeting (2010 series) of the UAC held on 14.01.2010.

The Committee ratified the minutes of the 1st UAC meeting (2010 Series).

2.1 Acceptance of LUT submitted by M/s. Ali International, Azamgarh for manufacture of Handloom silk & cotton fabrics without the minimum investment criteria of Rs. 1 crore in plant and machinery.

The Committee deliberated the issue regarding as to whether the handloom is a part of "Handicraft" sector or not. Since no body from the unit has attended the meeting to explain the nature of work being carried out on the silk and cotton fabric manufactured by handloom, the Committee decided deferred the proposal.

2.2 Conversion of DTA unit into a 100%EOU for manufacture of Pan masala and pan masala containing tobacco by M/s. Kothari Products Ltd., Kanpur– consideration of proposal in term of para 6.7 (c) and (d) of FTP

The Committee deliberated the proposal and noted that the Jurisdictional Commissioner of Central Excise has reported duty evasion cases against the unit involving duty amounting to Rs. 19.90 crore. The Joint Commissioner of Customs, Kanpur has further reported that besides this duty evasion, a penalty of Rs. 42 crores have also been imposed on the unit.

In view of above, the Committee decided not to recommend this proposal and forward to BOA, being the case falls under non-automatic route in terms of para 6.7 (c) and (d) of FTP.

2.3 Conversion of DTA unit into a 100%EOU for manufacture & export of rice by M/s. Bush Foods Overseas Pvt. Ltd., Sonapat, Haryana– consideration of proposal in term of para 6.7 (c) and (d) of FTP

The Committee noted that many un-clarified issues from the unit in respect of this proposal. Also, no director/promoter of the company has appeared before the Committee.

Hence, the Committee decided to defer the proposal.

2.4 Setting up new 100%EOU by M/s. Saboo Cemtech Engineers Pvt. Ltd, Jodhpur for manufacture and export of cement plants and machinery

The Committee noted that the unit vide letter dated 16.03.2010 has requested to withdraw the proposal. In view of the company's request, the Committee has approved withdrawal of the proposal.

2.5 Setting up a new 100% EOU by M/s RISING SUN IMPEX at B-258, ROAD NO.6 I.P.I.A, KOTA, RAJASTHAN for manufacture & export of Gold & Silver Jewellery (Handmade)

The Committee heard the representative of the unit. Taking into consideration the viability of the project and experience of the partners in the concerned field of jewellery manufacturing, the Committee approved the proposal.

The meeting ended with the vote of thanks to the chair.
