

### Minutes of 2<sup>nd</sup> meeting (2011 Series) of Unit Approval Committee for Joint Monitoring of EOUs held under the Chairmanship of Shri. S.C. Panda, Development Commissioner, NSEZ, Noida on 28.04.2011 at 11.30 AM at NSEZ, Noida.

2<sup>nd</sup> meeting (2011 Series) of Unit Approval Committee (UAC) for Joint Monitoring of EOUs falling under jurisdiction of C.Ex. Commissionerate, Meerut-I was held on 28.04.2011 under the Chairmanship of Shri S.C. Panda, Development Commissioner, Noida SEZ. List of participants is enclosed at Annexure I. The Chairman welcomed all participants of the UAC and thereafter agenda was taken up for discussion.

#### **2.11(11) Joint monitoring of EOUs in terms of Appendix 14-I-G of HBP, as per the list of units (EOUs falling under jurisdiction of C.Ex. Commissionerate, Meerut-I)**


1. **M/s. Bhalla International** : No representative of the unit attended the meeting. The Committee reviewed performance and noted that the NFE of the unit is positive.
2. **M/s. Famous Art Group of Industries** : Unit's representative attended the meeting. It is brought to the notice of the Committee that LOP of the unit has already expired on 31.03.2011. Further, a Showcause Notice for contravention of FTP Provision in respect of DTA sale has been issued to the unit. Though the unit has applied for debonding, yet they have to apply extension for at least six months to complete the adjudication proceedings and formalities with respect to final debonding of the unit. The Committee has directed the unit representative to apply for LOP extension and directed the EOU section for expediting adjudication proceedings and thereafter debonding of the unit.

*(Action: EOU Section)*
3. **M/s. Flex Foods Ltd.** : Unit's representative attended the meeting. Performance found satisfactory. However, the Committee noticed that the unit has been allowed DTA sale of Rs. 16.27 crore in the year 2008-09. The details of DTA sales and deemed export undertaken by the unit may be examined.

*(Action: EOU Section)*
4. **M/s. Gruner India Pvt. Ltd.** : Unit's representative attended the meeting. Performance found satisfactory.
5. **M/s. India Glycols Ltd (Unit-II)** : Unit's representative attended the meeting. The Committee noted that the unit has started production on 17.03.2009. Since the unit is in pharmaceutical sector which need various approvals from agencies like US FDA for exporting the goods, the representative of the unit explained that they are in process in obtaining the same and their exports may accelerate in this financial year. The Committee noted the position.

6. ***M/s. Mercator Healthcare Ltd.*** : No representative of the unit attended the meeting. Performance found satisfactory. However, the Committee noticed that the unit has undertaken DTA sale and deemed export which may be examined by the EOU Section and by the Commr. of C. Ex. at their end.
7. ***M/s. Shakumbhri Expo-Impo Ltd.*** : Unit's representative attended the meeting. Performance found satisfactory. However, the deemed export undertaken by the unit may be examined.

The meeting ended with the vote of thanks to the chair.
