## NOIDA SPECIAL ECONOMIC ZONE

Minutes of 4<sup>th</sup> Coordination Meeting held under the Chairmanship of Shri S.C. Panda, Zonal Development Commissioner, NSEZ, Noida on 29.12.2009 at 04.00 PM at NSEZ, Noida.

The meeting was chaired by Shri S.C. Panda, Zonal Development Commissioner.

Development Commissioner welcomed the Officers and representatives of SEZ developers. As advised in the 3<sup>rd</sup> Coordination meeting the following issues submitted by developers of Haryana & Rajasthan state were discussed in the meeting: -

1. Exemption from State Taxes, Duties, Fees, Cess or any other levies applicable to SEZ Developer & Co-Developer.
2. Waiving of Bank Guarantee clause by the SEZ Developers in Haryana.
3. Declaration of SEZs as Industrial Township and exclusion from jurisdiction of Municipal Corporation.
4. Anomalies in Haryana SEZ Rules 2007 and the Haryana Special Economic Zone (Amendment) Act 2008.
5. Exemption / Determination of rates of External & Infrastructure Development Charges (EDC/IDC).
6. Deemed Distribution License for power to SEZ Developer unlike in the state of Maharashtra and also availability of Power.
7. Creation of Single Window Clearance Mechanism for units in the SEZ. Presently Single Window Clearance Mechanism has been adopted by the State of Tamilnadu & Gujarat.

DC assured the developers that the issues would be taken up with the Chief Secretary of Haryana in the proposed meeting, which will be held shortly in Chandigarh. DC also suggested to the developer to attend the said meeting.

DC advised the representative of M/s. Somani Worsted Ltd. to furnish a copy of Show Cause Notice issued by RIICO alongwith terms & conditions of the allotment of land, so that the matter may be taken up with the Govt. of Rajasthan.

The meeting ended with a vote of thanks to the chair.
