

### Minutes of review meeting of Unit Approval Committee of M/s. Gurgaon Infospace Ltd., held on 04.11.2010 at 12.30 P.M. at NSEZ, Noida

The meeting was chaired by Shri S.C. Panda, Development Commissioner. The following officers / representatives also attended the UAC meeting:-

Development Commissioner welcomed all participants and informed that DOC vide Notification dated 29.10.2010 has reverted the IT/ITES SEZ of M/s. Gurgaon Infospace Ltd. at Vill. Dundahera, Distt- Gurgaon (Haryana) from STPI New Delhi.

The representative of M/s. Gurgaon Infospace Ltd., developer informed that they have already invested Rs. 414 Crores in construction of 13.50 Lacs Sqft area in the SEZ. Presently nine SEZ units are working in the SEZ. Total investment of Rs. 224.88 Crores has been made by the units. Total export figures during the last three years from the SEZ are as under:-

Total 7459 employment have been generated by these SEZ units.

The representatives of Royal Bank of Scotland were also present in the meeting. He informed that they have submitted application with Director, STPI, New Delhi to setup their SEZ unit in Gurgaon Infospace Ltd. SEZ. but no response has been received from STPI, New Delhi. In view of the Notification dated 29.10.2010, a fresh application will be submitted with DC, NSEZ. soon.
