At the outset Zonal Development Commissioner welcomed the Officers and representatives of SEZ developer & SEZ Units.

The representative of the developer informed that an area of 88071 Sqmt has been constructed in the processing area of SEZ. Further construction of the processing area is being done. The investment of Rs. 263.74 Crores has already been made upto 30.09.2010 on the project. As on date following four units have been approved in the SEZ:-

1. MetLife,
2. IBM,
3. Accenture,
4. T.C.S.

Out of above, Metlife & Accenture have become functional. The representative of M/s. Metlife informed that total export during the FY 2009-10 is Rs. 118 Crores & total export of Rs. 66.35 Crores has been made during the current FY 2010-11 upto 30.09.2010. They have generated 1792 employment by this SEZ unit. The representative of M/s. Accenture informed that they have made export of Rs. 3.50 Crores during the current financial year & expected export by end of the FY 2010-11 would be Rs. 20.00 Crores. They have generated 315 employments in this SEZ unit.

The representative of M/s. IBM informed that they will start operations by December, 2010. The representative of M/s. TCS informed that their unit will become functional within next 03 months.
