

The initial period of deputation is 3 years and all rules, regulations and provisions issued from time to time for deputation shall be applicable. However, a Govt. Officer in a higher grade pay / scale shall be ineligible for appointment on deputation to post in the lower grade pay / scale in terms of Deptt. of Expenditure's O.M. No. 1/1/2008-LC dt. 26.3.2009 and DOPT O.M. No. 6/8/2009-Estt (Pay II) dt. 17.6.2010.
