**Sub: Default list of services to be received and used for authorized operations by the Units/Developers/Co-Developers of SEZs under the jurisdiction of Noida SEZ -reg.**  
विषय: - नोएडा एसईजेड के अधिकार क्षेत्र में आने वाले एसईजेड की इकाइयों/विकासकर्ताओं/सह-विकासकर्ताओं द्वारा अधिकृत कार्यों के लिए प्राप्त और उपयोग की जाने वाली सेवाओं की डिफॉल्ट सूची - संदर्भ।

Kind attention is invited to the Approval Committee Meeting of Moradabad SEZ held on 02.06.2026, wherein the Approval Committee decided to approve the list of default services (as amended from time to time) approved by the Department of Commerce vide letter F. No. D.12/19/2013-SEZ dated 02.01.2018 (copy enclosed), to be received and used for authorized operations by the Units/Developers/Co-Developers of SEZs under the jurisdiction of Noida SEZ. However, units may apply afresh for any additional service(s) which are not included in the default list of services.

No. D.12/19/2013-SEZ दिनांक 02.01.2018 (प्रतिलिपि संलग्न) के माध्यम से अनुमोदित 'डिफॉल्ट सेवाओं' की सूची (समय-समय पर संशोधित) को स्वीकृत करने का निर्णय लिया है, जिन्हें नोएडा SEZ के अधिकार क्षेत्राधीन SEZ इकाइयों/डेवलपर्स/सह-डेवलपर्स द्वारा अधिकृत कार्यों हेतु प्राप्त एवं उपयोग किया जा सकता है। तथापि, यदि किसी इकाई को ऐसी अतिरिक्त सेवा(ओं) की आवश्यकता हो जो डिफॉल्ट सेवाओं की सूची में शामिल नहीं हैं, तो वह उसके लिए पृथक रूप से नया आवेदन प्रस्तुत कर सकती है।

2. ये डिफॉल्ट सेवाएं SEZ की इकाइयों/डेवलपर्स/सह-डेवलपर्स द्वारा 'डिफॉल्ट अधिकृत सेवाओं' के रूप में प्राप्त की जा सकती हैं, बशर्ते कि वे SEZ अधिनियम/नियमों तथा CBIC अधिसूचना संख्या 12/2013-ST दिनांक 01.07.2013 (01 जुलाई 2013 से प्रभावी) के प्रासंगिक प्रावधानों का अनुपालन करें। तथापि, 01.07.2013, effective from 01st July,

Sir/Madam

I am directed to refer to this Ministry's letter No. D.12/25/2012-SEZ dated 16<sup>th</sup> September, 2013 and subsequent letters of even number dated 19<sup>th</sup> November, 2013, 19<sup>th</sup> June, 2014 and 9<sup>th</sup> July, 2014 vide which a list of 66 services which may be permitted by all Unit Approval Committees (UACs) as default authorised services was conveyed (copies enclosed).

2. The BoA was appraised that consequent to implementation of GST Act, some State Government are not extending the benefits of IGST exemption for default services. Since, SEZs are exempt from IGST and the above matter was placed before 80<sup>th</sup> BoA meeting held on 17<sup>th</sup> November, 2017. The BoA, after deliberations, approved the reiteration of the default authorized operations as approved, earlier.
