Minutes of 2nd meeting (2017 Series) of Unit Approval Committee for Joint Monitoring of EOUs under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, NSEZ held on 09.05.2017 at 11.00 AM in the O/o Development Commissioner, Noida Special Economic Zone, Noida-Dadri Road, Phase-II, Noida-201305.

2nd meeting (2017 Series) of Unit Approval Committee (UAC) for Joint Monitoring of EOUs falling under jurisdiction of Central Excise Commissionerate, Agra, Allahabd, Kanpur & Lucknow was held on 09.05.2017 under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, Noida SEZ in the O/o Development Commissioner, Noida Special Economic Zone, Noida-Dadri Road, Phase-II, Noida-201305. List of officers is enclosed at Annexure-I. The Chairman welcomed all participants of the UAC and thereafter joint monitoring of each unit was taken up.

2.1(17): Joint monitoring of EOUs falling under jurisdiction of C.Ex. Commissionerate, Agra in terms of Appendix 6F of HBP.

1. **M/s. B.B. Foods:** The Committee reviewed the performance of the unit and noted that unit has not achieved positive NFE in their first block of five years. A Show Cause Notice was issued to the unit by NSEZ and unit has also been granted opportunity of personal hearing. After Personal hearing Show Cause Notice issued to the unit would be adjudicated. The Committee also requested Central Excise authorities to initiate action as per Customs & Central Excise law to recover the duties to safeguard the govt. revenue.
2. **M/s. Unilever India Exports.:** The Committee reviewed the performance of the unit and found it satisfactory. However, it was noted that unit has been submitting same figures of DTA sale and deemed export in their APR. Unit was asked to rectify the same at the earliest.

2.2(14): Joint monitoring of EOUs falling under jurisdiction of C.Ex. Commissionerate, Allahabad in terms of Appendix 6F of HBP.

- 1. M/s. Bholanath Industries Ltd.:** The Committee reviewed the performance of the unit and noted that unit has been issued Show Cause Notice dated 01.05.2015 for un-authorized DTA sale. Unit went to Policy relaxation Committee (PRC) in DGFT for relaxation, PRC has remanded back the case to Development Commissioner, NSEZ to decide the case on merits. Unit was asked to submit relevant documents to decide the case. Unit has submitted documents such as ARE-1 instead of shipping bills. The unit submitted that they have again approached PRC for review of their earlier decision. The Committee observed the matter has been pending for long and asked the unit to get it expedited so that the matter is settled.

2.3(17): Joint monitoring of EOUs falling under jurisdiction of C.Ex. Commissionerate, Kanpur in terms of Appendix 6F of HBP.

1. **M/s A & C Braid and Rope Co. (P) Ltd:** The Committee reviewed the performance of the unit and found it satisfactory. It was noted that discrepancy pointed out in respect of deemed export figures in the APR 2015-16 submitted by the unit has not been rectified. The Committee directed the unit to rectify the discrepancy in their APR at the earliest.
2. **M/s E.I.S. Electronics (I) Pvt. Ltd.:** The Committee reviewed the performance of the unit and found it satisfactory.
3. **M/s Equiplus India Limited:** The Committee reviewed the performance of the unit and found it satisfactory.
4. **M/s Equiplus India Exports Ltd.:** The Committee reviewed the performance of the unit and found it satisfactory.
5. **M/s Kanpur Texel (P) Ltd.:** The Committee reviewed the performance of the unit and found it satisfactory.
6. **M/s MKU (P) Ltd.:** The Committee reviewed the performance of the unit and found it satisfactory.
7. **M/s MKU (P) Ltd. (Optics Division):** The Committee reviewed the performance of the unit and found it satisfactory.
8. **M/s J.S. International:** The Committee reviewed the performance of the unit and noted that unit has been issued "In-principle" exit order dated 15.03.2011 by NSEZ. It was noted that Assistant Commissioner of Central Excise, Division-II, Kanpur vide their letter C.No. VIII (40)251/Regn/JS Intl/DII/04/2892 dated 06.11.2013 had issued No-dues certificate in respect of the location situated at B-15 to B-47, UPSIDC Industrial Area, Banthar, Unnao, U.P, but No-dues certificate in respect of the location located at 38-A, Sanjay Nagar, Jajmau, Kanpur, U.P. is still awaited. The Committee requested jurisdictional Central Excise authorities to expedite the matter so that further necessary action could be taken.
