3.2(15) Proposal for setting up 100%EOU by M/s Eglo India Productions (P) Ltd., Plot No. 349-350, Sector-2, Phase-I, IMT Bawal, Distt.-Rewari, Haryana.

The Committee deliberated the proposal and noted that as per the site inspection report furnished by the jurisdictional Central Excise, Rewari, that another unit namely, M/s Energetic Lighting India (P) Ltd. is already registered at the same premises. Further, Central Excise has submitted that the verification report cannot be submitted till the surrender of the registration of M/s Energetic Lighting India (P) Ltd. is accepted. Therefore, Committee decided to defer the proposal till proper report is received from the Central Excise, Rewari, Haryana.

3.3(15) Proposal for setting up 100%EOU by M/s VVDN Technologies, D-22, Infocity-2, Sector-33, Gurgaon.

The Committee deliberated the proposal and decided to approve the proposal.

3.4(15) Proposal for setting up 100%EOU by M/s Ishan Textile Mills Limited, ITM, Village-Khasa, G.T. Road, Amritsar, Punjab.

The Committee deliberated the proposal and noted that as per the site inspection report furnished by the jurisdictional Central Excise, Amritsar does not merit consideration as there is another unit namely, M/s Masuzawa Punjab Silk Ltd. (100%EOU) and from whom an amount of Rs. 54,34,799/- is recoverable as Government dues. Further, as per their office records M/s Masuzawa Punjab Silk Ltd. has not exited/debonded from the 100%EOU scheme. The Committee, therefore, decided to reject the proposal.

3.5(15) Adjudication of Show Cause Notice in respect of M/s F.E. Industries Limited A-44, Industrial area, Phase-VIII B, Mohali-160071, Punjab.

The Committee deliberated the proposal and DC heard the representative of the unit and took a lenient view in the matter and imposed a token penalty of Rs. 10,000/- (Rupees Ten thousand only) for violation of provisions of FT (D&R) Act, 1992. Central Excise authorities were also asked to take appropriate action (of recovering the duties etc.) in the matter.

3.6(15) Adjudication of Show Cause Notice in respect of M/s Sheel Biotech Limited, Kamal farms, Village-Sehrawan, District-Gurgaon, Haryana.

Since, the unit's representative was not present, the committee decided to defer the proposal.
