Minutes of 3rd meeting (2012 Series) of Unit Approval Committee for Joint Monitoring of EOUs held under the Chairmanship of Shri C.P.S. Bakshi, Development Commissioner (I/C), NSEZ, Noida on 18.05.2012 at 11.30 AM at NSEZ, Noida.

3rd meeting (2012 Series) of Unit Approval Committee (UAC) for Joint Monitoring of EOUs falling under jurisdiction of C.Ex. Commissionerate, Noida was held on 18.05.2012 under the Chairmanship of Shri C.P.S. Bakshi, Development Commissioner (I/C), Noida SEZ. List of participants is enclosed at Annexure I. The Chairman welcomed all participants of the UAC and thereafter agenda was taken up for discussion.

3.6 Joint monitoring of EOUs falling under jurisdiction of C.Ex. Commissionerate, Delhi-III, Gurgaon in terms of Appendix 14-I-G of HBP.

1. ***M/s. Alcome Perfumes & Cosmetics Pvt. Ltd.*** : No representative from the unit attended the meeting. The ADC concerned has informed that In-principal debonding was allowed to this unit on 12.06.2009 and the final NOC from the Central Excise is awaited for final debonding of the unit. The C. Ex., Noida has to examine the matter keeping in view the pending foreign exchange and a report in this regard would be sent to the NSEZ.
2. ***M/s. Anjani Technoplast Ltd.*** : No representative from the unit attended the meeting. The ADC concerned has informed that In-principal debonding was allowed to this unit on 10.06.2010 and the NOC from the Central Excise is awaited for final debonding of the unit. The C. Ex., Noida has to examine the matter keeping in view the pending foreign exchange and a report in this regard would be sent to the NSEZ.
3. ***M/s. Ansa Brakes Pvt. Ltd.*** : No representative from the unit attended the meeting. The concerned C. Ex, officer, Noida has informed that this unit is closed as per their record. The ADC concerned informed that this unit is functional. The C.Ex. has to check their record and send a report. On receipt of report from C. Ex., matter to be examined in NSEZ on file.

The representative of the unit has raised an issue regarding VAT refund from the State Government. It was advised to him that he may represent his case which would be suitably forwarded to the concerned authority.

The ADC informed that the In-principal debonding has been allowed to this unit. The matter relating to the pending foreign exchange was discussed and C.Ex. has to check the status of the same and send a report before considering the final debonding.
12. **M/s. DELTRONIX India Ltd.** : No representative attended the meeting. The performance of the unit found satisfactory. However, keeping in view the substantial amount of deemed export and DTA sale undertaken by the unit, it was decided to examine the case on the file.
13. **M/s. Denz Exports Pvt. Ltd.** : Unit's representative attended the meeting. The performance of the unit found satisfactory. However, the ADC informed that the APR for the year 2010-11 has not been received from the unit. The matter may be taken up with the unit.
14. **M/s. Elcomponics Sales Pvt. Ltd.** : Unit's representative attended the meeting. It was noticed that the chart showing high deemed export. It was decided that the data w.r.t. this unit need to reconcile from the APRs. C.Ex. has to examine the performance and send a status report. On receipt of report from C. Ex., matter to be examined in NSEZ on file.

The C.Ex., Noida may examine the entire performance of the unit and send a detailed report at the earliest. On receipt of report from C. Ex., matter to be examined in NSEZ on file.

The ADC informed that the unit is not functional and the no dues granted by the C.Ex. is not complete as it referred to the pending duty payment on the stock of finished goods and WIP. The C.Ex., Noida has to examine the case and send a report. On receipt of report from C. Ex., matter to be examined in NSEZ on file.
