2. **M/s. DLF Ltd., IT/ITES SEZ, Silokhera, Gurgaon.**

(i) Proposal of M/s. DLF Utilities Ltd., Co-developer for approval of three lists of materials.

After due deliberations, UAC approved the list of materials (As per Annexure-A) as proposed by the co-developer, M/s. DLF Utilities Ltd., for a period of six months, to carry on following approved authorized operation in the IT/ITES SEZ of M/s. DLF Ltd. at Sector-30, Silokhera, Gurgaon:-

It was informed to the UAC that documents like Form-32 for appointment / cessation of new directors and ITRs of Sh. Vikas Bhalla, Director are awaited from the applicant. The representative of the applicant assured to furnish above documents in due course. After due deliberations, UAC approved the proposal, subject to condition that formal approval shall be issued only after submission of requisite documents / information by the applicant.

It was brought to the notice of UAC that DTP (HQ), DTCP, Chandigarh vide its Memo No. SEZ-15/SD(BS)/2014/20136 dated 27.08.2014 has informed that the site has been got inspected through Senior Town Planner, Gurgaon and it has been reported that the developer has raised the construction at site and has completed the buildings in all respect, but, has made following violations which are compoundable:-
