● **Minutes of the Approval Committee Meeting of Jaipur Special Economic Zone, Sitapura (Multi Product SEZ) held at 2:00 PM on 04.11.2025 under the chairmanship of Shri A. Bipin Menon, Development Commissioner through Video Conferencing.**

The following members of Approval Committee were present during the meeting through video conferencing:-

i) Shri R. S. Dhariwal, Senior RM (RIICO) and ii) Shri Pankaj Sharma, ADC were also present through video conferencing in the meeting to assist the Approval Committee. It was informed that the quorum was complete and the meeting could proceed.

The Chairman welcomed the participants at the outset and then the agenda was taken up for sequentially. After detailed deliberation amongst the members of the Approval Committee as well as interaction with Developer/ Representatives of the Units/ Applicants, the following decisions were unanimously taken:

Agenda Ratification of Minutes of Approval Committee meeting held on No. 1 30.09.2025:

It was informed that no reference has been received against the decisions of the Approval Committee Meeting held on **30.09.2025** from any of the members of the Approval Committee/ Trade/ Unit. Therefore, Minutes of the meetings of Approval Committee held on **30.09.2025** was unanimously ratified.

Agenda Proposal of M/s Gaurav Jewels Exports Private Limited, for broad-banding (addition /Revision/ Change of New items)-reg.

2.1. The proposal of M/s Gaurav Jewels Exports Private Limited, Plot No. G-100, SEZ-II, Sitapura, Jaipur for broad-banding (addition / Revision / Change of New items) in LOA No. 2-52-SEZ-II (J) Proj./99 dated: 18.05.2010 was discussed in the meeting.

2.2 No one appeared before the Approval Committee.

2.3. Accordingly, after due deliberations, the Approval Committee unanimously decided to **defer** the proposal for next UAC.

3.1. The matter of M/s Symphony Jewels Private Limited, Plot No. H-58, SEZ-II, Sitapura, Jaipur in the wake of Action taken report dated 31.10.2025 of Specified Officer, JSEZ under FTDR Act in LOA No. 2-178-SEZ-II (J) Proj./792 dated: 11.08.2008 was discussed in the meeting.



3.2 Shri Navratan Johari, Director, appeared before the Approval Committee on behalf of the unit. On being asked by the committee about the negative NFE and pending BRC of Rs. 831.56, he informed that he would submit clarification on the above points. He also affirmed that plots of M/s Tarkesh Art Jewellers and M/s Symphony Jewels Pvt. Ltd. are merged as of now and if permitted, he will construct separate walls for both units with separate entry points. Further, it was also noticed by the committee that RIICO dues amounting to Rs 1.33 Lakh (Approx.) are also pending.

3.3. After due deliberations, the committee **took a serious view on the defaults committed by the unit** and unanimously decided to empower the O/o Development Commissioner to initiate further necessary action under FT(D&R) Act 1992 and SEZ Act 2005 (including issuance of Show Cause notice and cancellation of LOA, if required). Further, the committee also decided that a note in this respect shall also be sent to the Jurisdictional Customs Commissioner for information and necessary action under Customs Act 1962.

3.4. In this regard, the committee directed the Specified Officer, JSEZ to coordinate with Jurisdictional Customs Commissionerate and initiate necessary action under Customs Act 1962 to safeguard revenue leakage, if any.

4.2 Shri Jitndra Singh, Manager & authorized representative appeared before the Approval Committee on behalf of the unit. On being asked by the committee, he informed that unit will deposit RIICO dues amounting to Rs 93, 232- (Approx.) for further course of action. Further, the committee also noted that the APRs for the previous block years have been submitted with considerable delay.

4.3. After due deliberations, the committee **took a serious view on the defaults committed by the unit** and unanimously decided to empower the O/o Development Commissioner to initiate further necessary action under FT(D&R) Act 1992 and SEZ Act 2005 (including issuance of Show Cause notice and cancellation of LOA, if required). Further, the committee also decided that a note in this respect shall also be sent to the Jurisdictional Customs Commissioner for information and necessary action under Customs Act 1962.

5.2 Shri Akshay Bohra, brother of partner & authorized representative appeared before the Approval Committee on behalf of the unit. On being asked by the committee, he informed that unit will provide necessary evidential documents in respect of timely submission of APRs as well as reply to JSEZ office letter dated 30.12.2022. Further, it was also noticed by the committee that RIICO dues amounting to Rs 2.04 Lakh (Approx.) are also pending.

5.3. After due deliberations, the committee **took a serious view on the defaults committed by the unit** and unanimously decided to empower the O/o Development Commissioner to initiate further necessary action under FT(D&R) Act 1992 and SEZ Act 2005 (including issuance of Show Cause notice and cancellation of LOA, if required). Further, the committee also decided that a note in this respect shall also be sent to the Jurisdictional Customs Commissioner for information and necessary action under Customs Act 1962. 
