Minutes of the Approval Committee meeting in respect of SEZs located in Noida, Greater Noida & Khurja (Uttar Pradesh), held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner, NSEZ at 10:30 AM on 06.08.2025.

• Besides, during the meeting (i) Sh. Gya Prasad, DDC (ii) Sh. Noman Hafiz, DDC (iii) Shri Ravikesh Tripathi, Specified Officer (iv) Shri Prakash Chand Upadhyay ADC, (v) Sh. Sushil Kumar, ADC & (vi) Sh. Anuj Dixit, UDC /Dealing hand, were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.

• At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken unanimously:-

1. Ratification of the Minutes of the Approval Committee meeting held on 03.07.2025:-

One reference in respect of the decisions of the Approval Committee held on 03.07.2025 was received from a unit M/s. TLG India Private Limited for inclusion of revised projections in the Minutes of UAC. UAC took note and accordingly the Minutes of the Meeting held on 03.07.2025 were ratified.

Item No. 2: Ratification of minutes of UAC dated 03.07.2025-reg.

2.1.1 The Approval Committee noted that the matter was deliberated in the last UAC meeting dated 03.07.2025. Item No. 4: Proposal for Merger of the LOAs of SEZ Units-reg.

4.1 M/s. R Systems International Limited, Unit

4.1.1 Sh. Nand Sardana, Sh. Kumar Gaurav authorized representative of M/s. R Systems International Limited joined the meeting through video conferencing and explained the proposal.

4.1.2 The Approval Committee discussed the proposal in detail and after due deliberations approved the proposal of M/s. R Systems International Limited for merger of LOA No. 10/45/2019-SEZ/10944 dated 23.09.2019 into LOA No. 10/43/2016-SEZ/9942 dated 19.10.2016 as per proviso 4 to Rule 19 (2) of SEZ Rules, 2006. After merger, block period for calculation of Net Foreign Exchange shall be from the date of commencement of production of the Unit which commenced first i.e. w.e.f. 28.02.2017 and the Income Tax exemption shall be considered from the date of start of operation of the first unit i.e. w.e.f. 28.02.2017. 5.1.2 The Approval Committee noted that the entity has two units with two different LOAs. One of the units with LOA no. 10/58/2019-SEZ13119 dated 20.11.2019 is located in M/s. Golden Tower Infratech Pvt. Ltd. SEZ and the other unit with LOA No. 10/303/2010-SEZ/396 dated 14.10.2010 is located in M/s. Oxygen Business Park Pvt. Ltd. SEZ. The Approval Committee took note of the changes in Directors of the company for both the units, in terms of the Instruction No. 109 dated 18.10.2021 issued by DOC.

Item No. 06: Proposal of M/s. Golden Tower Infratech Private Limited, developer for grant one-time prior approval to lease out built-up space to facility providers in the processing area of the IT/ITES SEZ at Plot No. 20 & 21, Sector- 135, Noida (U.P.)-reg.

6.1 M/s. Golden Tower Infratech Private Limited, Developer

6.1.1 Sh. B. D. Joshi, DGM of M/s. Golden Tower Infratech Private Limited joined the



meeting through video conferencing and explained the proposal.

6.1.2 M/s. Golden Tower Infratech Private Limited, Developer vide its letter dt. 22.07.2025 has submitted proposal for one-time approval of UAC in terms of Rule 11(5) of SEZ Rules, 2006, to lease out the designated facility space in the Ground Floor of Building No. B-1 to relevant service providers (e.g., cafeteria, Creche, First Aid Centre, Gym etc.) as and when required in future, exclusively for SEZ unit usage. Representative of the Developer assured that every subsequent change in facility allotment and surrender shall be duly intimated to this office, along-with detailed particulars of the area and service provider.

6.1.3 The Approval Committee observed that in terms of Rule 11(5) of SEZ Rules, *"the Developer may, with the prior approval of the Approval Committee, grant on lease land or built up space, for creating facilities such as canteen, public telephone booths, first aid centres, crèche and such other facilities as may be required for the exclusive use of the Unit."*

6.1.4 The Approval Committee analyzed the provisions and took note of the practical difficulty being faced by the Developer. The Approval Committee observed that a one time approval would be a trade facilitatory measure and highlighted that Rule 11(5) talks about UAC approval for creation of facilities and not allocation to individual facility providers. Further, no tax/duty benefits were being allowed to these facility providers. It was also noted that in the past similar approval has been given to M/s Seaview Developers Private Limited (Developer). After due deliberations and based on the considerations in the above para and precedence, the Approval Committee unanimously approved the proposal for one-time approval to lease out built-up space in the Ground Floor of Building No. B-1 in the processing area of SEZ to relevant service providers (e.g., cafeteria, Creche, First Aid Centre, Gym etc.), in terms of Rule 11(5) for providing facilities. The approval is subject to the condition that the developer will submit intimation to Office of the Development Commissioner, NSEZ as and when such changes in service providers takes place along with a consolidated list showing details of area allotted to each vendor within 30 days of such changes, for post facto intimation to UAC

Item No. 07: Proposal of M/s. Tele-performance Global Business Pvt. Ltd. for partial surrender of area (incubation centre) of its unit located in the M/s Sea View Developers Pvt Ltd., IT/ITES, SEZ, at Plot No.20 & 21, Sector-135, Noida (U.P.)-Reg..

7.1 M/s Teleperformance Global Business Pvt. Ltd.

8.1 M/s. Diligent Logistics Solutions Pvt. Ltd.

8.1.1 Sh. Vinod Parekh, Sh. Rakesh Trikha and Ms. Kashish Trikha joined the meeting through video conferencing and informed that they have submitted a representation for rectification of Minutes of UAC dated 05.06.2025.

8.1.2 The Approval Committee discussed the representation in detail and after due deliberations noted that draft Show Cause Notice has been sent to Noida Customs for issuance and the alleged misconduct on part of CHA (i.e. M/s. Diligent Logistics Solutions) is under investigation. Further, UAC empowered DC office to take a decision on file after seeking legal opinion from YP legal and Legal Firm with respect to the issues raised by the unit in its representation.

Item No. 09: Inclusion of additional items in LOA for its unit in Arshiya Northern FTWZ LOA No 10/16/2023-SEZ/5784 dated 26.07.2023-reg.

9.1 M/s. We Spirit Inc.

9.1.1 The Approval Committee discussed the proposal in detail and noted that the internal committee constituted vide order 07.10.2024 under the chairmanship of Joint Development Commissioner has recommended inclusion of the proposed 8 digit HS codes in LOA with certain conditions for DTA sale.
