C. At the outset, the Chairman welcomed the participants. After brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken unanimously: -

Item No. 2 : **Renewal of Letter of Approval**

2.1: M/s. Srikaram Prescience Pvt. Ltd. (LoA No. 10/17/2012-SEZ/4136, dated 08.06.2012).

2.1.1. Shri Ramnathan Ranganathan, Director and Sh. Sumit Wadhwa, Legal representative of M/s. Srikaram Prescience Pvt. Ltd. joined the meeting in the meeting hall and explained the proposal.

2.1.2 It is informed to the Committee that earlier, the matter for renewal of LOA of the unit was discussed in the UAC dated 05.06.2025. As per the minutes of UAC:-

The Approval Committee observed that a show cause (Show Cause Notice No. 18/JC/NOIDA/CUS/2024-25 DATED 29.10.2024) has been issued to the unit by Noida Customs Commissionerate under Customs Act, 1962 and after due deliberations decided to renew the LOA of the unit only for a period of 01 year i.e. upto 18.7.2026 subject to submission of the clarification on the deficiencies already conveyed to the unit. The renewal of LOA for the remaining part of the block year will be considered after adjudication of show cause notice by the customs and after Monitoring the performance of the unit by UAC.

2.1.3 M/s. Srikaram Prescience Pvt. Ltd. has requested for renewal of LOA, according to the decision of Approval Committee dated 05.06.2025, the matter for renewal of LOA was again placed before Approval Committee for deliberations.

2.1.4 It was informed to the Committee that an order of Joint Commissioner (Customs) confirming the demands and penalty has been issued on 01.07.2025. Specified Officer, Arshiya Northern FTWZ has also informed that there are two Orders in Original have been issued against the unit by Noida (Customs) for contravention of Customs Act, 1962. Specified Officer, Arshiya Northern FTWZ further informed that the areca nut and sensitive items have already been removed from the Letter of Approval of the unit.

2.1.5 The committee took note of the positive NFE of the unit in the current block of 05 years.

2.1.6 Sh. Sumit Wadhwa, Legal representative of M/s. Srikaram Prescience Pvt. Ltd. informed that the matter is sub-judice before the Hon'ble High Court Allahabad.

2.1.7. The Approval Committee discussed the proposal in detail and after due deliberations **deferred** the proposal and directed to seek legal opinion in the matter. Further the Chairman of the Committee requested to the members to provide their written comments on the matter. The LOA is valid upto 18.07.2026 and the next UAC is scheduled on 02.07.2026.

The applicant has submitted copy of provisional offer of space dated 06.10.2025 issued to them by SEZ Developer for allotment of proposed space. The proposed employment mentioned by the Unit is 03 persons.

The unit shall comply the Customs Act, 1962, Customs Tarrif Act 1975, Wilf Life Protection Act, 1972 (Amended 2022), Foreign Trade (Development & Regulation) Act, 1992, Drugs & Cosmetics Act, 1940, The Livestock Importation Act, 1898 & also various permissions like Drugs Controller General of India (CDCSO & Quarantine) Approval, Narcotic Drugs and Psychotropic Substances Act (NDPS Act, 1985) etc. and take approvals as & when required.
- v. All the above conditions shall be ensured by the Customs, NSEZ.

1.1.5 The Approval Letter F. No. 10/23/2025-SEZ/5123 dated 11/06/2026 has been issued to the applicant.

1.1.6 Ms. Disha, representative of M/s. Arshiya Northern FTWZ Ltd. was also present in the meeting. It has been informed by the Specified Officer that Cameras on key positions like inward/outward gates and three warehouses are not working in the SEZ The Committee directed the Developer to ensure that all the cameras should be working condition and access of the cameras to be provided to Customs, NSEZ. Any Violation of the directions will leads to penal provisions.
