Minutes of the Approval Committee meeting in respect of SEZs located in Noida, Greater Noida & Khurja (Uttar Pradesh), held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner, NSEZ at 11.00 AM on 30.09.2025.

The following members of Approval Committee were present during the meeting:-

- Besides, during the meeting (i). Shri Gya Prasad, DDC, (ii). Shri Noman Hafiz, DDC, (iii) Shri Ravikesh Tripathi, Specified Officer, (iv). Shri Prakash Chand Upadhyay, ADC, (v) Shri Sushil Kumar, ADC & (vi) Shri Anuj Dixit, UDC / Dealing hand, were also present to assist the Approval Committee. It was informed that the quorum was available and the meeting could proceed.
- At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken unanimously:-

1. Ratification of the Minutes of the Approval Committee meeting held on 04.09.2025:-

As no reference in respect of the decisions of the Approval Committee held on 04.09.2025 was received from any of the members of the Approval Committee or trade, the Minutes of the Meeting held on 04.09.2025 were ratified.

Item No. 2: Proposal for setting up of new unit:-

2.1: M/s. In2IT Global Services Private Limited

2.1.1. M/s. In2IT Global Services Private Limited has submitted a proposal for setting up a unit over an built-up area of 232.26 Square metres (2500 Square feet) on 13th floor, Tower-1 in the Artha Infratech Private Limited IT/ITES SEZ at Plot No. 21, Sector-Techzone-IV, Greater Noida (Uttar Pradesh), to undertake service activities namely '*Information Technology, Consulting and support services (CPC- 83131)*'. The applicant had proposed export of Rs.22524.00 lakhs and cumulative NFE of Rs.22524.00 lakhs over a period of five years. The projected investment of Rs.60.00 lakhs towards indigenous capital goods have been proposed. The applicant had also proposed indigenous input services of Rs.56.00 lakhs. The applicant had submitted copy of provisional offer of space dated 22.08.2025 issued to them by M/s. Trustone Wegmans Developers Private Limited, SEZ Co-developer for allotment of proposed space.

2.1.2. Shri B. Nagrajan, Vice President of M/s. In2IT Global Services Private



Limited appeared before the Approval Committee and explained the proposal. He informed that due to internal dispute amongst directors of the company the existing unit of M/s. In2IT Technologies Private Limited could not continue its operations. One of the director of M/s. In2IT Technologies Private Limited had been forcefully removed from the board of directors. The said matter is under arbitration process. Shri Nagarajan assured that they will complete the exit formalities of existing unit with in next six months. As regard source of fund for proposed new SEZ unit, he informed that the existing DTA unit of M/s In2IT Global Services Private Limited will infuse the fund for proposed new SEZ unit.

2.1.3. The Approval Committee discussed the proposal in details and after due deliberations, approved the proposal of M/s In2IT Global Services Private Limited for setting up of new unit in the Artha Infratech Private Limited IT/ITES SEZ at Plot No. 21, Sector-Techzone-IV, Greater Noida (Uttar Pradesh), to undertake service activities namely '*Information Technology, Consulting and support services (CPC-83131)*', with the condition that the initial validity of the Letter of Approval shall be for a period of six months. The Committee directed that representative of the unit to submit an Undertaking on Rs.100/- non-judicial stamp paper that they will complete the exit formalities of existing unit within next six months and the existing DTA unit of M/s. In2IT Global Services Private Limited will infuse the fund for proposed new SEZ unit in case of requirement.

Item No. 3. Proposal for approval of list of materials:

3.1 : M/s. Wipro Limited, Developer

3.1.1. Shri Raj Kumar Singh, Senior Manager & Shri Narotam Kumar Sharma, authorized representative of M/s. Wipro Limited joined the meeting through video conferencing and explained the requirement of proposed materials.

3.1.2. The Approval Committee observed that the Developer has proposed '500 Kg. Refrigerant / AC Gas (Rs. 5.00 lakhs)' at Sl. No. 11 under authorized operations namely 'Air Conditioning of processing area'. Therefore, the Developer needs to provide name & ITC HS Code of proposed Refrigerant / AC Gas to ascertain Import / Export policy on the same.


3.1.5. This approval is subject to the condition that Specified Officer shall ensure that procurement of products 'Restricted / Prohibited' for import shall not be allowed.


