Besides, during the meeting i) Shri Rajesh Kumar, DDC, ii) Shri S.K. Tyagi, Specified Officer (In-Charge), iii) Shri Prakash Chand Upadhyay, ADC & iv) Shri Mohan Veer Ruhella, ADC, were also present to assist the Approval Committee.

At the outset, the Chairman welcomed the participants. After brief introduction, each items included in the agenda were taken up for deliberation one by one. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken:-

The Approval Committee was informed that no reference against the decisions of the Approval Committee held on 02.08.2019 was received from any of the members of the Approval Committee or Trade and therefore, Minutes of the Meeting held on 02.08.2019 were ratified.

2.1. It was brought to the notice of the Approval Committee that M/s. Morneau Shepell India LLP has submitted a proposal for setting up of unit over an area of 22844 Sqft. at 11th floor, Building No.7 in the IT/ITES SEZ of M/s. Seaview Developers Private Limited at Plot No. 20 & 21, Sector-135, Noida (Uttar Pradesh) to undertake service activities i.e. 'Information Technology / Information Technology Enabled Support Services such as human resource services, research and development services, Computer software services, back-office operations, call centers, content development or animation, data processing, engineering and design, graphic information system services, insurance claim processing, legal data bases, medical transcription, payroll, remote maintenance, revenue accounting, support centers and web-site services' with projected exports of Rs.11191.84 lakhs and cumulative NFE of Rs.10705.72 lakhs over a period of five years. It was also informed that the applicant has proposed investment of Rs.242.83 lakhs towards imported capital goods; Rs.480.94 lakhs towards indigenous capital goods and the cost of project shall be met from internal accruals and



advances against services. It was further informed that applicant has submitted copy of provisional offer of space for allotment of proposed space issued by M/s. Seaview Developers Private Limited, SEZ Developer vide letter dated 10.08.2019.

2.2. It was informed that following documents / information required to be submitted which had been communicated to the applicant:-

- (i) As per LLP Agreement dt. 09.08.2019, there are two Partners namely M/s. Morneau Shepell International Ltd. and M/s. Morneau Shepell India Ltd., therefore details of Mr. Scott Milligan and Mr. Naveen Narang required to be replaced in Para IV with actual partners.
- (ii) Audited Balance Sheet for last three years of Partners Company namely M/s. Morneau Shepell International Ltd. and M/s. Morneau Shepell India Ltd. required to be submitted.
- (iii) Type of 'Camera' as proposed in list of imported goods required to be mentioned whether these are Still camera or CCTV Camera.
- (iv) Copy of IEC, if obtained, may be submitted.

2.3. Shri Yogesh Khattar, Partner of M/s. Morneau Shepell and Ms. Ritika Gupta, authorized representative (E&Y), appeared before the Approval Committee on behalf of the applicant unit and explained the proposal. Shri Yogesh Khattar informed to the Approval Committee that the group parent company M/s. Morneau Shepell Inc. is a Canadian listed company incorporated around 40 years ago and is having 5000 employees worldwide. He further informed that the M/s. Morneau Shepell India LLP is newly incorporated entity in India and M/s. Morneau Shepell Inc. Canada will provide financial support for setting up & operating the proposed SEZ unit. Their area of work is HR consulting and consultancy related with benefits / pension fund. The representative of the unit informed that they have submitted the required documents / information. The Approval Committee observed that this will be a 100% Foreign Direct Investment.

2.4. After due deliberations, the Approval Committee <u>approved</u> the proposal, subject to submission of requisite documents / information.

3.1. It was brought to the notice of the Approval Committee that M/s. R Systems International Limited has submitted a proposal for setting up its 2nd unit over an area of 30706 Sqft. (2853 Sqmt.) with 405 Seats approx. at 2nd floor, Tower-1 in the IT/ITES SEZ of M/s. Artha Infratech Pvt. Ltd. at Plot No.21, Sector- Techzone- IV, Greater Noida (U.P) to undertake service activities i.e. 'Software product development, Software product maintenance and support & Software product testing and quality assurance' with projected exports of Rs.37582.31 lakhs and cumulative NFE of Rs.32080.14 lakhs over a period of five years. It was also informed that the applicant has proposed investment of Rs.1063.30 lakhs towards imported capital goods; Rs.392.48 lakhs towards indigenous capital goods and other cost of project shall be met from retained earnings i.e. out of Internal Accruals. It was

further informed that applicant has submitted copy of Letter of Intent dt. 02.08.2019 signed by and between M/s. R Systems International Ltd. & M/s. Trustone Wegmans Developers Pvt. Ltd., Co-developer for allotment of 30706 Sqft. (2853 Sqmt.) with 405 Seats approx. at 2nd floor, Tower-1 in the said SEZ.

3.2. It was informed that In Para XI of Form-F, applicant has mentioned proposed employment generation of 78 (Men- 62, Women- 16), whereas, in supporting documents applicant has projected 394 Nos. employment generation over a period of 5 years. Hence, Para XI of Form-F needs to be corrected.

3.3. Shri Nand Sardana, CFO & Brig. V.K. Chauhan, Admn. Head appeared before the Approval Committee on behalf of the applicant unit and explained the proposal. Besides, Shri Sudeep Gupta, Director of Artha Infratech Pvt. Ltd., Developer also appeared before the Approval Committee. The representative of the applicant unit informed that M/s. R. Systems is a Indian multi-national company worth 800 Crore with profit of Rs.80 Crore, worldwide it has 3000 employees. Its headquarter is in Noida where around 1600 employees are working. He further mentioned that the instant unit proposed to be setup for development of Digital Software. They further clarified that 394 Nos. employment generation have been proposed on a period of 5 years and they have rectified the same in online Form-F.

3.4. After due deliberations, the Approval Committee <u>approved</u> the proposal.

4.2. Mr. D.K. Sharma, General Manager-Commercial, Mr. Rohit Aneja, Director-Project & Mr. Subhash Chandra, Dy. Manager appeared before the Approval Committee on behalf of the developer and explained the requirement of proposed materials.

4.3. After due deliberations, Approval Committee approved the proposed list of materials.

5.2. It was further informed that while considering the proposal for approval of list of materials of the said developer, the Approval Committee in its meeting held on 05.07.2019 had observed that the developer had proposed purchase of '500 Ltr. Tarpin Oil/Thiner/Sprit' at an estimated value of Rs.50 lakhs, price of which was on very higher side. The Approval Committee had expressed displeasure on certification of list by the Chartered Engineer in a very casual manner and directed to call for an explanation from the Chartered Engineer in this regard. The Committee had also directed to seek explanation from the developer for not exercising due diligence while preparation of list of material. Accordingly, directions of the Approval Committee had been communicated to the Developer vide this office letter dated 23.07.2019 as well as to Mr. S.P. Chauhan, Chartered Engineer vide this office letters dated 22.07.2019.

5.3. It was informed that in reply to this office letter dated 23.07.2019, the Developer vide its letter dated 23.07.2019 has apologized for such clerical mistake. The developer has informed that the estimated value of said item is Rs.50 Thousand. The developer had also assured to take care that such mistakes do not happen in future. It was informed that the explanation from the Chartered Engineer is still awaited.

5.4. Shri Mukesh Chauhan, Sr. Manager appeared before the Approval Committee on behalf of the developer and explained the requirement of proposed materials.

5.5. The Approval Committee observed that Chartered Engineer, Mr. S.P. Chauhan, who had certified the earlier list, has again certified the instant list of items. Whereas explanation sought from him as per directions of the Approval Committee, has not been submitted by the said Chartered Engineer, so far.

5.6. After due deliberations, the Approval Committee observed that this is serious issue. Approval Committee approves list of material inter-alia based on Chartered Engineer Certificate and the same has not been given due care before signing by Chartered Engineer. Therefore, the Committee decided to defer the proposal till receipt of explanation from the Chartered Engineer. The Approval Committee further directed to write a detailed letter to directors of M/s. NIIT Technologies Ltd. in the matter.

It was informed that M/s. Seaview Developers Pvt. Ltd. had been granted LOA dated 01.04.2019 for setting up of unit for "Backup Power Generation through DG Sets for supply to the SEZ Developer-36750 KVA" over an built-up area admeasuring 2985.80 Sqmt. (comprising of Basement of Building No.1: 302.30 Sqmt., Building No.4: 426.40 Sqmt., Building No.7: 930.50 Sqmt., Building No.8: 937.00 Sqmt. & Space for HSD Tanks at Ground Near Building No.3: 389.60 Sqmt.) in the Processing area of the said SEZ. It was informed that the unit has requested for addition of 631 Sqmt. built-up area at Basement of Building No. 11A (MLCP/Office Block) in processing area of SEZ. It was informed that



unit has submitted copy of provisional offer of space in respect of proposed area issued by SEZ developer vide letter dated 14.08.2019.

8.2. It was informed to the Approval Committee that Occupancy Certificate in respect of Building No. 11A (MLCP/Office Block) is not available in records.

8.3. Shri Jay Kumar & Shri Amrik Singh, both authorized representative of the unit appeared before the Approval Committee and explained the proposal. The representative of the unit informed that Building No. 11A is under construction though basement has been completed. They further stated that required pipelines / fit-outs for DG Sets required to be done during the construction process. Further, they informed that the Occupancy Certificate of this building is expected by February, 2020. The representatives of the unit assured that the actual operations from this building will be started only after receipt of Occupancy Certificate.

9.2. It was informed that the unit had stated that they had obtained 2 separate LOAs as they had planned to carry out Software Development and IT/IT Enabled Services (including technical testing and analysis services) from the first LOA and Call Centre / BPO Operations from the second LOA. However, due to decent growth in both the line of business they may not be able to segregate both the operations among these 2 LOAs.

9.3. Further, it was informed that the unit has also requested to add "Call Centre / BPO Services" under LOA No. 10/02/2018-SEZ/1712 dated 15.02.2018 of Unit-I which will be continued after merger of these two LOAs.

9.4. It was further informed that as per Proviso 4 to Rule 19(2) of SEZ Rules, 2006 (as inserted vide Notification No. GSR 909(E) dt. 19.09.2018) provides as under:-

"Provided also that the Approval Committee may approve proposals for merger of Letters of Approvals of two or more Units of the same company or firm subject to the condition that these units fall within the same Special Economic Zone and after merger, block period for calculation of Net Foreign Exchange shall be from the date of commencement of production of the Unit which commenced first and the Income Tax exemption shall be considered from the date of start of operation of the first unit.".

9.5. It was further informed that following documents / information are required from the unit:-

- (i) Unit needs to submit revised consolidated export / NFE projections, requirement of imported / indigenous capital goods & employment generation, post-merger of LOAs.
- (ii) Unit had been requested vide this office email dated 18.07.2019 to submit copy of Passport & PAN Card of Mr. Rajiv Mohan Dhand (newly appointed Director) along with CA certificate details of changes in shareholding pattern of the company, if any. However, reply from the unit is awaited.

9.6. Shri Ashish Jain, Director & Shri Chetan Gupta, Asstt. Manager appeared before the Approval Committee and explained the proposal. The representative of the unit informed that they have

submitted combined projections post merger of LOAs. Documents related to newly appointed director shall be submitted soon, and requisite BLUT shall also be executed in time.

9.7. After due deliberations, the Approval Committee <u>approved</u> the proposal for merger of LOA No. 10/24/2018-SEZ/5232 dated 16.05.2018 of Unit-II into 10/02/2018-SEZ/1712 dated 15.02.2018 of Unit-I, in terms of Proviso 4 to Rule 19(2) of SEZ Rules, 2006, as well as inclusion of "Call Centre / BPO Services" in merged LOA, subject to the condition that block period for calculation of Net Foreign Exchange and Income Tax exemption shall be considered from the date of commencement of operation of Unit-I i.e. w.e.f. 24.12.2018.

10.1. It was brought to the notice of the Approval Committee that M/s. Metlife Global Operations Support Center Pvt. Ltd. (Unit-II) had submitted a proposal for approval of following 07 Nos. additional service, in addition to the default services, to carry on authorized operations in the IT/ITES SEZ of M/s. Seaview Developers Pvt. Ltd. at Plot No. 20 & 21, Sector-135, Noida (U.P.):-

- i) Business Auxiliary Services.
- ii) Foreign Exchange Broking Services

10.2. Ms. Neha Garg, Director & Ms. Neha Rai appeared before the Approval Committee on behalf of the unit and explained the requirement of proposed additional services.

10.3. The Approval Committee discussed the proposed additional services one-by-one and after due deliberations, <u>approved</u> the following additional services:-

- (i) <u>Business Auxiliary Services</u> Exclusively for works related to authorized operations carried out within the SEZ.
- (ii) <u>Health & Fitness services & Health Check-up & treatment services</u> Exclusively for health checkup of employees of SEZ unit carried out within the SEZ only.
- (iii) <u>Insurance agent services</u> Specifically for services rendered in respect of assets of the unit within SEZ.
- (iv) <u>Photography Services & Video production agency's services</u> Exclusively for business development activities carried out within the SEZ only.
- (v) Real estate agent's services Exclusively for renting of space within the SEZ.



(vi) <u>Event management services</u> – Exclusively for the event related to the authorized operations to be organized within the SEZ only.

10.4. On specified request of the representative of the unit, the Approval Committee also approved Management or Business Consultants Services, subject to the condition that exemption for "Management and business consultant services" would be limited to the extent of such value of services availed of/ consumed by the SEZ entity only. Further, the unit shall produce evidence to that effect, to the satisfaction of the authorities concerned, that the said service was consumed by the SEZ unit in relation to their authorized operations only. Besides, proposed additional service viz. Foreign Exchange Broking Services, has not been approved by the Approval Committee.

11.1. It was brought to the notice of the Approval Committee that M/s. Arshiya Logistics Services Limited had submitted a request to grant permission for cutting activities in its aforesaid FTWZ Unit located in the Free Trade and Warehousing Zone of M/s. Arshiya Northern FTWZ Ltd. at Village-Ibrahimpur, Junaidpur urf Maujpur, Khurja Distt- Bulandshahr (U.P.). It was informed that the unit had stated that one of its foreign client namely M/s. ZTE Corporation, Shenzhen, China importing the Cables in bigger or zambo rolls and they have to supply these cables to their end customers in a smaller size cable after cutting & re-packing. It was informed that the unit had enclosed copy of letter dated 16.08.2019 of M/s. ZTE Corporation addressed to DC, NSEZ.

11.2. Shri Pramod Chhoker, Sr. Manager on behalf of unit and Shri Hanif Tole, General Manager of ZTE Corporation appeared before the Approval Committee and explained their proposal. The representative of ZTE Corporation informed that they have warehoused many imported consignment items for Telecom Equipment consisting of cables in big rolls and as per requirement of its DTA customers in telecom sector like Airtel, Vodafone, DMRC etc. they need to cut these cables in a smaller size for re-packing before dispatch. He further informed that there will be no change in HS Code even after cutting of cables in smaller size.

11.3. The Approval Committee observed that as per Para VI of Instruction No. 49 dated 10.03.2010 issued by DOC, "Requests for allowing cutting, polishing, blending etc. as part of authorised operation of a FTWZ unit can be considered by the Approval Committee on a case to case basis based on the merits of the case".

13.3. Shri Pramod Chhoker, Sr. Manager appeared before the Approval Committee on behalf of FTWZ Developer and informed that Lease Agreement in respect of Siddharth Logistics Co. Pvt. Ltd. is under process and they will submit the same within a week.

13.4. After due deliberations, the Approval Committee <u>took note of</u> the submission of registered lease deed by above FTWZ units. The Approval Committee directed the representative of the developer to ensure submission of registered lease deed by remaining operating units.

14.1. It was brought to the notice of the Approval Committee M/s. HCL Technologies Ltd. has submitted a proposal for setting up of unit over an area of 92581 Sq.ft. i.e. (8601.05 Sq mt.) at 4th and 5th Floor, Building-1, Wing A & B in the IT/ITES SEZ of M/s Golden Tower Infratech Pvt. Ltd, at Plot No 8, Sector 144, Noida (Uttar Pradesh) to undertake service activities i.e. *'IT/ITES namely Computer Software Services, Including Information Enabled Services Such As Back-Office Operations, Call Centres, Content Development Or Animation, Data Processing, Engineering and Design, Graphic Information System Services, Human Resources Services, Insurance Claim Processing, Legal Data Bases, Medical Transcription, Payroll, Remote Maintenance, Revenue Accounting, Support Centres and Web-Site Services, Off-Shore Banking Services' with projected exports of Rs. 142788.75 lakhs and cumulative NFE of Rs.140082.05 lakhs over a period of five years. It was also informed that the applicant has proposed investment of Rs.10232.69 lakhs towards imported capital goods; Rs.2460.62 lakhs towards indigenous capital goods and the cost of project shall be met from Reserves & Surplus of the company. It was further informed that applicant has submitted copy of*

provisional offer of space for allotment vide letter dated 27.08.2019 issued by M/s. Golden Tower Infratech Private Limited, SEZ Developer.

4.2. Mr. D.K. Sharma, General Manager-Commercial, Mr. Rohit Aneja, Director-Project & Mr. Subhash Chandra, Dy. Manager appeared before the Approval Committee on behalf of the applicant and explained the proposal.

14.3. After due deliberations, the Approval Committee approved the proposal.

15.1. It was brought to the notice of the Approval Committee that M/s. SPI Technologies India Pvt. Ltd. had been granted LOA No. 10/05/2018-SEZ/2171 dated 26.02.2018 for setting up of unit in the IT/ITES SEZ of M/s. Seaview Developers Pvt. Ltd., Plot No. 20 & 21, Sector-135, Noida (Uttar Pradesh). Thereafter, the Approval Committee in its meeting held on 01.02.2018 had approved the proposal of the unit for change of entrepreneur from M/s. SPi Technologies India Pvt. Ltd. to **M/s.** Lambda Content India Pvt. Ltd. pursuant to scheme of amalgamation approved by the NCLT vide Order dated 23.10.2018. It was further informed that the initial LOA of the unit was valid upto 25.02.2019, however, unit neither submitted intimation for commencement of operation nor applied for extension of LOA.

It was informed that the unit vide its letter dated Nil received on 23.05.2019 again submitted a 15.2 proposal for change of name of the company from 'M/s. Lambda Content India Pvt. Ltd.' to 'SPi Technologies India Private Limited'. It was informed that since, the LOA of the unit was already lapsed on 25.02.2019, hence unit had been requested vide this office on 15.03.2019 to first submit online application for LOA extension giving reasons for non-submission of application for LOA extension before its expiry along with requisite documents for change of name of the company. It was further informed that the unit vide its letter dated 25.06.2019 submitted copy of Commercial Invoice dated 21.06.2019 as proof of commencement of operation and also submitted the online request for LOA extension. Further, it was informed that unit vide its email dated 01.08.2019 had stated that though the commercial production was commenced on 01.08.2018 i.e. within the LOA validity period, but the project extended for a period of 10 month until June 2019 for completion. Besides unit had stated that their company was undergone restructuring process by way of merger in Feb 2019, hence they inadvertently overlooked the validity of the LOA which was lapsed on 25.02.2019. Unit had further mentioned that without realizing the fact that their LOA is not valid, they raised the first invoice to the client in June, 2019. It was informed that the unit has stated that it was completely oversight

from their end and not intentional and the Unit has requested to consider the above facts and condone the delay in seeking LOA extension.

15.3. It was informed that Specified Officer vide his letter dated 22.08.2019 has informed that the unit site was visited by the Authorised Officer in-charge on 21.09.2019 and he has submitted the following observations:-

- (i) The unit was asked to submit copy of Date of Commencement letter submitted to DC office and file MPR w.e.f. March 2019 but the Unit has not filed any MPR till date.
- (ii) W.e.f. 26.02.2019 i.e. post-expiry of LOA, no Custom duty/ IGST exemption on goods has been allowed by this office under Rule 27; nor any input service Invoices have been countersigned/endorsed.
- (iii) as per information provided by the Unit, they have made sale of IT/ITES exports of USD 5693.54 till date (which was actually made under one Invoice in June 2019 after expiry of LOA).
 No information in this regard was furnished to this office earlier.
- (iv) The unit was having Capital goods viz. Desktops, Laptops, Servers, Networking and Electrical equipment etc. and approximately 150 nos. of manpower at the time of visit by the Authorized Officer.
- (v) It was also observed that the unit is having a small Cafeteria within its premises.
- (vi) In view of the expiry of LOA dated 26.02.2018, no BLUT has been executed by M/s. Lambda Content India Pvt. Ltd. (change in name of Unit after approval by DC office) as per letter F. No. 2448 dated 26.02.2019 issued by this office.

15.4. It was further informed that with regard to proposal for change of name of the company from 'M/s. Lambda Content India Pvt. Ltd." to "M/s. SPi Technologies India Pvt. Ltd.", the unit has submitted following documents :-

- (i) Certificate of Incorporation pursuant to change of name of the company Lambda Content India Private Limited to SPI Technologies India Private Limited issued by ROC, Pondicheri on 10.04.2019.
- (ii) Copy of M&AOA and e-PAN Card No. AADCL3320N in the name of M/s. SPI Technologies India Private Limited.
- (iii) Copy of CA certified details of shareholding pattern of M/s. Lambda Content India Pvt. Ltd., as on 31.03.2018, as given below:-

15.5. Further, it was informed that following documents also required to be submitted by the unit:-

- (i) An Undertaking on Rs. 100/- non-judicial stamp paper from SPI Technologies India Pvt. Ltd. to the effect that upon the change of name of company from Lambda Content India Pvt. Ltd. to SPI Technologies India Pvt. Ltd., all the assets & liabilities in respect of Lambda Content India Pvt. Ltd. under LOA No. 10/05/2018-SEZ/2171 dated 26.02.2018 have been taken over by M/s. SPi Technologies India Pvt. Ltd.
- (ii) A Copy of revised IEC Certificate incorporating SEZ name in unit address.

15.6. Shri Ezhil Arasan Kuppusamy, Director appeared before the Approval Committee and explained the matter in detail. He informed that the unit had commenced operation on 01.08.2018 i.e. within the LOA validity period, but the project extended for a period of 10 month until June 2019 for completion. He further mentioned that the company had undergone restructuring process by way of merger in Feb 2019, hence they inadvertently overlooked the validity of the LOA which lapsed on 25.02.2019. He further stated that without realizing the fact that their LOA is not valid, inadvertently they raised the first invoice to the client in June, 2019, which was completely oversight from their end and not intentional. The representative of the unit requested to consider the above facts and condone the delay in seeking LOA extension. As regards, request for change of name, the representative of the unit informed that as per conditions of the order dated 23.10.2018 passed by NCLT, they have to continue with the name of SPi Technologies India Pvt. Ltd.

15.7. After due deliberations, the Approval Committee <u>decided to extend</u> the validity of LOA upto 21.06.2019 i.e. date of issuance of first commercial invoice by the unit, subject to the condition that the Block period of 5 years shall be calculated from 21.06.2019 to 20.06.2024. The Approval Committee also <u>approved</u> the proposal for change of name of the unit from M/s. Lambda Content India Pvt. Ltd. to M/s. SPi Technologies India Pvt. Ltd., in terms of Instruction No. 89 dated 17.05.2018 & subsequent clarification issued vide Instruction No. 90 dated 03.08.2018 issued by DOC, subject to submission of required documents.
