

❖ At the outset, the Chairman welcomed the participants. After brief introduction, each items included in the agenda were taken up for deliberation one by one. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the developers / units, the following decisions were taken:-

The Approval Committee was informed that no reference against the decisions of the Approval Committee held on 01.11.2019 was received from any of the members of the Approval Committee or Trade and therefore, Minutes of the Meeting held on 01.11.2019 were ratified.

2.1. It was brought to the notice of the Approval Committee that M/s. HCL Technologies Ltd., Developer of IT/ITES SEZ at Plot No. 3A, 3B & 2C, Sector- 126, Noida (U.P) had submitted proposal for approval of list of materials to carry on following default authorized operations in their SEZ:-

2.2. It was informed that the developer has proposed various types of 'Signage' at Sl. No. 592 to 630' under the authorized operation namely "Construction of all types of building in Processing area as approved by UAC' (Annexure-II), whereas a separate authorized operation namely "Roads with Street lighting, Signals and **Signage**" is available in the list of default authorized operations issued by DOC vide Instruction No. 50 dated 15.03.2010.

2.3. Mr. D.K. Sharma, Associate Director, Mr. Jyotirmay Mishra, Head- India Litigation & Mr. Shankey Agrawal, Pri. Associate of M/s. HCL Technologies Ltd. appeared before the Approval Committee and explained the requirement of proposed materials.

2.4. After due deliberations, Approval Committee approved the proposed list of materials, subject to submission of revised Chartered Engineer's Certificate and list of materials indicating 'Signage' under authorized operation 'Roads with Street lighting, Signals and Signage'.

3.1. It was informed to the Approval Committee that M/s. HCL Technologies Ltd. (Unit-I) had submitted representation on coverage of 'Group Health and Medical Insurance' of its employees, under the authorised operations of its unit located in the IT/ITES SEZ of M/s. HCL Technologies Ltd. at Plot No. 3A, 3B & 2C, Sector-126, Noida (U.P), as well as coverage under the default service namely 'General Insurance Business Services'. It was informed that "Group Health and Medical Insurance" is not part of default list of services and unit had sought clarification on its coverage under "General Insurance Business Services" which is available at Sl. No. 26 of uniform list of services issued by DOC vide Instruction No. 79 dated 19.11.2013. It has been submitted by the unit that none of the 'Group Health and Medical Insurance' received by them are in nature of life insurance services. In the following table, they have summarised the list of all these services received by them during the GST regime:-

3.2. It was further informed that the unit had referred Rule 27(2) of SEZ Rules, 2006, which provides that *'In case of any doubt as to whether any goods or **services** are required by a Unit or Developer for authorized operations or not, it shall be decided by the Development Commissioner.'* Further, in terms of Proviso to Rule 27(3) of SEZ Rules, 2006, *"Provided further that any **goods** for the personal use of, or consumption by officials, workman, staff, owners or any other person in relation to a Unit or Developer, shall not be eligible for exemption, drawback and concessions or any other benefit in accordance with the provisions of Section 7 or 26."*

3.3. It was informed that the unit has requested to (i) whether the 'Group Health and Medical Insurance' received by the unit, are covered within the default authorised services issued by DOC under the title "General Insurance Business Services" for the purpose of SEZ Act, and (ii) whether they are entitled to SEZ law benefits thereon.

3.4. Mr. D.K. Sharma, Associate Director, Mr. Jyotirmay Mishra, Head- India Litigation & Mr. Shankey Agrawal, Pri. Associate of M/s. HCL Technologies Ltd. appeared before the Approval Committee. The representatives of the unit informed that in general, a group or corporate health insurance policy is purchased by an employer for employees of company. By insuring the health and medical needs of the employees, the company inter alia ensure productivity in their operations by keeping their employees healthy. This is besides the other legal and moral obligations on their part as employer. Accordingly, they have requested to consider "Group Health and Medical Insurance (which are not in the nature of life insurance services)" as part of authorised operation only.

3.5. The Approval Committee observed that exemption available to the SEZ Units is only on the input services related to authorised operations of the unit. The Group Insurance of employees is related to individuals and not related to authorised operations of the SEZ unit. The actual beneficiary of said service is an individual. The Committee also observed that Income earned by an unit on account of export is exempted from payment of Income Tax, whereas individual employees are not given the benefit of Income Tax exemption.

3.6. After due deliberations, the Approval Committee clarified that the 'Group Health and Medical Insurance' of its employees is not related to the authorised operations of the SEZ unit, hence not covered under default authorised services namely "General Insurance Business Services". Further, Approval Committee directed that a reference may be sent to DOC informing them about the request of the unit and about the observation of the Approval Committee.

5.3. Shri Jay Kumar and Shri Amrik Singh both authorized representative of M/s. Seaview Developers Private Ltd. appeared before the Approval Committee and explained the proposal.

5.4. After due deliberations, Approval Committee approved the proposal for allotment of space to M/s. Godfrey Phillips India Ltd. to setup & operate 'Utility Store' under the category of 'Shopping Arcade / Retail Space' approved by BoA, subject to the condition that no tax / duty benefit shall be available to M/s. Godfrey Phillips India Ltd. to setup, operate & maintain such facility in the processing area of the SEZ and this facility shall be exclusively for the employees of SEZ & units located therein.

6.1. It was brought to the notice of the Approval Committee that M/s. Seaview Developers Private Ltd., Developer had submitted proposal for allotment of built-up space of 80 Sqft. Ground floor Lobby, Building No.6(40 Sqft) in the processing area of IT/ITES SEZ at Plot No. 20 & 21, Sector-135, Noida (U.P.) on lease to M/s. Euronet Services India Pvt. Ltd. for setup & operate 02 Nos. 'ATM Machine' of HDFC Bank Ltd., under the category of 'Shopping Arcade and / or Retail space' approved by BoA.

6.4. The Approval Committee clarified that the developer may allot space for Bank ATM under the provision of Rule 11(5) of SEZ Rules, 2006.

6.5. After due deliberations, Approval Committee approved the proposal for allotment of space to M/s. Euronet Services India Pvt. Ltd. for setup & operate 02 Nos. 7.2. It was informed that at present the proposed additional area i.e. 5705 sqft. at 6th floor, Building No.9 is in possession of their another SEZ unit namely M/s. NEC Technologies India Pvt. Ltd. (Unit-I). The said Unit-I has submitted its proposal for exit from SEZ scheme and their area is proposed to be taken over by Unit-II. It was further informed that the developer has given provisional offer of space dated 19.11.2019 for allotment of 5705 Sqft. at 6th floor, Building No.9 to M/s. NEC Technologies India Pvt. Ltd.(Unit-II), subject to the condition that M/s. NEC Technologies India Pvt. Ltd. (Unit-I) shall obtain necessary approval for surrender of aforesaid premises.

The Approval Committee observed that proposed activity i.e. 'Gift Gallery' is purely in commercial in nature and does not fall under employees welfare facilities, hence it can be setup only in the Non-Processing Area of SEZ. Approval Committee can approve only those activities which come within ambit of Rule 11(5) of SEZ Rules. Hence, the proposal of the developer was not approved by the Approval Committee.

9.5. After due deliberations, the Approval Committee rejected the proposal.





11.2. It was informed that M/s. 



14.4. It was informed that the unit had not provided background of its proposed clients in respect of items mentioned at Para 14.3 above.





15.2. Shri Sanjeev Kumar Jain, Proprietor of M/s. Vardhman Custom Clearing and Forwarding Agents along with representative of its client Shri Amit Bhardwaj, G.M-F&I of M/s. Sanchar Telesystems Ltd. appeared before the Approval Committee and explained that proposal.

15.3. The Approval Committee observed that some of the items proposed under Exim Code 2207, are 'Restricted' for import.

15.4. After due deliberations, the Approval Committee approved the above items (excluding Exim Code 2207) proposed by the unit, subject to following terms & conditions:-

- (i). The scope of authorized operations of the unit will be strictly as per Rule 18(5) of SEZ Rules, 2006.
- (ii). No export / import of any items will be allowed, which comes under Prohibited/Restricted items/Negative list under Import policy given in ITC(HS) Classification or any other law and/or covered under SCOMET list as per DGFT Notifications / Public Notice / Instructions issued from time-to-time.
- (iii). Port restrictions as per DGFT Notifications / Public Notice / Instructions issued from time-to-time, shall be applicable.
- (iv). Any sale in DTA shall be only in convertible foreign currency in terms of proviso to Rule 18(5) of SEZ Rules, 2006.

16. **Request of M/s. HCL Technologies Limited for approval of exemption from duty on Error and Omission Policy (E&O Policy) under General Insurance Business Services listed at Sl. No. 26 of Uniform List of Services for their all SEZ Units under the Jurisdiction of DC, NSEZ.**

16.1. It was brought to the notice of the Approval Committee that M/s. HCL Technologies Ltd. had informed that they are in the process of obtaining an Error and Omission Policy ('E&O Policy') Service for their all SEZ Units under the Jurisdiction of DC, NSEZ, Noida. It was informed that in justification of their proposal, M/s. HCL Technologies Ltd. had mentioned that the said policy would protect the company against the following risks;

- Any actual or alleged negligent acts, error or omission
- Unintentional infringement of copyright, or trademark
- Network security liability/Breach of privacy
- Cyber Extortion
- Legal expenses for defense

Further, M/s. HCL Technologies Ltd. had mentioned that the said policy also protects the company against any willful breach of contract, damages or against any third-party claims preventing any commercial loss and thereby maximizing the efficiency and profitability of the SEZ Unit.

16.2. It was informed that based on the following grounds, the company has sought approval for availing exemption on Error and Omission Policy (E&O Policy) under General Insurance Business Services listed at Sl. No. 26 of Uniform List of Services for their all SEZ Units under the Jurisdiction of DC, NSEZ, Noida:-

- The said policy is in the nature of "General Insurance" policy.
- General insurance is covered within the list of "default authorized services" at Sr. No. 26 i.e. 'General Insurance Business Service'.
- While the term "General issuance" or 'General Insurance Business Service' is not defined in SEZ Act or SEZ Rules. However, the term 'general insurance' is defined in Insurance Statutes including General Insurance Business (Nationalization) Act, 1972 ('Act of 1972') and Insurance Act, 1938.
- As per the said Acts, the term General Insurance covers everything other than "life insurance". Thus, E&O Policy is clearly not in the nature of Life Insurance.
- Accordingly, E&O Insurance Policy would be covered within General Insurance Business and qualify as a "default authorized services".




16.3. The proposal was discussed by the Approval Committee in detail and after due deliberations the Approval Committee observed that 'Error and Omission Policy (E&O Policy) service' is related to the authorised operations of the unit and covered under 'General Insurance Business Services' listed at Sl. No. 26 of uniform list of services issued by DOC vide Instruction No. 79 dated 19.11.2013.
