2. **M/s. Seaview Developers Ltd., IT/ITES SEZ at Sector- 135, Noida**

(i). Proposal of the developer, M/s. Seaview Developers Ltd. for approval of list of materials.

After due deliberations, UAC approved the lists of materials / HSD (As per Annexure-A) proposed by the developer, M/s. Seaview Developers Ltd., for a period of six months, to carry on following default authorized operations in the IT/ITES SEZ at Plot No. 20 & 21, Sector-135, Noida: -

After due deliberations, UAC approved the expansion of area as well as revised projections, subject to execution of revised Bond-cum-LUT and submission of revised APRs & other documents as called by O/o. DC, NSEZ vide letter dated 16.06.2014.

3. M/s. Aachvis Softech Pvt. Ltd., IT/ITES SEZ at Sector- 144, Noida.

- (i) Proposal of the co-developer, M/s. Aachvis IT SEZ Infra Pvt. Ltd. to allot space to M/s. EHBH Services Pvt. Ltd. to setup & operate a 'Food Court' in the processing area of SEZ.

The proposal of the co-developer, M/s. Aachvis IT SEZ Infra Pvt. Ltd. to allot space approx. 20964 Sqft. to M/s. EHBH Services Pvt. Ltd. to setup & operate a 'Food Court' at Ground floor, Tower-A in the processing area of IT/ITES SEZ of M/s. Aachvis Softech Pvt. Ltd. at Plot No. 7, Sector-144, Noida was placed before the UAC. After due deliberations, UAC approved the proposal subject to condition that no duty / tax including service tax exemptions shall be available to M/s. EHBH Services Pvt. Ltd. to create & operate such facility in the processing area of the SEZ. This facility shall be used exclusively by the employees of SEZ.

- (ii) Proposal of M/s. Sapient Consulting Ltd. for enhancement in the value of imported capital goods and revised projection.

The proposal of M/s. Sapient Consulting Ltd. for enhancement in the value of imported capital goods & revised projection of the unit located in the IT/ITES SEZ of M/s. Aachvis Softech Pvt. Ltd. at Plot No. 7, Sector-144, Noida was placed before UAC. It was brought to the notice of UAC that the unit has imported capital goods of Rs.2008.04 lacs against the approved limit of Rs.1771.82 lacs. Besides, the unit has also shifted old CG from DTA more than the prescribed limit of 20% eligible for IT exemption. The representative of the unit could not explain the reasons for imports in excess of approved CG limits before UAC. Accordingly, UAC decided to issue Show Cause Notice to the unit.

- (iii) Proposal of M/s. Dell International Ltd. for part de-bonding of the unit located in Aachvis Softech Pvt. Ltd. SEZ, Noida.

After due deliberations, UAC approved the part de-bonding of premises i.e. 56588 Sqft. area at 2nd floor & part of 3rd floor, Tower-E of the IT/ITES of M/s. Aachvis Softech Pvt. Ltd. at Plot No. 7, Sector-144, Noida subject to execution of Bond-cum-LUT by the unit for remaining area.

- (iv) Proposal of M/s. Newgen Software Technologies Ltd. for expansion of area as well as revised projections.

The proposal of M/s. Newgen Software Technologies Ltd. for expansion of area and revised projections of the unit located in the IT/ITES SEZ of M/s. Aachvis Softech Pvt. Ltd. at Plot No.7, Sector-144, Noida was placed before UAC. After due deliberations, UAC directed the developer to reconcile the proposals & submit a consolidated list of materials for consideration. UAC empowered DC to decide the list of materials after receiving of a reconciled proposal from the developer.

5. M/s. Artha Infratech Pvt. Ltd., IT/ITES SEZ at Greater Noida.

- (i). Proposal of M/s. Inmacs Management Services Ltd. for setting up its unit in IT/ITES SEZ of M/s. Artha Infratech Pvt. Ltd. at Gr. Noida.

The proposal of M/s. Inmacs Management Services Ltd. for setting up of unit over an builtup area of 250 sq. ft. at Unit No. GF/001 in Tower No.2 of IT/ITES SEZ of M/s. Artha Infratech Pvt. Ltd. at Plot No. 21, Techzone-IV, Greater Noida was placed before UAC. Projected FOB value of exports has been shown as Rs.651.72 Lacs with NFE earnings of Rs. 651.72 Lacs over a period of five years. After due deliberations, UAC approved the project.
