Minutes of 3rd Meeting (2016 Series) of Unit Approval Committee for EOU Scheme held under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, NSEZ, Noida on 08.06.2016 at 11.00 AM at NSEZ, Noida.

3rd meeting (2016 Series) of Unit Approval Committee for EOU scheme (UAC) was held on 08.06.2016 under the Chairmanship of Dr. L.B. Singhal, Development Commissioner, Noida SEZ.

The following members of the Unit Approval Committee were present in the meeting:

Besides during the meeting of UAC, Smt. Mala Rangarajan, DDC, Shri Ram Baboo, ADC & Shri Subodh Kumar Jha, ADC were also present to assist the UAC.

2. The Chairman welcomed all participants of the UAC and thereafter agenda was taken up for discussion.

3.0(16) Confirmation of minutes of 2nd meeting (2016 series) of the UAC held on 13.04.2016.

The Committee ratified the Minutes of the 2nd UAC meeting (2016 Series).

3.1(16) Proposal for addition of accessories of finished products in LOP by M/s Groz Engineering Tools (P) Ltd., Village-Kherki Daula, National Highway-8, Gurgaon-122001, Haryana.

The Committee deliberated and noted that the items proposed for broad banding provided linkage to existing line of manufacture and that the FOB value of exports of the unit for the period 2014-15 is Rs. 239.79 crore and the estimated turnover of the proposed items would be around Rs. 3.00 crore, which is less than 1% of the FOB value of manufactured items. Hence, the Committee approved the proposal subject to the condition that provisions of paragraph 6.8, 6.9, 6.10, 6.13, 6.14 of FTP and 6.29 (a), (b), (c) & (d) shall not apply to the proposed activity.

The Committee deliberated the proposal and noted that the unit is engaged in manufacturing of Wrist bands, Tamper Evident Seals Labels, tags, tickets for amusement industry, thermal tickets, redemption tickets, RFID labels etc. and for this purpose they have developed a unique machinery system as per their custom made design.

The Committee also noted that the unit would be using existing machinery for printing and additional machinery would be used for magnetic lamination, chip engraving and embedding. Since, the activity proposed provides forward linkage to the existing line of manufacture, the Committee approved the proposal.
