5. If weighbridge is not operational for more than 48 hrs penalty of Rs. 3000/- per day shall be imposed.
  6. Contractor shall charge Rs. 50/- up to 10 ton , Rs 100/- up to 15 ton Rs. 150/- up to 20 ton and Rs. 200/- beyond 20 ton per truck/container for weighing and will not charge any other fee and will not enhance any charge without approval of Chairman & CEO, NSEZA.
  7. Weighing details shall be provided to Zone authorities as & when required or demanded.
  8. Contractor shall deposit contract money as accepted by CEO up to 10<sup>th</sup> of every month through challan in SBI/Canara Bank, NSEZ & submit a copy to the Estate Section of this office failing which interest@ 12% per annum shall be charged by the Authority.
  9. Room no. 2 near machine room has not been included for allotment.
  10. Tender not accompanied with required Earnest Money in the prescribed manner shall be rejected outright.
  11. The contractor or his employee deployed in the NSEZ shall not cause any nuisance/inconvenience of whatsoever nature resulting in disturbance/inconvenience to allottees/workers of units/ visitors. The contractor shall be liable for such action on the part of his employees deployed in the NSEZ.
  12. It shall be the sole liability of the Contractor (Including the contracting firm/company) to obtain and to abide by all necessary licenses/permissions from the concerned authorities as provided under various labour legislations including the labour license required under provisions of the contract labour (Regulation and Abolition) Act 1970.
  13. The contractor shall discharge obligations as provided under various applicable statutes including the Employees State Insurance (ESI) Act, 1948, the Contract Labour (Regulation of Employment & Conditions of Service) Act, 1979, the Minimum Wages Act 1948, the Payment of Wages Act, 1936, the workmen's Compensation Act. 1923 and other relevant Acts, Rules and Regulations enforced from time to time.
  14. The contract shall be initially for one year **extendable for a further period** at the discretion of CEO, NSEZA after evaluation of the services rendered and such extension shall be binding on the contractor. Notice of intention for extending the contract will however, be given 30 days before expiry of the contract.

16. The successful bidder shall deposit Security Money of Rs. Two lacs in the form of Demand Draft in favour of NSEZ Authority. Security deposits will be forfeited in case of termination of contract due to poor performance by the contractor.
17. The details given in the terms & conditions of contract are tentative only and not exhaustive. NSEZ will issue further necessary details as per requirement during executions from time to time and the work will be done in accordance therewith.
18. The contractor's staff shall abide by the existing security rules/regulations/precautions as per instructions given from time to time. NSEZ is a Customs bonded area and entry and exit would be from the main gate only. Goods and vehicle coming in and going out of NSEZ shall be liable for checking by NSEZ Security/Customs staff.
19. **Penalty Clause:** In case of any misconduct due to any reason attributable to the contractor, a penalty as decided by the CEO will be imposed which will be binding.
20. No equipment machinery or transport shall be provided by the NSEZ. However, expenditure on new equipment/capital goods shall be borne by NSEZA as per decision of NSEZA.
21. Contractor shall provide his/her residential/identity proof & copy of PAN number with the tender.
22. The Earnest Money of the successful bidder (hereinafter called the contractor) will be forfeited in case the bidder declines to sign the agreement or fails to deposit Security Money within 10 days of being called upon to do so.
23. NSEZ Authority reserves the right to reject any or all the tender(s) received or to allot the work to one or more contractor(s) without assigning any reason thereof.
