'NOTICE INVITING 'EXPRESSION OF INTEREST'

Sub:-Engagement of a legal firm on retainership basis by Noida Special Economic Zone, Authority, Noida-reg.

Noida SEZ Authority invites online "Quotation (Monthly Charges)" from experienced and registered legal firms for engagement on retainership basis. The quotation should reach to this office on or before **09.02.2018 up to 3.00 P.M.**

2. Scope of work:-

- (i) The firm shall provide necessary legal services of all nature as and when sought during the course of business of NSEZ.
- (ii) The services to be performed by the firm shall comprise of general and commercial advice, legal opinion and advice rendered to the Authority including review of all relevant agreements, documents, preparing Affidavits.
- (iii) The firm shall go through the files of NSEZ Authority and shall ensure saving of interest of the Authority.
- (iv) To visit and participate in meetings/ conferences with NSEZ representatives and render legal advice/opinion(s) on documents executed and other legal formalities entered into by NSEZ during the period of retainership.
- (v) To peruse all legal documents furnished by lessee(s) for execution of lease documents and legal compliance pertaining to the various formalities associated with such lease agreements and other affairs of NSEZ.

3. Eligibility Criteria:

- (i) Law firm registered with Government approved agency like law Council.
- (ii) Five years' experience in matters related to Land issues, DRI, BIFR, AAIFR, Labour, Foreign Trade Policy or SEZ Act/Rules etc.
- (iii) Having established network and offices in Delhi/NCR. (Signed and scanned copy of evidence to be furnished).
- (iv) Completed operation for a minimum of 15 (fifteen) years since its inception in rendering legal services. (Signed and scanned copy of evidence to be furnished)
- (v) Should be on the panel of at least 2 (two) PSU/Central Government/Statutory Body/Autonomous Organization/Sub-ordinate/attached offices of Central Government. In support of this, firm shall submit signed and scanned copy of

4. Conditions

- (i) The firm shall hold all information concerning the business in confidence and shall not disclose without prior consent of the CEO of Authority/DC, NSEZ.
- (ii) Representative of firm shall visit Noida SEZ office once in a week compulsorily and as when required for perusal of files, preparing legal opinion, counter affidavits, suits etc. for which NSEZ Authority shall pay monthly retainer ship.

5. Parameters for selection of legal firm

- (i) Experience and legal abilities including credentials and back ground of the partners/lawyers.
- (ii) Fulfillment of all conditions mentioned in the tender
- (iii) Fulfillment of other eligibility criteria mentioned in the Tender.
- (iv) Willingness to sit in NSEZ twice in a week
- (v) Registration with various Courts.

6. Other Terms & Conditions:-

- (i) The selected Law Firm shall enter into an Agreement with NSEZ. The contract shall be initially for one year **extendable** at the same rate, terms & conditions, at the discretion of CEO, NSEZA.
- (ii) The retainership charges will be paid on monthly basis subject to condition that assigned work is performed satisfactorily.
- (iii) All the information/details to be supported by authentic documents duly certified by the authorized signatory.
- (iv) CEO, NSEZ Authority reserves the right to reject any or all Bids without assigning any reason thereof as well as the right to add/delete/modify any one or more of the terms and conditions.
- (v) CEO, NSEZ Authority reserves the right to discontinue the services of the appointed Law Firm(s) at any point of time without assigning any reason or non-satisfactory performance by the Law Firm(s).

8. Opening of Online EOI Responses:-

The online EOI responses will be opened at 04:00 PM on 09.02.2018. Representative of law firm may be present at the venue on the date and time of opening of online responses. The EOI without EMD would be rejected.

9. Submission of Bids:-

- (i) Bidder should log into the NSEZ website www.nsez.gov.in well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- (ii) The bidder has to upload the required bid documents one by one as indicated in the tender document.
- (iii) Bidder should pay/submit the EMD as per the instructions specified in the tender document at S. No. 7.
- (iv) Bidders are requested to note that they should necessarily submit their financial bids online only and in the format available there.
- (v) Once the details have been completed, the bidder should save it and submit it online, without changing the filename.
- (vi) The server time which is displayed on the bidders' "dashboard" will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
