**VACANCY CIRCULAR**

Applications are invited from willing and eligible candidates for filling up the following posts, on deputation basis, in State Govt. Special Economic Zone(s) at Moradabad (SEZ Developer : UPSIDA) and Jaipur (SEZ Developer : RIICO) under the jurisdiction of Development Commissioner, NSEZ, Noida. The description of the post(s) and eligibility conditions are as follows:-

2. The application with bio-data of the eligible and willing officer(s), in the Annexure- I, who could be relieved in the event of selection, may please be forwarded by parent department through proper channel to the Development Commissioner at the above mentioned address on or before 45 (forty five) days from the date of publication of the vacancy advertisement in the Employment News, along with the following documents:-

- a. A certified copy of complete and up-to-date confidential reports and APAR Gradations for the last five years;

- b. Vigilance clearance and Integrity Certificate;
- c. Details of minor or major penalties imposed, if any; during the last 10 years. If no penalties have been imposed, it should be so stated.
3. The bio-data duly supported by documents will be assessed by the Selection Committee while selecting candidates for appointment to the concerned post(s) on deputation basis.
4. The Application received after the last date or without the confidential reports and other necessary documents or otherwise found incomplete will not be considered. Besides, Advance Applications even if received before the last date shall also not be entertained.
5. Those applicants whose applications were received in this office earlier, through proper channel, against the vacancy advertisement published in the Employment News dated 10.07.2021 (for ADC in SEZ Jaipur) and 25.09.2021 (for ADC in SEZ Moradabad) need not to apply afresh. However, (i) updated Vigilance Clearance, (ii) updated APARs, and (iii) updated status of Minor or Major penalties imposed, if any, of such applicants may be forwarded to the above mentioned address of this office. If no penalties have been imposed, it should be so stated.
6. The appointment will be on transfer on deputation basis for three years. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/ Department of the Central Government shall ordinarily not exceed three years. The maximum age for appointment by deputation shall not be exceeding 56 years as on closing date of receipt of application.
7. The deputation rules, regulations and provisions as issued from time to time by DoPT shall be applicable. However, a Govt. Officer in a higher grade pay / scale shall be ineligible for appointment on deputation to a post in the lower grade pay / scale in terms of DOPT O.M. No. 6/8/2009-Estt (Pay II) dt. 17.6.2010.
8. Number of post and station of posting may differ depending upon actual requirement at the time of selection and DC, NSEZ reserves the right to modify and/or withdraw the vacancy circular at any time without assigning any reasons.
9. Since the vacancy is to be filled on deputation basis, private candidates are not eligible.
