- (a) A certified copy of complete and up-to-date confidential reports and APAR Gradations for the last five years;
- (b) Vigilance clearance and Integrity Certificate;
- (c) Details of minor or major penalties imposed, if any, during the last 10 years. If no penalties have been imposed, it should be so stated.
- (3) The Application received after the last date or without the confidential reports and other necessary document or otherwise found incomplete will not be considered. Besides, Advance Applications even if received before the last date shall also not be entertained. Further, the applicants whose applications have been received for this post earlier through proper channel need not to apply again.
- (4) The post has been created by Deptt. Of Commerce on cost recovery basis and continuation of post shall be depending upon the operational status of the SEZs.
- (5) The appointment will be on transfer on deputation basis initially for three years. The period of deputation including the period of deputation another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed three years. The maximum age for appointment by deputation shall not be exceeding 56 years as on closing date of receipt of application.
- (6) The deputation rules, regulations and provisions as issued from time to time by DoPT shall be applicable. However, a Govt. Officer in a higher grade pay/ scale shall be ineligible for appointment on deputation to a post in the lower grade pay/scale in terms of DOPT O.M. No. 6/82009-Estt (Pay II) dt.17.06.2010.
